Current Job Openings

Current Bid Projects

The Committee reviewed payroll sheets from RAD corporation, the company currently doing work on the Reed's Brook project. The Committee was pleased to note that the company had employed a female machinist for the project.

School Diversity Task Group

Barbara Boltz reported that the Vision 2020 Diversity Task Group met Monday and School Committee members Paul Schlictman and Suzanne Owayda were in attendance. Barbara Boltz indicated that the meeting was very passionate. They discussed the hiring process for the Arlington Public Schools. The Group also learned that the Superintendent of Schools, Kay Donovan will be retiring and the group plans on being very active in the hiring process. Over the next few months the group plans to meet with the remaining members of the School Committee. Barbara Boltz further reported that today they met with the Superintendent. The group intends to hold a social event for those applicants that have self identified as a minority. Affirmative Action will co-sponsor this event. The group intends to meet with the Superintendent again on March10th.

State Affirmative Action Executive Orders Status

Jeannine Rice-Oppedisano reported that the City of Boston does not have an Affirmative Action plan. She has attempted to contact Ruth Bramson, the executive in charge of reviewing the state's executive orders on affirmative action.
