# **December 16 2009 Meeting Minutes**

# Arlington Human Rights Commission Minutes – Final December 16, 2009

<u>Open Forum</u> – Our guest this evening was Jill Lewis who came to invite us to sponsor a town event for a YWCA project titled, "Stand Against Racism." This will be a nation wide undertaking scheduled for May 1<sup>st</sup> and 2<sup>nd</sup>. She suggested that as a group effort with a coordinator, the HRC would be an effective sponsor for this event. Other related groups will be invited to work with the HRC. There is a scheduled plan for each month leading up to the event, which should start in January, etc. Vice Chair Cohen asked where she heard of us and was pleased to know it was from the recent Rapid Response mailing. Commissioner Baron suggested a steering committee be formed and discussion followed as to how to proceed. Ms. Lewis agreed to chair the steering committee. Meeting space will be booked for January 13<sup>th</sup> with a letter for mailing January 4<sup>th</sup>. A motion was made and seconded: "That the Arlington Human Rights Commission will partake in the "Stand Against Racism." Chair Minton thanked her for coming this evening and for bringing this information before us.

**Review of October/November Minutes** – Minutes for October accepted and Notes accepted for unofficial meeting of November 18<sup>th</sup> where there was no quorum.

#### **Incidents and Complaints** -

Commissioner Briggett followed up the Mirak Chevrolet complaint. The reported party thanked her for her help but had already filed a report to MCAD.

# Subcommittee Reports -

## **Dialogues**

As a follow up to the November Open Forum regarding census information – it was decided to invite a representative to set up a table with information for the public to view at our February 4<sup>th</sup> Dialogue on Church and State. Commissioner Rhoads moved: "That the AHRC establish a partnership with the 2010 National Census." Chair Minton will call Nasad DeJanis and inform her of the Commission's decision to participate.

*The Separation of Church and State Dialogue* - scheduled for Thursday, February 4<sup>th</sup> at Robbins Community Room is still a work in progress. Commissioners Sweeney and Shea will meet with Mr. Leone to ask him to participate in this discussion. Commissioner Pierce suggested the topic revolve around the legal issues that impact Arlington such as the handling of religious holidays, etc. More suggestions were discussed. Plans are still being worked out.

**Schools** – Commissioners Davison and Sweeney plan to speak with the Middle School Principal to ask what we as a commission can do to help with bullying concerns. These plans are a work in progress.
