# Arlington Human Rights Commission Minutes – Final October 15, 2008

**Open Forum** – There were no guests this evening.

<u>Review of September Minutes</u> – Commissioner Sweeney made a motion to accept the September Minutes - motion seconded by Commissioner Shea – there was one abstention.

Race and Place Dialogue Series Update – The first session will be next Tuesday, October 21<sup>st</sup> at Robbins Library at 7:00pm – all commissioners are encouraged to attend.

Arlington Police Department Update - Chief Ryan gave a detailed explanation of how the Crash/Data program evolved from profiling to racially biased policing. Because of so many complaints Chief Ryan invited the Racial Justice Department of Northeastern University to visit Arlington to check the data collection and reported that the original study of year one was inconclusive. New software was purchased and has worked very well with traffic analysis. Lt. Conroy gave a presentation on the history of year two and three. Capt. Serson explained how the new data collection enables the department to red flag problem officers and will implement programs to help solve them. Chief Ryan asked that the commission continue to work with the department and explained that overall the culture of the APD organization is good but feedback is necessary to keep on top of things.
