#### Open Forum -

Barbara Boltz and Susan Lees (Arlington United for Justice and Peace) came before the commission requesting the AHRC to sign on to the pledge in support of program entitled: Welcoming Mass: Immigrants Rights Initiative. It is hopeful that this program will create awareness of the difficulties of immigrants, taking action to treat people fairly and change the emotional climate for immigrants. Chair Minton thanked the guests for coming and related that the Commission would follow up with their presentation later in the meeting.
