Other Business

Vision 20/20 will have a conflict resolution facilitator help the group resolve disruptive disagreement that resulted from discussions relating to May 17 gay marriage in Arlington. Miriam Stein invited AHRC to participate in this facilitation.

Response: No, because this would involve us in a problem that we do not share at that level. HRC is a separate group, is at a different place and should have separate meetings for this.

Question: Does the AHRC have the need for a similar activity

Response: To be discussed as a group if and when to have a facilitator on group-conflict resolution.

Complaints And Incidents

Subcommittees Rapid Response

Subcommittee has met twice

Framework discussed for rapid response is as follows:

Incident is reported the chair would contact the RR subcommittee and would decide whether a meeting would take place.

Commission Chair or Co-Chair initiates rapid response.

HRC meets and decides a) whether a response is required or not, or b) if there's to be a response, what kind.

Commission can a) make a decision to take action or b) decide whether we need more input and should bring in others in the community for suggestions c) if major response necessary, take to the next level.

Next level

Identify phone tree of groups that rapid response put together, let them know what's going to happen.

HRC has to be willing to meet on an emergency basis. If some can't make the meeting, need to be comfortable with the decision of those who attend the meeting.
