### **REVIEW MINUTES**

A motion was made to accept the January minutes with these corrections:

- Under the Sub-Committee reports section, the second bullet capitalize "March"
- At the bottom of the first page, last sentence change to read;" Marlissa Briggett spoke to the Police, who reported that after an investigation they believe it was not motivated based on the student's Middle Eastern decent."

#### COMPLAINTS AND INCIDENTS

- 9 out of 10 Commissioners voted in favor (1 abstained due to lack of knowledge of case) of sending the letter written by K. McGann after agreement with the sub-committee's finding of "no jurisdiction".
