- 4) Arlington Reservoir Management Plan discussion on the management plan ensued with various editing comments given for various sections. Ann and David will make the appropriate revisions and additions.

Ann asked for volunteers to help with editing and re-formatting all the management plans. She suggested that this be done over the summer months as people have some time freed up. Elizabeth, Adam, Teresa, all volunteered to help.

5) Town Day Booth – The committee discussed ideas for Town Day in September. Some wanted to do a raffle again. Roly suggested selling packets of bulbs rather than a raffle. He will investigate this. The idea of selling bulbs to be planted at the res was also raised.

Leslie suggested having a combination of photos of open spaces in Arlington with the maps that we've used for display. The group thought that was an excellent suggestion.

6) Updates

\*Leslie advised that there is a dog park hearing and discussion scheduled for Monday, 4/11/2005. Different approaches to dog parks will be discussed, including the "Brookline" model, i.e. no fence.
