Arlington Recycling Committee Minutes of 3/1/12

- 1. Introductions: Adam was welcomed.
- 2. DPW news/announcements: The new contract should be signed this month. It will include the features in the Rademacher memo from last month. Solid waste tonnage is down a little from last month (Ref 3). Charlotte provided a handout (Ref 1) with dates for the next 9 months for review.

3 Recycling promotional activities:

Uncle Sam posters Juli tried to use the Real Uncle Sam logo developed for the tourism committee but it doesn't work. The plan is to distribute the posters to each of the elementary schools along with a survey to find out what each school needs. This project is approved by the Superintedent.

Survey: Charlotte, using a handout (Ref 2), related recycling goals to measurable facilities/behavior to survey questions. The members found this a reasonable approach.

New collection program: Juli proposed using Town Meeting to explain it with a handout coordinated with an ARC report. Rademacher will be prepared to answer questions.

Recycling tips: After some discussion, we decided to try working through Joan Roman and the Town website. Perhaps the adocate can get the material there. Another possibility is a series of ppt pages for use by ACMI. Also mentioned were Wicked Local, Your Arlington, Patch, and The Arlington List

EcoFest: DPW will staff a table. They will provide an array of info. They will sell up to 40 heavy tarpaper composting bins. The cost was \$53/bin. As in previous years, the ARC agreed provide a \$13 subsidy making the price \$40 for a total possible outlay of \$520.

4. On-going discussion: waste reduction strategies

Lunch trays: Charlotte described a webinary which she recently watched which was given by DEP. The NY City schools are using a school program that uses paper plates one day a week instead of styrofoam. If clean, the trays are recycled. If covered w/ catsup they are trashed. They also teach the children to dump then stack their trays to save space in the trash bags.

Charlotte also reported that the Bishop parents and janitor are planning a sink to collect lunchroom liquids so that the containers can be recycled. DPW will provide a bag frame for the containers.

Charlotte will update the bin location map.

Library/Got Books bin – Juli reviewed this initiative. Teresa expects there will be room at the Town Yard.

5. Committee memberships update: Adam has agreed to fill out our roster.

6. New business:

Sue noted that the Annual Town Report does not contain an ARC report. . She volunteered to write it next year. Teresa said recycling info is in the DPW report this year.

Sue suggested that businesses should recycle more. Perhaps under the new contract, the hauler would pick up recycleable even when not on their list. Recycling may not otherwise be an option for businesses that use a private hauler. Sue will discuss the hauler permit requiring hauler to offer recycling service.

Sue suggested that every Town trash barrel should have a recycle barrel beside it. Teresa said she would like to get more big belly barrels for the parks.

The Mystic River Watershed Assoc will host a program on rain gardens 3/22 at 7 PM in the Senior Center.
