### No. 14

Arlington's regular spring 2003 Town Meeting continued Wednesday, June 18, and members took the following actions before the meeting dissolved:

**Article 16 (REFUSE CONTRACT):** Jackie Harrington and John Deyst had both submitted substitute motions at the June 16 Town Meeting. Both withdrew their motions. Harrington submitted another substitute motion, which was approved by a standing vote of 82-81. The article is voted as amended.

**Article 37 (EARLY RETIREMENT):** No action.

**Article 38 (EDUCATION REFORM):** Unanimous, no action.

**Article 39 (SPECIAL EDUCATION):** No action.

**Article 48 (COLLECTIVE BARGAINING/PATROLMEN):** Two separate votes were approved on this article. First, the Finance Committee's recommendation; second, a motion Nancy T. Galkowski submitted, which was approved by a standing vote of 111-54.

**Article 49 (COLLECTIVE BARGAINING/RANKING POLICE OFFICERS):** Unanimous.

**Article 50 (MSCHEDULE AND NON-UNION EMPLOYEES) :** Voted

**Article 51 (SALARY ADJUSTMENT/ELECTED OFFICIALS):** Voted

**Article 52 (FUNDING FUTURE COLLECTIVE BARGAINING):** Voted (Allan Tosti changed the sum of money in this article from \$252,000 to \$45,000)

**Article 55** (AUGMENT FUNDS/ DEFERRED COMPENSATION): Unanimous

**Article 72** (APPROPRIATION/HARDY SCHOOL): Unanimous, no action.

Joshua Lobel, Precinct 8, made a motion at the end of the evening to reconsider Article 28 (AMEND TOWN MANAGER ACT/ TOWN MANAGER QUALIFICATIONS). After some discussion, Town Meeting voted not to reconsider this article by a two-thirds vote.

There were 188 Town Meeting members in attendance, a 76-percent turnout.

Town meeting dissolved at 10:35 p.m.
