- 4. Report of Chair. No meeting on Dec.19,2013. 5 members chose to attend TRUE STORY THEATER. The players ask a volunteer to relate the one life event that changed their life. Using various props they conveyed to the audience an astonishing numbers of emotions. The Redevelopment Board posted a notice regarding after hours use of Senior Center and the Whittemore Robbins House at \$50.00 an hour and \$100.00 for out of town groups. An LGBT Elderly social program is underway, called Game Nite. Coming in February a SHINE representative with Lisa Krinsky and MMHSS will give a presentation concerning Medicare, DOMA or Defense of Marriage Act and same sex marriage benefits. The COA Inclusion statement will be in March newsletter.

Susan has met with John Griffith of Arlington Housing Authority regarding providing programs at the 4 sites. The Tenant's Association at each site is given funds for events.

Each Nursing student will be assigned to a site for the semester. There are many issues of note especially Drake with the largest population, language barriers, low use of Meal site, some residents are afraid to leave their apartments at night because of dark halls, some younger tenants and a few transients always about. Susan hopes to offer the famous Lobster Roll lunch as an ice breaker. She also would like to collect data on residents in order to help AHA solve some of the major issues. Some tenants do not utilize the Center and it's resources.
