Attorney Annese appeared before the Board seeking to amend the existing Board of Survey Plan identified as revised profile for Irving Street Station 3+03 to 4+53 in Arlington, Massachusetts dated August 8, 2013 prepared by Lanata & Associations, Inc.

Attorney Tournayan appeared before the Board representing Drew Kline, 64 Churchill Avenue who is opposed to the modification of the Board of Survey.

Attorney Carl R. Toumayan asked Mrs. Krepelka to include in the Minutes a copy of his

Christopher M. Geyer, 56 Churchill Avenue, stated he was concerned about safety issues,

snow plowing and trash collection.

Nicholas Deldon, 9 Windermere Park, stated he was not against the change, but wished

he had more time to work together with Mr. Pigott regarding the layout of road, etc. Robert D. Willemin, 70 Churchill Avenue, has no objections. He feels the house will

enhance the neighborhood and the Pigotts will work with the neighbors.

Jean Yoder, 70 Churchill Avenue, is not opposed and her questions had been answered regarding the removal of the ledge.

Mr. Greeley moved to amend the existing Board of Survey Plan dated August 12, 1924.

The Board approved a provision of repaving a private way. Two-thirds majority of approval was required from abutters.

New Business:

Mr. Chapdelaine announced the appointment of Douglas W. Heim as the new

Town Counsel for the Town of Arlington. Mr. Heim is presently the Assistant Corporation Counsel for the City of Boston and will begin his new role on December 16th.

Mr. Chapdelaine stated that on November 6th Massachusetts Department of Transportation is holding a public meeting on Wednesday night at 7: p.m. at the Arlington Senior Center to discuss a state and federally-funded project that will reconfigure a portion of Massachusetts Avenue to make crossing safer for the bicyclists and pedestrians. The project deals with the section that intersects with Mystic Street

and Pleasant Street where bicyclists and pedestrians who are using the Minuteman Bikeway must cross the roadway. The current plans call for reconfiguring traffic lanes and installing on-street bike lanes to improve safety for cyclists crossing the road.

Mr. Curro stated that the Arlington Master Plan Advisory Committee will host a presentation to be held on Thursday, November 7th, at 7:00 p.m. in the Arlington Senior Center for Town Meeting Members, the Redevelopment Board and the public. They will

present their report on Arlington's existing conditions in land use, transportation, economic development, housing, open space and recreation, historic and cultural resources and public facilities.

Mrs. Mahon stated that she would like Mr. Chapdelaine and Mrs. Krepelka to work with the new Town Counsel on updating our Hackney Rules & Orders and also draft new language for the alcohol policies.

Mrs. Mahon thanked Chair Dunn and the Town Manager for sending letter to Commissioner Jack Murray, Dept. of Conservation and Recreation, regarding the conditions along the Greenway in the Sunnyside Avenue neighborhood.

Mrs. Mahon reported that the Arlington High School Cheerleaders hosted the Middlesex League Qualifying Competition last Wednesday night, October 30th and had a very successful competition. The Arlington High School Varsity Cheerleaders are moving on to the Regionals.

Mr. Curro moved to adjourn at 8:30 p.m.
