#### TRAFFIC RULES & ORDERS/OTHER BUSINESS

5. Presentation: Family of John F. MacEachern William J. Reilly, Forward Capital Partners

Mr. William J. Reilly, long time personal friend of Arlington resident John F. MacEachern informed the Board that Mr. MacEachern's will entitled the Town of Arlington to the following monies along with the conditions listed:

\$146,510 - the Town of Arlington is entitled under Mr. MacEachern's will to receive a 13% share of residuary estate for the limited purposes of planting of new trees and the maintenance of such new trees. In particular, a small portion of this money (not to exceed \$10,000) would be utilized to plant a nice tree in Waldo Park, East Arlington, with a bench and plaque in memory of Mr. MacEachern. The tree, bench, and plaque would be in accordance with standards established by the Town of Arlington. The plague would read: "In loving memory of John F. MacEachern ("Uncle Mac") for his unending and unsurpassed love of all people, places, and things related to Arlington, Massachusetts." \$45,080 - Robbins Library is entitled under

Mr. MacEachern's will to receive a 4% share of his residuary estate solely for the purpose of making audio books available through online access.

The details of these gifts and conditions are still being reviewed by Town Counsel.

The Board thanked Mr. Reilly and Mr. MacEachern's family for their generous donation and looks forward to working with the family to memorialize Mr. MacEachern.

6. Vote: Authorization to Renew Intermunicipal Agreement with Bedford for Regional Energy Manager Adam W. Chapdelaine, Town Manager

Town Manager Chapdelaine asked the Board to authorize him to sign a two-year renewal of Arlington's inter-municipal agreement with the Town of Bedford regarding the position of Regional Energy Manager. The position has been very successful and he believes that the

Town will continue to receive substantial benefits by maintaining this arrangement with Bedford. This past year the Energy Manager has implemented multiple energy conservation measures, received a grant award for beginning the process of constructing solar arrays on municipal buildings, and guided Arlington to be recognized with a Leading By Example Award from the State's Department of Energy Resources.
