PROJECT UPDATE

June 22, 2010

The information below is a chronological list of project activities following the 25% submission to MassDOT on September 16, 2009:

Adjustments to Project Elements

Typical Section – Mass Avenue

Increased thru travel lane widths from 11 feet to 12 feet eastbound and 13 feet westbound

Increased width of left turn lanes where possible

Increased parking lane widths from 9 feet to 10 feet (9 feet where ROW controls)

Extended left-turn storage length for Mass. Ave. to Bates Road traffic movement

Extended two-lane eastbound section from Harlow Street to Tufts Street

Provided pedestrian refuge via small raised islands at Wyman, Foster and Winter Streets

Eliminated concerns relative to crossing the flush, painted medians

Adjustments to Project Design Parameters

Mass Avenue Corridor

Traffic analysis includes a 10-year and 20-year traffic projection (per MassDOT)

Traffic growth rate established at 0.5% per year (0.3% from MassDOT through CTPS)

Side street traffic counts (26 locations) and speed data collected for baseline comparison purposes
