Mrs. Winstanley O'Connor stated that she cannot discuss personnel matters and the Town's Human Resources Director is handling applications.

The success of the Visitor Information Booth will be dependent upon the availability of trained, enthusiastic volunteers who are willing to work in shifts. Ms. Bennett and two other neighbors stated that traffic jams are a persistent problem, and they had hoped the Town would study the problem and make improvements. Ms. Bennett hoped that the TAC would responsd to the BOS request more appropriately with not only an analysis of the traffic congestion issues but proposed solutions to: 1) more appropriately manage the bike path traffic; (2) ensure better coordination of traffic

through the lights on Brooks Ave. and Mass. Ave. and; (3) address the problem of people cutting through Mary Street at high speeds.

Mr. Dunn stated they are looking at the bike path and hopefully improvements will be made after construction of the Mass. Avenue project. Mr. Dunn also stated he understands that backups are really problematic.

Mr. Curro stated that Arlington, Bedford and Lexington are looking into a number of issues around the bike path. He hopes that the Committee will make recommendations for better signage at several crossings on the bike path.

The Selectmen voted no action on the request of Leslie Bennett to make signage changes and roadway improvements to Lake Street. The Board voted to support the TAC recommendations.

17. <u>For Approval: Abandonment of Easement 55 Venner Road per Town Meeting Vote</u> Douglas W. Heim, Town Counsel

In 1942 the Town of Arlington had taken easements on several properties located on or nearby Venner Road for the purpose of constructing an additional roadway. The roadway in question was never built, and accordingly the owners of 55 Venner Road sought an agreement with the Town to extinguish the easement on their property. As recommended by the Board of Selectmen, the 2014 Town Meeting voted to surrender or "abandon" the portions of such easement on the parcel located at 55 Venner Road in exchange for consideration. The instrument before the Board of Selectmen finalizes the Town's abandonment of the easement consistent with the will of Town Meeting and will be recorded with the Registry of Deeds and thereby extinguish the Town's interest in the property located at 55 Venner Road. The Board, being assured that approving and signing the instrument maintained the Town's right to the promised consideration, finalized the approved Town Meeting determination.
