SEAT SHELL: Seat shell shall be a one-piece with ergonomically designed hour glass shape. Seat shall be constructed of an automotive grade Polypropylene. The thickness of polypropylene shall be 5/16" at seat and back and 1/4" at mounting ribs. Molded seat shell shall provide proper lumbar and high back shoulder support. Seventeen (17) reinforcement ribs shall be required for back support. The shell shall be attached to the frame with steel rivets underneath the seat, which shall offer no exposed hardware on the surface. Shell shall be available in at least eight (8) colors.
