1.2 PROJECT DESCRIPTION

- A. Work covered by Contract Documents, without limiting the generality thereof, includes masonry waterproofing of portions of the exterior elevations.

- B. Contract time: The Contractor may begin on-site work on, or after June 26th, 2015 with receipt of a written Notice to Proceed, or suitable Letter of Intent. After commencement of work, the Contractor shall pursue the Work continuously and with diligence, and bring the Project to Substantial Completion prior to August 15, 2015.
 - Substantial completion is the stage in the progress of the Work when the work or designated portion thereof is sufficiently complete in accordance with the Contract Documents so the Owner can occupy or utilize the Work for its intended use. This includes any and all permits required by governmental agencies necessary for occupancy and use.

1.4 WORK BY OWNER

1.5 USE OF SITE

- A. Typical hours of construction: 7:00 am to 4:30 pm local time, Monday to Friday. Provisions for working hours other than those specified, must be prearranged with the Owner.
- B. Regulatory Authority: The Contractor shall comply with all local ordinances.
 - None of the requirements herein shall be construed as relieving the Contractor of his
 responsibility to conduct his operations in conformance with local ordinances or
 requirements established by the Commonwealth.
- C. Suspension of Work: The Owner retains the right to temporarily suspend work at any time when the noise or disturbance created by construction proves disruptive to the building's occupants. The Owner may request of the Contractor to utilize other means and methods, if practical, and acceptable to the Consultant, which are less disruptive.
- D. Use of, and access to, site may be subject to special requirements of the Owner, as directed.
 - 1. Pre-construction meeting: Prior to beginning the Work of this Contract, the Contractor shall meet with the Owner and the Consultant to determine procedures regarding access and use of the site, locations and access to staging and storage areas, tree protection, temporary barriers and fencing, and any special site conditions or restrictions regarding the use of the site areas surrounding the construction.
 - 2. Use of Owner's receiving/shipping areas: Contractor is responsible to deliver and receive all materials and equipment. Contractor is not permitted to have supplies or equipment shipped directly to them in care of the Owner or Building Manager.
 - 3. Security: Owner's Staff access must be permitted at all times in all construction areas, for purposes of security.
- E. Confine operations to areas within Contract limits indicated on the Drawings. Portions of the site and building beyond areas in which construction operations are indicated are not to be disturbed.
 - 1. Use of on-site areas for storage of materials must be pre-arranged with Owner. Schedule deliveries to minimize requirements for storage of materials.
 - F. Keep all public roads and walks, and access drive to facility clear of debris caused by this Work during building operations.

1.6 COORDINATION WITH OCCUPANTS

- A. General: Perform all work in such a manner as to prevent interference with the Owner's operation of the facility, nor endanger the health, safety and well-being of the facility's staff and building's occupants.
 - Take all measures to insure the safety of the general public. The Contractor must take
 every reasonable precaution and employ all necessary measures including extra
 cleaning, special supervisory personnel, and additional temporary barriers and signage
 to facilitate the clean, quiet, safe, and continual operation of the facility.
 - 2. The work will be done in an occupied building. It is imperative that the Contractor, its subcontractors and all their personnel treat building's occupants with consideration and respect. No unnecessary noise or disruption of the activities of the will be permitted.
- B. Interruption of services: Any major work entailing disruption to heating, lighting, life safety system utility connections or other similar major disruption to building functioning must be coordinated with the Owner, and temporary services, safety precautions, or connections provided. Do not shut down any service without approval of the Owner.
 - 1. Provide both Owner and Consultant with 48 hour (2 work days minimum) notification for any disruption of service; provide notification for connecting, disconnecting, turning on or turning off any service which may affect Owner's operations.
 - 2. Provide 48 hour (2 work days minimum) notice to local fire department of disruptions in electrical services, fire alarm services and emergency power services.
 - 3. Any action either planned or unplanned, by the Contractor which impairs the operation of anyone or the activation of the fire alarm detection and or suppression system shall cause notification of the appropriate party. In case of unplanned, accidental, impairment, the Contractor will immediately notify the Owner. The Contractor should be prepared to provide assistance as required to correct the problem.

1.7 PROJECT MANUAL FORMATS AND CONVENTIONS

- A. Project Manual Format: The Project Manual is organized into Divisions and subdivided into Sections and Documents using Construction Specification Institute (CSI) publication numbering system.
 - Section Identification: Section numbers are utilized and cross-referenced throughout the Contract Documents. Sections in the Project Manual are in numeric sequence; however, the sequence is incomplete because only those Section numbers which are applicable to this Project are used.
 - 2. Division One of the Project Manual governs procedural and administrative requirements of the Work. Division One requirements are applicable to all Sections and Documents in the Project Manual.
- B. Specification Content: The Specifications use certain conventions for the style of language and the intended meaning of certain terms, words, and phrases when used in particular situations. These conventions are as follows:
 - Abbreviated Language: Language used in the Specifications and other Contract
 Documents is abbreviated. Words and meanings shall be interpreted as appropriate.
 Words implied, but not stated, shall be inferred as the sense requires. Singular words

- shall be interpreted as plural, and plural words shall be interpreted as singular as applicable to the context of the Contract Documents.
- 2. Imperative mood and streamlined language is generally used in the Specifications. Requirements expressed in the imperative mood are to be performed by Contractor. Occasionally, the indicative or subjunctive mood may be used in the Section Text for clarity to describe responsibilities that must be fulfilled indirectly by Contractor or by others when so noted.

SECTION 04 50 00 MASONRY REPAIRS

PART 1 GENERAL

1.01 RELATED DOCUMENTS

A. Drawings and the "Conditions Of The Contract" including General and Supplementary Conditions and Division 1 Specifications Sections apply to work of this Section.

1.02 DESCRIPTION OF WORK

- A. Repoint and repair masonry areas indicated on drawings.
- B. Repair cracks in precast sills.
- C. Preparation for application of waterproofing sealant.
- D. ALTERNATE #1 Replace steel lintels as indicated on drawings

1.03 RELATED WORK SPECIFIED ELSEWHERE

A. Sections 07 19 23/Masonry Sealer, 07 90 00/Joint Sealer, and 09 91 00/Painting.

1.04 SUBMITTALS

- A. Product Data: Submit manufacturer's product data for each type of manufactured product, including certifications that each type complies with specified requirements. Include instructions for handling, storage, installation and protection.
- B. Contractor Qualifications: Submit references and provide assurances to indicate that the contractor has a minimum of five (5) years experience performing similar masonry work.
- C. Samples for Verification Purposes: Submit the following samples:
 - Colored masonry mortar samples for each color required showing the full range of color which can be expected in the finished work. Label samples to indicate type and amount of colorant used.

1.05 DELIVERY, STORAGE, AND HANDLING

- A. Deliver masonry materials to project in undamaged condition.
- B. Store and handle masonry units to prevent their deterioration or damage due to moisture, temperature changes, contaminants, corrosion or other causes.
- C. Limit moisture absorption of concrete masonry units during delivery and until time of installation.
- D. Store cementitious materials off the ground, under cover and in dry location.
- E. Protect grout, mortar and other materials deterioration by moisture and temperature. Store in a dry location or in waterproof containers. Keep containers tightly closed and away from open flames. Protect liquid components from freezing. Comply with manufacturer's recommendations for minimum and maximum temperature requirements for storage.

1.06 QUALITY ASSURANCE

- A. Work must be performed by a firm having not less than 5 years successful experience in comparable masonry projects and employing personnel skilled in the processes and operations indicated.
- B. Field Constructed Mock-Up for Repointing: Prior to masonry repointing work.

1.07 PROJECT CONDITIONS

- A. Staining: Prevent grout or mortar or soil from staining the face of masonry to be left exposed or painted. Immediately remove grout or mortar in contact with such masonry.
 - Protect base of walls including clerestory glazing and framing from rain-splashed mud and mortar splatter by means of self supporting protective coverings spread on clerestory, roof and wall surface.
 - 2. Protect sills, ledges and projections from droppings of mortar.
- B. Do not point mortar joints or repair masonry unless air temperatures are between 40°F (4°C) and 80°F (27°C) and will remain so for at least 48 hours after completion of work.

PART 2 PRODUCTS

2.01 MORTAR AND GROUT MATERIALS

- A. Portland Cement and Lime: ASTM C 150, Type N.
 - 1. Match existing mortar color as closely as possible.
- B. Aggregate for Mortar: ASTM C 144, except for joints less than 1/4" use aggregate graded with 100% passing the No. 16 sieve.
 - 1. Colored Mortar Aggregate: Natural or manufactured sand selected to produce mortar color indicated. Match size, texture and gradation of existing mortar as closely as possible. Color match to be determined by Architect.
- C. Aggregate for Grout: ASTM C 404.
- D. Colored Mortar Pigments: Natural and synthetic iron oxides and chromium oxides. compounded for use in mortar mixes. Use only pigments with record of satisfactory performance in masonry mortars. Use premixed colored masonry cements of formulation required to produce color to match existing.
- E. Water: Clean and potable, free of oils, acids, alkalis and organic matter.

2.02 **BRICK**

A. Face brick if needed shall match existing face brick and must comply with ASTM C216, Grade SW, Type FBS.

2.03 STEEL LINTELS (ALTERNATE 1)

Galvanized steel lintels - 1 per wythe of brick sized in accordance with the Massachusetts A. State Building Code

PART 3 EXECUTION

3.01 MASONRY REPOINTING

- with hammer and chisel or other hand tools. Power tools may not be used without written permission of the architect.
- B. All loose particles shall be washed away with water spray. Wet the areas to be repointed before applying the new mortar.
- C. Use Type N mortar mix. New repointing mortar should match color and texture of existing original mortar. Architect to view sample s prior to commencement of work.
- D. Re-temper mortar during the 2-1/2 hour period only as required to restore workability. Do not use mortar that has begun to set.
- E. Shape exposed joints to match existing good joints (slightly concave) Use hard bristle brushes after initial set to expose aggregate of mortar in order to give look of the mortar of the rest of the wall.
- F. After mortar has cured, clean repaired wall areas using stiff bristled brushes or wood scrapers to remove loose mortar particles.

3.02 PREPARATION OF CONCRETE SILLS AND CONCRETE FOUNDATION FOR CRACK REPAIR

A. Remove all loose mortar to a minimum depth of 2 times the width of the joint with hammer , chisel or other power tools.

3.03 CLEANING

A. Clean work daily to remove excess mortar. Do not use acid, which could bleach stone or mortar.

Provide a uniform, clean finish.

PART I: GENERAL

1.01 DESCRIPTION

Provide labor, materials, equipment and supervision necessary to complete the application of product to existing substrate.

1.02 QUALITY ASSURANCE

Products shall be installed by a trained applicator with a minimum of five years experience and meet the requirements of the specifier.

1.03 SUBMITTALS

- A. Manufacturer's current product data bulletin.
- B. The trained applicator shall prepare a test panel of the repair installed on the actual structure as a submittal for approval of proper application.
- C. The trained applicator shall submit to the specifier a list of five projects that he has completed within the last five years, exhibiting the applicator's skills. The list shall include project name, location, and description of work and completion date.

1.04 PRODUCT DELIVERY, STORAGE & HANDLING

- A. Deliver all products and all accessories in original labeled, sealed, and undamaged containers or bundles.
- B. Store all products in accordance with manufacturer's printed instructions.
- C. Handle products in accordance with manufacturer's printed instructions.

1.05 JOB CONDITIONS

All products shall be applied at substrate and ambient temperatures of 40°F or above. A minimum temperature of 40°F shall be maintained 1 hour after completion of work. Protect products from weather and other damage for a period of 24 hours after installation. Do not apply products to frozen surfaces.

1.06 COORDINATION & SCHEDULING

The work requires close coordination with related sections and trades.

A. GEOCELL 2310 Tripolymer Brushable repair coating.

PART III: EXECUTION

3.01 GENERAL

- A. Installation shall be performed strictly in accordance with manufacturer's current product data bulletin.
- B. Examine substrates and conditions under which materials will be installed. Do not proceed with installation until unsatisfactory conditions are corrected.
- C. Coordinate installation with adjacent work to ensure proper sequence of construction. Protect adjacent areas and landscaping from contact due to mixing, handling, and application of materials.

3.02 SURFACE PREPARATION

Surfaces to be treated must be clean and free of frost, loose debris, coatings, dirt, mildew, oils and grease, or any other substance that would interfere with penetration.

3.03 MIXING

Mix until homogeneous. Do not use high-speed mixers or over mix.

3.04 APPLICATION

A. Apply Conpro Shield MX by low-pressure spray.

- B. For vertical application, start at the top or bottom of the wall, slowly working in opposite directions using overlapping horizontal strokes to fully saturate the surface.
- C. On horizontal surfaces, start at one edge and work backwards, applying enough material to saturate the surface. When using Shield MX horizontally, care should be taken not to let product pond. If ponding occurs, excess material must be soaked up or broomed out.
- D. The surfaces must be permitted to dry after treatment for proper cure to take place. Refer to Data Sheet for additional application instructions.
- E. Always apply a sample to determine coverage and ensure there is no discoloration from contaminants, excess moisture in the substrate or from previously applied treatments.
- F. A single coat is usually sufficient, but on very porous surfaces, a second coat may be needed. Refer to the Data Sheet for additional application instructions.
- G. Apply Geocell in accordance with Manufacturers Instructions.

3.05 CURING

Protect from moisture and traffic for eight hours. Material is fully cured in fourteen days.

3.06 JOB SITE CLEANUP

- A. Material left over at the job site by the approved applicator shall be removed.
- B. All adjacent surfaces and materials shall be cleaned.
- C. Clean glass with glass cleaner before material can dry.

- A. The full set of contract documents affects this section, and such effects shall be accommodated in the execution of the work specified herein.
- B. The scope of work, without limiting the generality thereof, consists of the following:
 - Caulking the following areas with sealant compound to establish and maintain airtight and watertight continuous seals:
 - a. The perimeter of all windows.
 - b. Cracks in concrete foundation.
 - c. Cracks in window opening sills and heads.
- C. Section Includes:
 - Sealants.
 - 2. Joint filler materials.
 - 3. Miscellaneous materials.
- D. Related work in other Sections Includes:
 - 1. 04 50 00/Masonry Repairs.

1.04 SUBMITTALS

A. Submit complete Manufacturer's Data clearly indicating that each product to be furnished complies with specifications, recommended for application shown, and compatible with each other material in joint system. Complete instructions for handling, storage, mixing, priming, installation, curing, and protection of each type of compound and sealant. Submit color samples for each type of exposed sealant compound, except those required to be black.

1.05 QUALITY ASSURANCE

A. Qualifications:

- Before installation of sealants, and at Contractor's direction, meet at Project site to review material selections, joint preparations, installation procedures, and work sequencing.
- 2. Examine sample application to determine and record whether all parties agree proposed installations are likely to perform as required.
- 3. Single source responsibility for joint sealers.

1.06 PROJECT CONDITIONS

A. Caulking:

- Environmental Conditions: Do not proceed with installation of joint sealers under the following conditions:
 - a. When ambient and substrate conditions fall outside the limits permitted by joint sealer manufacturer or below 40 deg. F (4.4 deg C)
 - b. When joint substrates are wet due to rain, frost or condensation, or other causes.
- 2. Joint Width Conditions: Do not proceed with the installation of joint sealers where joint widths are less than allowed by joint sealer manufacturer for application indicated. Joint width to be 3/8 inch minimum.
- 3. Joint Substrate Conditions: Do not proceed with the application of joint sealers until contaminants capable of interfering with their adhesion are removed from joint substrates.

PART 2 PRODUCTS

2.01 GENERAL

- A. Compatibility: Provide joint sealers, joint filler and other related materials that are compatible with one another and with joint substrates under service and application conditions, as demonstrated by testing and field experience.
- B. Colors: Provide color of exposed joint sealers indicated, or if not otherwise indicated, as selected by Architect from manufacturer's standard colors.
- C. Acceptable Manufacturers: Pecora , Tremco , Dow Corning Corp., General Electric, Bostik, or approved equal.
- D. Minimum service life for all sealants is 20 years.

2.02 MATERIALS

- A. Bulk compounds:
 - General: Use self-leveling compounds for horizontal joints and non-sag compounds for all other areas, except as indicated or specified.
 - 2. Sealant color:
 - a. Concealed joints: Use sealant with manufacturer's standard color having best overall performance qualities for indicated application.
 - Exposed joints: Use sealant as selected from manufacturer's selected colors, unless special colors are shown or specified by Architect.
- B. Exterior sealant for window, vent & door perimeter, and any other exterior joints where movement is expected:
 - Polyurethane sealant: The joint sealant shall be a high performance, low modulus, one component, moisture curing, gun grade, polyurethane base material. It shall be applicable in horizontal, vertical, and overhead joints. The sealant shall cure under the influence of atmospheric moisture to form an elastomeric substance.
 - 2. Initial cure (tack free time): Within 24 hours.
 - Consistency: Non-sag.
 - 4. Color: As approved by Architect from manufacturer's standard colors.
 - 5. Tensile properties (ASTM D-412) at 21 days:
 - a. Tensile strength: 180 psi (minimum).
 - b. Elongation at break: 500% (minimum).
 - 6. Hardness 20-30 at standard condition TT S-00230C
 - 7. Adhesion in Peel TT S-00230C 19-23 lb/in
 - 8. Service range: -40 to 180F (minimum).
 - 9. The sealant shall conform to Federal Specification TT-S-00230C, Type II, Class A.
 - 10. The sealant shall conform to ASTM C-920, Type S, Grade NS, Class 25.
 - 11. The sealant shall be approved by the United States Department of Agriculture.
 - 12. The sealant shall be approved by the Environmental Protection Agency for use in contact with potable water.
 - 13. The sealant shall be non-staining.
 - 14. Final cure: 5 to 8 days.
 - 15. G.E. Silpruf Sealant, Tremco Dymonic 500, Pecora Dynatrol I or approved equal.
- C. Primer: As recommended by joint sealer manufacturer where required for adhesion of sealants to joint substrates indicated.

PART 3 EXECUTION

3.01 INSPECTION

- A. Examine substrates, adjoining construction, and conditions under which Work is to be installed.
- B. Do not proceed with Work until unsatisfactory conditions have been corrected.
- C. Clean surfaces and remove protective coatings which might interfere with bond of compound.

3.02 PREPARATION

A. General:

- Where existing sealant exists, apply skim coat of new sealant over existing perimeter sealant. Do not remove existing sealants.
- 2. Where no sealant exists comply w/paragraph C below.

- 3. Comply with test method procedures applicable to particular sealant.
- 4. Use masking tape as required to prevent contact of sealant with adjoining surfaces which otherwise could be damaged or stained by such contact or removal.
- 5. Prime all joint substrates. Confine to areas of joint sealant bond.
- B. Coated Metal Joint Surfaces:
 - Clean bonding surfaces unless coated metal joint surfaces have been successfully tested for bondcohesion of sealant.
 - 2. Clean bonding surfaces to base, non-oxidized metal by sanding, wire brushing, or clean with Toluol, Zylol, Xylene, MEK, or other process recommended by sealant manufacturer.
 - 3. Clean immediately before sealant installation. Do not damage substrate.
- C. Concrete Foundation and Window Sill and Head Joint Surfaces:
 - I. Rout joints to remove loose materials.
 - 2. Etch bonding surfaces with five percent solution of muriatic acid to remove excess alkalinity.
 - 3. Rinse thoroughly with diluted ammonia solution and then with clear water.
 - 4. Insure surfaces are dry before sealant installation.
 - 5. Install foam backer material to allow installation of sealant at manufacturer's recommended depth.

3.03 INSTALLATION

- General: Comply with joint sealer manufacturer's instructions applicable products and applications indicated.
 - All surfaces shall be clean, free of dampness, frost, dust, laitance or loose concrete, or films of oil, grease, curing compounds, lacquers, or other substances which would affect the application of damproofing, membrane waterproofing or sealant.
 - Sealant compound shall be delivered to the job site in sealed containers, each bearing the manufacturers name and product designation.
 - All soiling of adjacent materials or surfaces due to the caulking operations shall be cleaned immediately as the work progresses, including smears, droppings or misplaced sealant, and all work shall be left in a neat, clean condition upon completion.
 - 4. Provide weep holes as required.
 - 5. Tool sealant to form smooth, uniform bead, to eliminate air pockets and ensure contact and adhesion with sides of joint. Do not use tooling agents.
 - 6. Store and gun at proper temperature.
 - 7. Install only as weather permits.
- B. Elastomeric Sealant Installation Standard: Comply with ASTM C 962.
- C. Sealant Depth:
 - I. At foundation cracks apply sealant to depth shown or, if not shown, apply to manufacturer's recommendations and following general proportions and limitations.
 - 2. At window perimeters do not remove existing sealant apply new sealant as a skim coat to completely cover existing sealant.
 - 3. Horizontal Joints: Depth equal to 75 percent of joint width, min. 3/8 in., max. 3/4 in.
 - 4. Non-Traffic or Non-Abrasion Surfaces: Depth equal to 50 percent of joint width, min. I/4 in., max. I/2 in.
- D. Joint Sealant Placement:
 - Placement procedure: Prime all substrates only as required based upon the recommendations of the manufacturer of the specified product, when field testing indicates need, and when the joints will be subject to immersion after cure, as approved by the Architect.
 - Apply compounds in continuous beads or rivers, filling joint from bottom without openings, voids, or air pockets.
 - 3. Force compounds to sides of joint so as to carefully and thoroughly "wet" opposite joint bond surfaces, forming equal areas of contact with sealant.
 - 4. Confine compound to joint areas indicated by use of masking tapes or other precautions to prevent spillage or migration onto adjoining surfaces.
 - Compress joints accurately so that excess compound will not exude from joint.
 - Tool exposed surfaces to compress sealant to profiles indicated or, if none is shown, tool surface slightly concave except provide a slight wash on horizontal joints where horizontal and vertical surfaces meet.
 - 7. Remove excess sealant promptly as work progresses.
 - 8. Clean adjoining surfaces as necessary to eliminate any evidence of spillage.

3.04 PROTECTION

A. Cure sealants to manufacturer's instructions to obtain maximum bond to surfaces, cohesive strength, and durability at earliest possible date.

1.04 SUBMITTALS

A. Submit manufacturer's technical information, label analysis, and application instructions for each paint material proposed for use.

1.05 DELIVERY, STORAGE AND HANDLING

- A. Deliver materials to job site in new, original and unopened containers bearing manufacturers' name, trade name, and label analysis. Store material in designated paint storage area and in a manner which meets the requirements of applicable codes and fire regulations. When not in use, such spaces shall be kept locked and inaccessible to those not employed under this section.
- B. Materials shall be delivered in sufficient quantities in advance of the time needed in order that work will not be delayed in any way.

PART 3 EXECUTION

3.01 PROJECT CONDITIONS

- A. Do not apply paint in snow, rain, fog or mist, when the relative humidity exceeds 85 percent, at temperatures less than 5 deg. F. (3 deg. C.) above the dew point, or to damp or wet surfaces.
- B. Examine substrates and conditions under which painting will be performed for compliance with requirements. Do not begin application until unsatisfactory conditions have been corrected.
- C. The starting of painting operations will be construed as acceptance of such surfaces as being satisfactory and any defects in work resulting from such accepted surfaces shall be corrected without additional expense to the Owner.

3.02 PREPARATION

A. General:

- 1. Furnish and lay suitable drop cloths in all areas where painting is being cone to protect floors and all other surfaces from damage during work.
- B. Surface Preparation: Clean and prepare surfaces to be painted in accordance with manufacturer's instructions for each particular substrate condition. Scrape and sand to remove scale and rust. Clean to bare metal.
- C. Materials Preparation: Mix and prepare paint in accordance with manufacturer's directions.
 - Stir material before application to produce a mixture of uniform density; stir as required during application. Do not stir surface film into material. Remove film and, if necessary, strain before using.

3.03 APPLICATION

- A. Apply paint in accordance with manufacturer's directions. Use applicators and techniques best suited for substrates and type of material being applied. Do not paint over dirt, rust, scale, grease, moisture, scuffed surfaces, or conditions detrimental to formation of a durable paint film.
- B. Scheduling Painting: Apply first-coat to surfaces that have been cleaned, pretreated or otherwise prepared for painting as soon as practicable, and before subsequent surface deterioration. Allow sufficient time between successive coats to permit proper drying. Do not recoat until paint has dried
- C. Minimum Coating Thickness: Apply materials at the manufacturer's recommended spreading rate. Provide total dry film thickness of the system as recommended by the manufacturer.

3.04 CLEAN UP

- A. At the end of each work day, remove empty cans, rags, rubbish, and other discarded paint materials from the site.
- B. Upon completion of painting, clean glass and paint-spattered surfaces. Remove spattered paint by washing, scraping or other proper methods, using care not to scratch or damage adjacent finished surfaces.

CONSOLIDATED GENERAL CONDITIONS OF THE CONTRACT FOR CONSTRUCTION

ARTICLE:1

GENERAL PROVISIONS

1.1 BASIC DEFINITIONS

1.1.1 THE CONTRACT DOCUMENTS

The Contract Documents consist of the Agreement between Owner and Contractor (hereinafter the Agreement), the Consolidated General Conditions of the Conflict for Constitution, the Supplemental Standard Conditions, Drawings, Specifications, including all numbered sections. Addendar issued prior to execution of the Confract, Instructions to Budders and Proposal, other documents listed in the Agreement, and Modifications issued after execution of the Contract. A Modification is (1) a written amendment to the Contract signed by both parties, (2) a Change Order, (3) a Construction Change Directive or (4) a written order for a minor change in the Work issued by the Architect. Unless specifically enumerated in the Agreement, the Contract Documents domotioned according to Bidders, sample forms, the Confractor's bid or portalise or addendary requirements (advertisement or invitation to bid dissinguishes to Bidders, sample forms, the Confractor's bid or portalise or addendary requirements bidding requirements or bid and positions or addendary requirements.

In the event of any conflict among the Contract Documents, the Documents shall be construed according to the following priorities:

Highest Priority? Modifications

Second Priority: Agreement

Third Priority: Addenda—later date to take precedence
Fourth Priority: Supplemental Statutory Conditions
Fifth Priority: Consolidated General Conditions
Sixth Priority: Specifications and Drawings

Seventhis Priority: - Instructions to Bidders and Proposal

Any references throughout the contract documents (or any other project documents) to "General Conditions" or "Supplementary General Conditions" are deleted and "Consolidated General Conditions and Supplemental Statutory Conditions" is substituted therefor. All bidders and subbidders take note that the Town has consolidated and modified former versions of the standard form AIA Document A210 General Conditions of the Contract for Construction with the Town's desired Supplementary General Conditions into one document. The Supplemental Statutory Conditions remain intact and separate, and form a part of the Contract Documents.

1.1.2 THE CONTRACT

The Contract Documents form the Contract for Construction. The Contract represents the entire and integrated agreement between the parties hereto and supersedes prior negotiations, representations or agreements, either written or oral. The Contract may be amended or modified only by a Modification. Except as provided in Paragraph 3.18, nothing contained in the Contract Documents shall be construed to create any contractual relationship (1) between the Architect and the Contractor, (2) between the Owner or the Architect and a Subcontractor or Subsubcontractor, (3) between the Owner and the Architect, or (4) between any persons or entities other than the Owner and the Contractor. The Contract Documents shall comply with the requirements of Mass. Gen. Laws Chapter 44, Section 31C.

1.1.3 THE WORK

The term "Work" means the construction and services required by the Contract Documents, whether completed or partially completed, and includes all other labor, materials, equipment and services provided or to be provided by the Contractor to fulfill the Contractor's obligations. The Work may constitute the whole or a part of the Project.

1.1.4 THỂ PROJECT

The Project is the total construction of which the Work performed under the Contract Documents may be the whole or a part and which may include construction by the Owner or by separate contractors.

1.1.5 THE DRAWINGS

The Drawings are the graphic and pictorial portions of the Contract Documents, wherever located and whenever issued, showing the design, location and dimensions of the Work, generally including plans, elevations, sections, details, schedules and diagrams.

1.1.6 THE SPECIFICATIONS

The Specifications are that portion of the Contract Documents consisting of the written requirements for materials, equipment, construction systems, standards and workmanship for the resources, work, and performance of related services.

1.1.7 THE PROJECT MANUAL SECTION OF THE PROJECT MANUAL SECTION OF

The Project Manual is the volume usually assembled for the work which may include the bidding the sample forms, Consolidated General Conditions of the Contract and Specifications.

- 1.2.1 The Contract Documents shall be signed by the Owner and Contractor as provided in the Agreement. A copy of the signed set shall be deposited with the Architect. If either the Owner or Contractor or both do not sign all the Contract Documents, the Architect shall identify such unsigned Documents upon request.
- 1.2.2 Execution of the Contract by the Contractor is a representation that the Contractor has visited the site, become familiar with local conditions under which the Work is to be performed, and correlated personal observations with requirements of the Contract Documents. By executing the Contract, the Contractor also certifies, under penalties of perjuty, that to the best of his information, knowledge and belief he has complied with all laws of the Commonwealth of Massachusetts relating to taxes.
- 1.2.3 The intent of the Contract Documents is to include all items necessary for the proper execution and completion of the Work by the Contractor. The Contract Documents are complementary, and what is required by one shall be as binding as if required by all; performance by the Contractor shall be required only to the extent consistent with the Contract Documents and reasonably inferable from them as being necessary to produce the intended results. All Work mentioned or indicated in the Contract Documents shall be performed by the Contractor as part of this Contract unless it is specifically indicated in the Contract Documents that such Work is to be done by others.
- 1.2.4 Organization of the Specifications into divisions, sections and articles, and arrangement of Drawings shall not control the Contractor in dividing the Work among Subcontractors or in establishing the extent of Work to be performed by any trade.
- 1.2.5 Unless otherwise stated in the Contract Documents, words which have well-known technical or construction industry meanings are used in the Contract Documents in accordance with such recognized meanings.
- 1.2.6 Where codes, standards, requirements and publications of public and private bodies are referred to in the Specifications, references shall be understood to be to the latest revisions prior to the date of receiving bids, except where otherwise indicated.
- 1.2.7 Where no explicit quality or standards for materials or workmanship are established for Work, such Work or materials is to be of good, workmanlike quality for the intended use and consistent with the quality of the surrounding Work and of the construction of the Project generally.
- 1.2.8 All manufactured articles, materials, and equipment shall be applied, installed, connected, erected, used, cleaned, and conditioned in accordance with the manufacturer's written or printed directions and instructions unless otherwise indicated in the Contract Documents.
- 1.2.9 The Mechanical, Electrical and Fire Protection Drawings are diagrammatic only, and are not intended to show the alignment, physical locations or configurations of such Work.

Such Work shall be installed without additional cost to the Owner to clear all obstructions, permit proper clearances for the Work of other trades, and present an orderly appearance where exposed. Prior to beginning such Work, the Contractor shall prepare coordination drawings showing the exact alignment, physical location and configuration of the Mechanical, Electrical and Fire Protection installations and demonstrating to the Contractor's satisfaction that the installations will comply with the preceding sentence.

- 1.2.10 Exact locations of fixtures and outlets shall be obtained from the Architect as provided in Subparagraph 3.2.5 before the Work is roughed in; Work installed without such information from the Architect shall be relocated at the Contractor's expense.
- 1.2.11 Test boring or soil test information included with the Contract Documents or otherwise made available to the Contractor was obtained by the Owner for use by the Architect in the design of the Project or Work. The Owner does not hold out such information to the Contractor as an accurate or approximate indication of subsurface conditions, and no claim for extra cost or extension of time resulting from a reliance by the Contractor on such information shall be allowed except as provided in Subparagraph 4.3.6.
- OWNERSHIP AND USE OF ARCHITECT'S DRAWINGS, SPECIFICATIONS....
 AND OTHER DOCUMENTS
- The Drawings, Specifications and other documents prepared by the Architect are ... instruments of the Architect's service through which the Work to be executed by the Contractor is described. The Contractor may retain one contract record set. Neither the Contractor nor any Subcontractor, Sub-subcontractor or material or equipment supplier shall own or claim a copyright in the Drawings, Specifications and other documents prepared by the Architect, and unless otherwise indicated, and except as provided in the Owner/Architect Agreement for the Project, the Architect shall be deemed the author of them and will retain all common law. statutory and other reserved rights, in addition to the copyright. All copies of them, except the Contractor's record set, shall be returned or suitably accounted for to the Architect, on request, which is upon completion of the Work. The Drawings, Specifications and other documents prepared by the completion of the Work. the Architect, and copies thereof furnished to the Contractor, are for use solely with respect to this Project. They are not to be used by the Contractor or any Subcontractor, Sub-subcontractor or material or equipment supplier on other projects or for additions to this Project outside the scope of the Work without the specific written consent of the Owner and Architect. The Architect. Contractor, Subcontractors, Sub-subcontractors and material or equipment suppliers are granted a limited license to use and reproduce applicable portions of the Drawings, Specifications and other documents prepared by the Architect appropriate to and for use in the execution of their in the execution of their Work under the Contract Documents. All copies made under this license shall bear the statutory and states copyright notice, if any, shown on the Drawings, Specifications and other documents prepared by the Architect. Submittal or distribution to meet official regulatory requirements or for other purposes in connection with this Project is not to be construed as publication in derogation of the Architect's copyright or other reserved rights.

Notwithstanding anything herein to the contrary, as between the Owner and Architect; their rights and obligations with respect to the Architect's instruments of service are governed by the provisions of the Owner/Architect Agreement for the Project.

1.4 CAPITALIZATION

1.4.1 Terms capitalized in these General Conditions include those which are (1) specifically defined, (2) the titles of numbered articles and identified references to Paragraphs, Subparagraphs and Clauses in a document or (3) the titles of documents published by the American Institute of Architects.

1.5 INTERPRETATION

1.5.1 In the interest of brevity the Contract Documents frequently onit modifying words such as "ail" and "any and articles such as "the" and "any but the fact that a modifier or an article is absent from one statement and appears in another is not intended to affect the interpretation of either statement.

ARTICLÉ 2

OWNER

2.1 DEFINITIONS

.

- 2:1.1 The Owner is the person or entity identified as such in the Agreement and is referred to throughout the Contract Documents as if singular in number. From time to time herein the Owner is referred to as the Town
- 2.1.2 The Project Manager is the person of entity identified as such in writing by the Owner, at the Owner's option. The Project Manager shall act as the Owner's representative with respect to all matters perfaming to the Project. The duties, responsibilities, and obligations of the Project Manager under this Contract may be modified from time to time by the Town, so long as such modifications do not interfere materially with the Contractor's performance of the Work hereunder, and so long as the Contractor is given notice of any such modifications that affect the Contractor's performance of the Work.

2.2 INFORMATION AND SERVICES REQUIRED OF THE OWNER

- 2.2.1 The Owner upon reasonable written request shall furnish to the Contractor in writing information which is necessary and relevant for the Contractor to evaluate, give notice of, or enforce mechanic's lien rights. Such information shall include a correct statement of the record legal title to the property on which the Project is located, usually released to as the site, and the Owner's interest therein at the time of execution of the Agreement.
- 2.2.2 The Owner shall furnish surveys describing physical characteristics, legal limitations and utility locations for the site of the Project, and a legal description of the site.

- 2.2.3 Except for permits and fees which are the responsibility of the Contractor under the Contract Documents; the Owner shall secure and pay for necessary approvals, easements, assessments and charges required for constitution, use or occupancy of permanent structures, or for permanent changes in existing facilities.
- 2.2.4 Information or services required of the Owner hereunder shall be furnished by the Owner with reasonable promptness after receipt from the Contractor of a written request for such information or services.
- 2.2.5 Unless offictwise provided in the Contract Documents, the Contractor will be furnished, free of charge, such copies of Drawings and Project Manuals as are reasonably necessary for execution of the Work.
- 2.2.6 The foregoing are in addition to other duties and responsibilities of the Owner emmerated herein and especially those in respect to Article 6 (Construction by Owner or by Separate Contractors), Article 9 (Payments and Completion) and Article 11 (Insurance and Bonds).

2.3 OWNER'S RIGHT TO STOP THE WORK

- 2.3.1 If the Contractor fails to correct Work which is not in accordance with the requirements of the Contract Documents as required by Paragraph 12.2 or persistently fails to carry out Work in accordance with the Contract Documents, the Owner, by written order signed by the Project Manager, may order the Contractor to stop the Work, or any portion thereof, until the cause for such order has been eliminated; however, the right of the Owner to stop the Work shall not give rise to a duty on the part of the Owner to exercise this right for the benefit of the Contractor or any other person or entity.
- The Owner may order the Contractor in writing to suspend, delay, or interrupt all or any part of the Work for such period of time as it may determine to be appropriate for the convenience of the Owner, provided however, that if there is a suspension, delay or interruption, ordered by the Owner for infect days of more or the to a failure of the Owner to an within the time specified in time Contract, the Owner shall make an adjustment in the Contract Sum for any increase in the cost of performance of this Contract, but shall not include any profit to the Contract on such increase; and provided further, that the Owner shall not make any adjustment in the Contract Sum under this provision for any suspension, delay, interruption or failure to act to the extent that such is due to any cause for which this Contract provides for an equitable adjustment of the Contract Sum under any other contract provisions.
- 2.3.3 The Contractor must submit the amount of a claim under Subparagraph 2.3.2 to the Owner in writing as soon as practicable after the end of the suspension, delay, interruption or failure to act and, in any event, not later than 21 days after the end thereof. Except for costs due to a suspension order, the Owner shall not approve any costs in the claim incurred more than twenty days before the Contractor notified the Owner in writing of the act or failure to act involved in the claim.

2.4.1 If the Contractor defaults or neglects to carry out the Work in accordance with the Contract Documents and fails within a seven-day period after receipt of written notice from the Owner to begin and prosecute correction of such default or neglect with diligence and promptness, the Owner may, without prejudice to other remedies the Owner may have, correct such deficiencies. In such case an appropriate Construction Change Directive shall be issued deducting from payments their or thereafter due the Contractor the cost of correcting such deficiencies, including compensation for the Architect's additional services and expenses made necessary by such default, neglect or failure. If payments then of thereafter due the Contractor are not sufficient to cover such amounts, the Contractor shall pay the difference to the Owner.

Errors, inconsistencies or omissions discovered shall be reported to the Architect at once. Any necessary change shall be ordered as provided in Article 7, subject to the requirements of Paragraph 1.2 and other provisions of the Contract Documents. If the Contractor proceeds with the Work without such notice to the Architect; having discovered such errors, inconsistencies or omissions, the Contractor shall bear all costs arising therefrom.

- The Contractor shall give the Architect timely notice of any additional Drawings, 3.2.4 Specifications, or instructions required to define the Work in greater detail, or to permit the proper progress of the Work.
- The Contractor shall not proceed with any Work not clearly and consistently defined in detail in the Contract Documents, but shall request additional drawings or instructions from the Architect as provided in Subparagraph 3.2.4. If the Contractor proceeds with such without obtaining further Drawings, Specifications or instructions, the Contractor shall correct Work incorrectly done at the Contractor's own expense.

SUPERVISION AND CONSTRUCTION PROCEDURES 3.3

Work not conforming to these requirements, including substitutions not properly approved and authorized, may be considered defective. The Contractor's warranty excludes remedy for damage or defect occurring after Substantial Completion and caused by abuse, modifications not executed by the Contractor, improper or maintineer maintenance, improper operations of normal wear and tear under normal usage.
- The Contractor shall be responsible for determining that all materials furnished for the Work meetall requirements of the Contract Documents. The Architect may require the Contractor to produce reasonable evidence that a material meets such requirements, such as certified reports of past tests by qualified testing aboratories, reports of studies by qualified experts, or other evidence which, in the opinion of the Architect, would lead to a reasonable certainty that any material used, or proposed to be used in the Work, meets the requirements of the Contract Documents. All such data shall be furnished at the Contractor's expense. This provision shall not require the Contractor to pay for periodic testing of different batches of the same material, unless such testing is specifically required by the Contract Documents to be performed at the Contractor's expense.
- 3.5.3 If the Contractor proposes to use a material which, while suitable for the intended use, deviates in any way from the detailed requirements of the Contract Documents, the Contractor shall inform the Architect in writing of the nature of such deviations at the time the material is submitted for approval, and shall request written approval of the deviation from the requirements of the Contract Documents, in accordance with the procedures set forth in Mass. Gen. Laws Chapter 30, Section 391.
- 3.5.4 In requesting approval of deviations or substitutions, the Contractor shall provide, upon request, evidence leading to a reasonable certainty that the proposed substitution or

deviation meets or exceeds the requirements set forth in Mass. Gen. Laws Chapter 30, Section 39M(b). If, in the opinion of the Architect, the evidence presented by the Contractor does not provide a sufficient basis for such reasonable certainty, the Architect may reject such substitution or deviation.

In order to permit coordinated design of color and finishes the Contractor shall, if required by the Architect, finnish the substituted material in any color, finish, texture, or pattern which would have been available from the manufacturer originally specified, at no additional cost to the Owner.
- 3.5.6 Any additional cost, or any loss or damage arising from the substitution of any material or any method for those originally specified shall be bonne by the Contractor, notwithstanding approval or acceptance of such substitution by the Owner or the Architect, unless such substitution was made at the written request or direction of the Owner or the Architect.
- 3.5.7 The wairanty provided in this paragraph 3.5 shall be in addition to and not in the limitation of any other wairanty required by the Contract Documents or otherwise prescribed by law.
- 3.5.8 The Contractor shall procure and deliver to the Architect, no later than the dates of claimed by the Contractor as the date of Substantial Completion, all special warranties required by the Contract Documents. Delivery by the Contractor shall constitute the Contractor's and the warranties shall be performed in accordance with their terms and the conditions.
- 3.6 TAXES
- 3.6.1 The Contractor shall pay sales, consumer, use and similar taxes for the Work or a state of portions thereof provided by the Contractor which are legally enacted when bids are received or negotiations concluded, whether or not yet effective or merely scheduled to go into effect.

- 3.7 PERMITS, FEES AND NOTICES
- 3.7.1 Unless otherwise provided in the Contract Documents, the Contractor shall secure and pay for the building permit and other permits and governmental fees, licenses and inspections necessary for proper execution and completion of the Work which are customarily secured after execution of the Contract and which are legally required when bids are received or

negotiations concluded. Notwithstanding the foregoing, the Town hereby waives the fee for the Town's building permit for the Project.

- 3.7.2 The Contractor shall comply with and give notices required by laws, ordinances, rules, regulations and lawful orders of public authorities bearing on performance of the Work.
- 3.7.3 It is not the Contractor's responsibility to ascertain that the Contract Documents are in accordance with applicable laws, statutes, ordinances, building codes, and rules and regulations. However, if the Contractor observes that portions of the Contract Documents are at variance therewith, the Contractor shall promptly notify the Architect and Owner in writing, and necessary changes shall be accomplished by appropriate Modification.
- 3.7.4 If the Contractor performs Work knowing it to be contrary to laws, statutes, ordinances, building codes, and rules and regulations without such notice to the Architect and Owner, the Contractor shall assume full responsibility for such Work and shall bear the attributable costs.
- 3.8 ALLOWANCES
- 3.8.1-3.8.2 OMITTED.
- 3.9 SUPERINTENDENCE
- 3.9.1 The Contractor shall employ a competent superintendent, acceptable to the Owner, and necessary assistants who shall be in attendance at the Project site full time during the progress of the Work until the date of Substantial Completion, and for such additional time thereafter as the Architect may determine to be necessary for the expeditious completion of the Work. The superintendent shall be licensed to act as superintendent in accordance with all applicable laws for projects of this type. The Contractor shall remove the superintendent if requested to do so in writing by the Owner, and shall promptly replace him with a competent person reasonably acceptable to the Owner. The superintendent shall represent the Contractor, and communications given to the superintendent shall be as binding as if given to the Contractor.
- 3,9.2 The Contractor shall retain a competent Registered Professional Engineer or Registered Land Surveyor, acceptable to the Architect, who shall establish the exterior lines and required elevations of all buildings and structures to be erected on the site and shall establish sufficient lines and grades for the construction of associated Work such as, but not limited to, roads, utilities and site grading. The Engineer or Land Surveyor shall certify as to the actual location of the constructed facilities in relation to property lines, building lines, easements, and other restrictive boundaries.
- 3.9.3 The Contractor shall establish the building grades, lines, levels; column, wall and partition lines required by the various Subcontractors in laying out their Work.
- 3.9.4 The Contractor shall coordinate and supervise the Work performed by
 Subcontractors to the end that the Work is carried out without conflict between trades and so that

no trade, at any time, causes delay to the general progress of the Work. If such delays occur, the Owner may deduct anticipated liquidated damages from the Progress Payments to the Contractor. The Contractor and all Subcontractors shall at all times afford each trade, any separate contractor, or the Owner, every reasonable opportunity for the installation of Work and the storage of materials.

- By approving and submitting Shop Drawings, Product Data, Samples, and similar submittals, the Contractor thereby represents that the Contractor has determined and verified all dimensions, quantities, field dimensions, relations to existing work, coordination with work to be installed later, coordination with information on previously accepted Shop Drawings, Product Data, Samples, or similar submittals and verification of compliance with all the requirements of the Contract Documents. The accuracy of all such information is the responsibility of the Contractor. In reviewing Shop Drawings, Product Data, Samples, and similar submittals the Architect shall be entitled to rely upon the Contractor's representation that such information is correct and accurate.
- The Contractor shall not be relieved of responsibility for deviations from requirements of the Contract Documents by the Architect's review of Shop Drawings, Product Data, Samples or similar submittals unless the Contractor has specifically informed the Architect in writing of such deviation at the time of submittal and the Architect has given written approval to the specific deviation. The Contractor shall not be relieved of responsibility for errors or omissions in Shop Drawings, Product Data, Samples or similar submittals by the Architect's review thereof.

- 3.12.9 The Contractor shall direct specific attention, in writing or on resubmitted Shop Drawings, Product Data, Samples or similar submittals, to revisions other than those requested by the Architect on previous submittals. Unless such notice has been given, the Architect's review of a resubmitted Shop Drawing, Product Date, Sample, or similar submittal shall not constitute acceptance of any changes not requested on the prior submittal.
- 3.12.10 Informational submittals upon which the Architect is not expected to take responsible action may be so identified in the Contract Documents.
- 3.12.11 When professional certification of performance criteria of materials, systems or equipment is required by the Contract Documents, the Owner shall be entitled to rely upon such certifications, and neither the Owner nor the Architect shall be expected to make any independent examination with respect thereto.
- 3.12.12 The Architect will not check dimensions or quantities on any Shop Drawings and will not assume any responsibility for any errors in dimensions or quantities on Shop Drawings.
- 3.13 USE OF SITE.
- 3.13.1 The right of possession of the premises and the improvements made thereon by the Contractor shall remain at all times in the Owner. The Contractor's right to entry and use thereof arises solely from the permission granted by the Owner under the Contract Documents. The Contractor shall confine the Contractor's apparatus, the storage of materials and the

operations of the Contractor's workers to limits indicated by law, ordinances, the Contract Documents and permits and/or directions of the Architect, and shall not unreasonably encumber the premises with the Contractor's materials. The Owner shall not be liable to the Contractor, the Subcontractors, their employees or anyone else with respect to the conditions of the premises except only for a condition caused directly and solely by the negligence of the Owner.

3.14 CUTTING AND PATCHING

- 3.14.1 The Contractor and its Subcontractors shall be responsible for cuiting, fitting or patching required to complete the Work or to make its parts fit together properly, all to be performed in accordance with the requirements of the Contract Documents.
- 3.14.2 The Contractor shall not damage or endanger a portion of the Work or fully or partially completed construction of the Owner or separate contractors by culting patching or otherwise altering such construction, or by excavation. The Contractor shall not cut or otherwise alter such construction by the Owner or a separate contractor except with written consent of the Owner and of such separate contractor, such consent shall not be unreasonably withheld. The Contractor shall not unreasonably withheld from the Owner or a separate contractor the Contractor sconsent to cutting or otherwise altering the Work.

3.15 CLEANING UP

- 3.15.1 The Contractor daily shall keep the premises and surrounding area free from accumulation of waste materials or rubbish caused by operations under the Contract. At completion of the Work the Contractor shall remove from and about the Project waste materials, rubbish, the Contractor's tools, construction equipment, machinery and simplify materials. Immediately prior to the Architect's inspection for Substantial Completion, the Contractor shall completely clean the premises. Concrete and ceramic surfaces shall be cleaned and washed. Resilient coverings shall be cleaned, waxed and buffed. Woodwork shall be dusted and cleaned. Sash, fixtures and equipment shall be thoroughly cleaned. Stains, spots, dust, marks and smears shall be removed from all surfaces. Hardware and all metal surfaces shall be cleaned and polished. Glass and plastic surfaces shall be thoroughly cleaned by professional window cleaners. All damaged, broken or scratched glass or plastic shall be replaced by the Contractor at the Contractor's expense.
- 3.15.2 If the Contractor fails to clean up as provided in the Contract Documents, the Owner may do so and the cost thereof shall be charged to the Contractor.
- The provisions of paragraphs 3.15.1 and 3.15.2 shall apply equally to all subcontractors at the project insofar as each subcontractor's work is concerned.

3.16 ACCESS TO WORK

3.16.1 The Contractor shall provide the Owner and Architect access to the work in preparation and progress wherever located.

ROYALTIES AND PATENTS

3.17.1 The Contractor shall pay all royalties and license fees. The Contractor shall defend suits or claims for infingement of patent rights and shall hold the Owner and Architect harmless from loss on account thereof, but shall not be responsible for such defense or loss when a particular design, process or product of a particular manufacturer or manufacturers is required by the Contract Documents. However, if the Contractor has reason to believe that the required design, process or product is an infringement of a patent, the Contractor shall be responsible for such loss unless such information is promptly furnished to the Architect.

3.18 INDEMNIFICATION

3.17

- 3.18.1 To the fullest extent permitted by law, the Contractor shall indemnify and hold harmless the Owner, Architect, Architect's consultants, and agents and employees of any of them from and against claims, damages, losses and expense, including but not limited to attorneys' fees, arising out of or resulting from performance of the Work, provided that such claim, damage, loss of expense is attributable to bodily injury, suckness, disease or death, or to injury to or destruction of tangible property (other than the Work itself) including loss of use resulting therefrom, caused in whole or in part by negligent acts or omissions of the Contractor, a Subcontractor, anyone directly or indirectly employed by them or anyone for whose acts they may be liable, regardless of whether or not such claim, damage, loss or expense is caused in part by a party indemnified hereinder. Such obligation shall not be construed to negate abridge, or reduce other rights or obligations of indemnify which would otherwise exist as to a party or person described in this Paragraph 3.18
- 3.18.2 In claims against any person or entity indemnified under this Paragraph 3.18 by an employee of the Contractor, a Subcontractor, anyone directly or indirectly employed by them or anyone for whose acts they may be liable, the indemnification obligation under this Paragraph 3.18 shall not be limited by a limitation on the amount of type of damages, compensation, or benefits payable by or for the Contractor or a Subcontractor under workers or workmen's compensation acts, disability benefit acts, or other employee benefit acts.
- 3.18.3 The obligations of the Contractor under this Paragraph 3.18 shall not extend to the liability of the Architect, the Architect's consultants, and agents and employees of any of them arising out of (1) the preparation of maps. Drawings, opinions, reports, surveys, Change Orders, designs or Specifications, or (2) directions or instructions given by the Architect, the Architect's consultants, and agents or employees of any of them.

3.19 COVENANT NOT TO SUE

- Decision of Architect. Claims arising prior to final payment or the earlier termination of the Contract shall be referred initially to the Architect for action as provided in Paragraph 4.4. Action by the Architect, as provided in Paragraph 4.4, shall be required as a condition precedent to arbitration of a Claim between the Contractor and Owner as to all such matters arising prior to the date final payment is due. Action by the Architect in response to a Claim shall not be a condition precedent to arbitration in the event (1) the position of Architect is vacant; (2) the Architect has failed to take action as required under Subparagraph 4.4.1 within 15 days after the Claim is made; (3) the Architect has failed to take action required under Subparagraph 4.4.4 within 30 days after the Claim is made, unless the Architect has notified the parties in writing of the reasons why action could not be taken within 30 days, and of the date by which action will be taken; or (4) the Claim relates to a mechanic's lien.
- 4.3.3 Time Isimits on Claim. Claims by either party must be made within 35 days after occurrence of the event giving rise to such Claim or within 35 days after the claimant first recognizes the condition giving rise to the Claim, whichever is later. Claims must be made by written notice. Any change or addition to a previously made Claim shall be made by timely written notice in accordance with this Subparagraph 4.3.3.
- 4.3.4. Continuing Contract Performance. Pending final resolution of a Claim including arbitration, unless otherwise agreed in writing the Contractor shall proceed diligently with performance of the Contract and the Owner shall continue to make payments in accordance with the Contract Documents.
- 43.5 Waiver of Claims: Final Payment. The making of final payment shall constitute a waiver of Claims by the Owner except those arising from:
 - .1 liens, Claims, security interests or encumbrances arising out of the Contract and unsettled;
 - .2 failure of the Work to comply with the requirements of the Contract
 __Documents; or
 - .3 terms of special warranties required by the Contract Documents.

Any Claim which has not been waived in accordance with this Subparagraph shall be deemed to have accrued upon discovery by the Owner of the condition or breach upon which such Claim is based, for the purpose of any applicable statute of limitation.

4.3.6 Claims for Differing Subsurface or Latent Physical Conditions. If, during the progress of the Work, the Contractor or the Owner discovers that the actual subsurface or latent physical conditions encountered at the site differ substantially or materially from those shown on the plans or indicated in the Contract Documents, either the Contractor or the Owner may request

an equitable adjustment in the Contract Sum applying to Work affected by the differing site conditions. A request for such an adjustment shall be in writing and shall be delivered by the party making such claim to the other party as soon as possible after such conditions are discovered. Upon receipt of such a claim from a Contractor, or upon its own initiative, the Owner shall make an investigation of such physical conditions, and, if they differ substantially of materially from those shown on the plans or indicated in the Contract Documents or from those ordinarily encountered and generally recognized as inherent in Work of the character provided for in the plans and Contract Documents and are of such a nature as to cause an increase or decrease in the cost of performance of the Work of a change in the construction methods required for the performance of the Work which results in an increase or decrease in the cost of such as a change in the construction methods the Work, the Owner shall make an equitable adjustment in the Contract Sum and the Contract shall make an equitable adjustment in the Contract Sum and the Contract shall be modified in writing accordingly.

No Claim by the Contractor on account of such acts, omissions, instructions or orders shall be valid unless the Contractor has so notified the Architect before proceeding, and has received the further written order to proceed.

ARBITRATION 4.5

Controversies and Claims Subject to Arbitration. Any Claim arising out of or related to the Contract, or the breach thereof, except claims relating to aesthetic effect, shall be settled by arbitration, subject to the foregoing provisions of paragraph 4:4 and the provisions of Subparagraph 4.5.7. Arbitration will be conducted in accordance with the Construction Industry Arbitration Rules of the American Arbitration Association and judgment upon the award rendered by the Arbitrator or Arbitrators may be entered in any Court having jurisdiction thereof. In any such arbitration in which the amount stated in the demand is \$100,000 or less, a single ... arbitrator shall be appointed in accordance with the procedures set forth in the American Arbitration Association Construction Industry Arbitration Rules. In any such arbitration in which the amount stated in the demand is in excess of \$100,000, a panel of three arbitrators shall be appointed in accordance with the procedures set forth in the American Arbitration Association Construction Industry Arbitration Rules.

Rules For Arbitration. The parties may agree to any arbitration forum. If mable to agree, by default the forum shall be the American Arbitration Association. If the neutral arbitrator(s) is are appointed by the American Arbitration Association, the said Association shall administer the arbitration and its Construction Industry Arbitration Rules shall govern all aspects of the proceeding including the enforcement of any award. If the neutral arbitrator(s) is/are not appointed by the American Arbitration Association, then the arbitrator(s) shall act as the administrator of the arbitration but the Construction Industry Arbitration Rules of the Association shall nonetheless govern all aspects of the proceeding, including the enforcement of any award. The arbitration panel shall have all of the powers and duties conferred on the Association pursuant to said rules.

In addition, the following rules shall govern the selection of arbitrators and the proceedings:

- 4.5.2.1 Neither party may appoint as arbitrator an employee or an owner of that party not a taken the parent, spouse or child of an employee or other party.
- 4.5.2.Z After the neutral arbitrator has been appointed, neither party may engage in ex parte communication with the arbitrator appointed by that party.
- 4.5.3 Contract Performance During Arbitration. During arbitration proceedings, the Owner and Contractor shall comply with Subparagraph 4.3.4.
- When a written decision of the Architect states that the decision is final, any demand for arbitration of the matter covered by such decision must be made within two months after substantial completion of the project, as determined by the Architect in accordance with paragraph 9.8.2 hereof. The failure to demand arbitration within said two month period will result in the Architect's decision becoming final and binding upon the Owner and the Contractor.
- 4.5.4.1 A demand for arbitration shall be made within the time limits specified in Subparagraph 4.5.4, and in no event shall be made after the date when the institution of legal of equitable proceedings based on such Claim would be barred by the applicable statute of limitations.
- 4.5.5 Claims and Timely Assertion of Claims. A party who files a notice of demand for arbitration must assert in the demand all Claims then known to that party on which arbitration is permitted to be demanded. When a party falls to include a Claim through oversight, inadvertence or excusable neglect, or when a Claim has matured or been acquired subsequently, the arbitrator or arbitrators may permit amendment.
- 4.5.6 Judgment on Final Award. The award rendered by the arbitrator or arbitrators shall be final, and judgment may be entered upon it in accordance with applicable law in ariy court having jurisdiction thereof.

- Notwithstanding any provision contained in this Paragraph 4.5 or elsewhere in the 4.5.7 Contract Documents, the Owner reserves the following rights in connection with Claims and disputes between the Owner and the Contractor:
 - the right to institute legal action against the Contractor in any court of .1 competent jurisdiction in lieu of demanding arbitration pursuant to this Paragraph 4.5, in which case the dispute or disputes which are the subject of such action shall be decided by such court, and not by arbitration;
 - the right to obtain from any court of competent jurisdiction a stay of any .2 arbitration instituted by the Contractor, provided that the application for stich stay is made before the appointment of the neutral arbitrator in such 'arbitration, in which case the dispute or disputes which are the subject of such arbitration shall be decided by such court, and not by arbitration;
 - the right to require the Contractor to join as a party in any arbitration · .3% between the Owner and the Architect relating to the Project, in which case the Contractor agrees to be bound by the decision of the arbitrator or 'arbitrators in such arbitration.

- A Subcontractor is a person or entity who has a direct contract with the Contractor to perform a portion of the Work at the site. The term "Subcontractor" is referred to throughout the Contract Documents as if singular in number and means a Subcontractor or an authorized representative of the Subcontractor. The term "Subcontractor" does not include a separate contractor or Subcontractors of a separate contractor.
- A Sub-subcontractor is a person or entity who has a direct or indirect contract 5.1.2 with a Subcontractor to perform a portion of the Work at the site. The term "Sub-subcontractor" is referred to throughout the Contract Documents as if singular in number and means a Subsubcontractor or an authorized representative of the Sub-subcontractor.
- AWARD OF SUBCONTRACTS AND OTHER CONTRACTS FOR PORTIONS 5.2 OF THE WORK
- Unless otherwise stated in the Contract Documents or the bidding requirements, 5.2.1 the Contractor, as soon as practicable after award of the Contract, shall furnish in writing to the

Owner through the Architect the names of persons or entities (including those who are to furnish materials or equipment fabricated to a special design) proposed for each principal portion of the Work. The Architect will promptly reply to the Contractor in writing stating whether or not the Owner or the Architect, after due investigation, has reasonable objection to any such proposed person or entity. Failure of the Owner or Architect to reply promptly shall constitute notice of no reasonable objection.

- 5.2.2 The Contractor shall not contract with a proposed person or entity to whom the Owner or Architect has made reasonable and timely objection. The Contractor shall not be required to contract with anyone to whom the Contractor has made reasonable objection, unless otherwise required by law to do so.
- by the Contractor, the Contractor shall propose another to whom the Owner or Architect has no reasonable objection. The Contract Sum shall be increased or decreased by the difference in cost occasioned by such change and an appropriate Change Order shall be issued. However, no increase in the Contract Sum shall be allowed for such change unless the Contractor has acted promptly and responsively in submitting names as required.
- 5.2.4 The Contractor shall not change a Subcontractor, person or entity previously selected if the Owner or Architect makes reasonable objection to such change.
- 5.2.5 The form of each filed Subcontract shall be submitted to the Owner for its acceptance, which shall not be unreasonably withheld or delayed. The form of subcontract shall out be that set forth in Mass. Gen. Laws Chapter 149, Section 44F. Each Subcontract shall expressly provide for the contingent assignment referred to in Paragraph 5.4.

5.3 SUBCONTRACTUAL RELATIONS

By appropriate agreement, written where legally required for validity, the 5.3.1 Contractor shall require each Subcontractor, to the extent of the Work to be performed by the Subcontractor, to be bound to the Contractor by leans of the Contract Documents, and to assume toward the Contractor all the obligations and responsibilities which the Contractor, by these were the contractor, by these were the contractor. Documents, assumes toward the Owner and Architect, including without limitation the obligations set forth in Paragraph 3.18. Each Subcontract agreement shall preserve and protection in the state of the stat the rights of the Owner and Architect under the Contract Documents with respect to the Work to be performed by the Subcontractor so that Subcontracting thereof will not prejudice such rights. and shall allow to the Subcontractor, unless specifically provided otherwise in the Subcontract agreement, the benefit of all rights, remedies and redress against the Contractor that the Contractor, by the Contract Documents, has against the Owner. Where appropriate, the and the contract Documents against the Owner. Contractor shall require each Subcontractor to enter into similar agreements with Subsubcontractors. The Contractor shall make available to each proposed Subcontractor, prior to the execution of the Subcontract agreement, copies of the Contract Documents to which the Subcontractor will be bound, and, upon written request of the Subcontractor, identify to the Subcontractor terms and conditions of the proposed Subcontract agreement which may be at

variance with the Contract Documents. Subcontractors shall similarly make copies of applicable portions of such documents available to their respective proposed Sub-subcontractors.

5.4 CONTINGENT ASSIGNMENT OF SUBCONTRACTS

- 5.4.1 Each Subcontract agreement for a portion of the Work is assigned by the Contractor to the Owner provided that:
 - assignment is effective only after termination of the Contract by the Owner for cause pursuant to Paragraph 14.2 and only for those Subcontract agreements which the Owner accepts by notifying the Subcontractor in writing; and
 - 2 assignment is subject to the prior rights of the surety, if any, obligated under bond relating to the Contract.

ARTICLE 6

CONSTRUCTION BY OWNER OR BY SEPARATE CONTRACTS

6.1 OWNER'S RIGHT TO PERFORM CONSTRUCTION AND TO AWARD SEPARATE CONTRACTS

- The Owner reserves the right to perform construction or operations related to the Project with the Owner's own forces, and to award separate contracts in connection with other portions of the Project or other construction or operations on the site under Conditions of the Contract identical or substantially similar to these, including those portions related to insurance and waiver of subrogation. If the Contractor claims that delay or additional cost is involved because of such action by the Owner, the Contractor shall make such Claim as provided elsewhere in the Contract Documents.
- 6.1.2 When separate contracts are awarded for different portions of the Project or other construction or operations on the site, the term "Contractor" in the Contract Documents in each case shall mean the Contractor who executes each separate Owner-Contractor Agreement.
- 6.1.3 The Owner shall provide for coordination of the activities of the Owner's own forces and of each separate contractor with the work of the Contractor, who shall cooperate with them. The Contractor shall participate with other separate contractors and the Owner in reviewing their progress schedules when directed to do so. The Contractor shall make any revisions to the progress schedules and Contract Sum deemed necessary after a joint review and mutual agreement. The progress schedules shall then constitute the schedules to be used by the Contractor, separate contractors and the Owner until subsequently revised.

Fairing of the Contractor so to report shall constitute an acknowledgement that the Owner's or separate contractors completed or partially completed construction is fit and proper to receive the Contractor's Work, except as to defects not then reasonable discoverable.
- 6.2.3 Costs cansed by delays or by improperly timed activities or defective construction shall be borne by the party responsible therefor.
- Contractor to completed or partially completed construction or to property of the Owner or separate contractors as provided in Subparagraph 10.2.5. If such separate contractor sues or initiates an arbitration proceeding against the Owner on account of any damage alleged to have been caused by the Contractor, the Owner shall notify the Contractor, who shall defend such proceedings at the Contractor's expense, and if any judgment or award against the Owner arises therefrom the Contractor shall pay or satisfy it and shall reimburse the Owner for all attorneys fees and court or arbitration costs which the Owner has incurred.
- 6.2.5 Claims and other disputes and matters in question between the Contractor and a separate contractor shall be subject to the provisions of Paragraph 4.3 provided the separate contractor has reciprocal obligations.
- 62.6 The Owner and each separate contractor shall have the same responsibilities for a second cutting and patching as are described for the Contractor in Paragraph 3.14.

- 6.3 OWNER'S RIGHT TO CLEAN UP
- If a dispute arises among the Contractor, separate contractors and the Owner as to the responsibility under their respective contracts for maintaining the premises and surrounding area free from waste materials and rubbish as described in Paragraph 3.15, the Owner may clean up and allocate the cost among those responsible as the Architect determines to be just.

ARTICLE 7

CHANGES IN THE WORK

7.1 CHANGES

- 7.1.1 Changes in the Work may be accomplished after execution of the Contract, and without invalidating the Contract, by Change Order, Construction Change Directive or order for a minor change in the Work, subject to the limitations stated in this Article 7 and elsewhere in the Contract Docliments.
- 7.1.2 A Change Order shall be based upon agreement among the Owner. Contractor and Architect; a Constitution Change Directive requires agreement by the Owner and Architect and may or may not be agreed in by the Contractor, an order for a minor change in the Work may be issued by the Architect alone.
- 7.1.3 Changes in the Work shall be performed under applicable provisions of the Contract Documents, and the Contractor shall proceed promptly, unless otherwise provided in the Change Order, Construction Change Directive or order for a mimor change in the Work.
- 7.1.4 If unit prices are stated in the Contract Documents or subsequently agreed upon, and if quantities originally contemplated are so changed in a proposed Change Order of Construction Change Directive that application of such unit prices to quantities of Work proposed will cause substantial inequity to the Owner or Contractor, the applicable unit prices shall be equitably adjusted.

7.2 CHANGE ÖRDERS

- 7.2.1 A Change Order is a written instrument prepared by the Architect and signed by the Owner, Contractor and Architect, stating their agreement upon all of the following:
 - .1 a change in the Work;
 - 2 the amount of the adjustment in the Contract Sum, if any, and
 - 3 the extent of the adjustment in the Contract Time, if any.

7.3 CONSTRUCTION CHANGE DIRECTIVES

- A Construction Change Directive is a written order prepared by the Architect and signed by the Owner and Architect; directing a change in the Work and stating a proposed basis for adjustment, if any, in the Contract Sum or Contract Time, or both. The Owner may by Construction Change Directive, without invalidating the Contract; order changes in the Work within the general scope of the Contract consisting of additions, deletions or other revisions, the Contract Sum and Contract Time being adjusted accordingly.
- 7.3.2 A Construction Change Directive shall be used in the absence of total agreement on the terms of a Change Order.

- Upon request of the Owner or the Architect, the Contractor shall without cost to 7.3.3 the Owner submit to the Architect, in such form as the Architect may require, an accurate written estimate of the cost of any proposed extra. Work or change contemplated by a Construction Change Directive. The estimate shall indicate the quantity and unit cost of each item of materials, and the number of hours of work and hourly rate for each class of labor, as well as the description and amounts of all other costs chargeable under the terms of this Article. Unit labor costs for the installation of each item of materials shall be shown if required by the Architect. The Contractor shall promptly revise and resubmit such estimate if the Architect determines that it is not in compliance with the requirements of this Article, or that it confains errors of fact or mathematical errors. If required by the Architect, in order to establish the exact cost of new and the state of the state Work added or of previously required Work omitted, the Contractor shall obtain and furnish to the Architect bona fide proposals from recognized suppliers for furnishing any material included in such Work. Such estimates shall be furnished promptly so as to occasion no delay in the Work, and shall be firmished at the Contractor's expense. The Contractor shall state in the estimate any extension of time required for the completion of the Work if the change or extra work is ordered,
- 7.3.3.1 If the Construction Change Directive provides for an adjustment to the Contract.
 Sum, the adjustment shall be based on one of the following methods, as selected by the Owner.
 - (a) By unit prices stated in the Contract Documents or otherwise mutually agreed upon.
 - (b) By Cost and Percentages (as defined below) estimated by the Contractor is as provided in Subparagraph 7.3.3 and accepted by the Owner; the Contractor's estimate shall become a fixed price which shall not be changed by any variation in the actual cost of executing the Work covered by the change.

"Percentage" shall mean an allowance to be added to or subtracted from the Cost in lieu of overhead and profit and of any other expense which is not included in the Cost of the Work

Percentage for a Sub-subcontractor shall be 10% of any net increase or decrease of Cost of any Work performed by the Sub-subcontractor's own forces plus 5% of any aggregate net increase in Cost of any Work performed for the Sub-subcontractor by other contractors. Percentage for a Subcontractor shall be such percentage allowances for overhead and profit as are set forth in the Subcontract between such Subcontractor and the Contractor. Percentage for the Contractor shall be 9 1/2% of any net increase or decrease of Cost of any Work performed by the Contractor's own forces plus 4 1/2% of any net increase or decrease in the Cost for all other Work covered by the change.

When in the reasonable judgment of the Architect a series of Construction Change Directives or Change Orders effect a single change, Percentage shall be calculated on the cumulative net increase or decrease in Cost, if any.

- 7.3.4 Upon receipt of a Construction Change Directive, the Contractor shall promptly proceed with the change in the Work involved and advise the Architect of the Contractor's agreement or disagreement with the method, if any, provided in the Construction Change.

9.1.1 The Contract Sum is stated in the Agreement and, including authorized adjustments, is the maximum amount payable by the Owner to the Contractor for performance of the Work under the Contract Documents, or in equity, should the Contractor assert a quantum meruit claim for the fair value of Contractor's Work, regardless of whether the Contractor is terminated hereunder.

The date of receipt of a periodic estimate received on a Saturday, Sunday, or holiday shall be the first working day thereafter.

- 9.2.4 All periodic estimates shall be submitted to the Owner, or to the Owner's representative, and the date of receipt by the Owner or its representative shall be marked on the estimate. All periodic estimates shall contain a separate item for each filed subtrade and each sub-subtrade listed in sub-bid form as required by the Specifications and a column listing the amount paid to each Subcontractor and Sub-subcontractor as of the date the periodic estimate is filed. - 9.2.5 The format and number of copies of applications for payment shall be as directed by the Architect. Such application shall be notatized, if required, and supported by such data substantiating the Confractor's right to payment as the Owner or Architect may require, such as copies of requisitions from Subconfractors and material suppliers, and reflecting retainage if provided for elsewhere in the Confract Documents.
- 9.2.5.1 Such applications may include requests for payment on account of changes in the Work which have been properly authorized by Construction Change Directives but not yet included in Change Orders when such Construction Change Directives have set forth an adjustment to the Contract Sum.
- 9.2.5.2 Such applications may not include requests for payment of amounts the Contractor does not intend to pay to a Subcontractor or material supplier because of a dispute or other reason.
- 9.2.6 Unless otherwise provided in the Contract Documents, payments shall be made on account of materials and equipment delivered and suitably stored at the site for subsequent incorporation in the Work. If approved in advance by the Owner, payment may similarly be made for materials and equipment suitably stored off the site at a location agreed upon in writing. Payment for materials and equipment stored on or off the site shall be conditioned upon compliance by the Contractor with procedures satisfactory to the Owner to establish the Owner's title to such materials and equipment or otherwise protect the Owner's interest, and shall include applicable insurance, storage and transportation to the site for such materials and equipment stored off the site.
 - 9.3 The Contractor warrants that title to all Work covered by an application for payment will pass to the Owner either by incorporation in the construction or upon receipt of payment by the Contractor, whichever occurs first, free and clear of all liens, claims, security, interests or encumbrances, heremafter referred to in this Article 9 as "liens."

9.4 CERTIFICATES FOR PAYMENT

Contractor, less any amount retained by the Owner as the estimated cost of completing the incomplete and unsatisfactory items of Work, the Subcontractor may demand direct payment of that balance from the Owner. The demand shall be by a sworn statement delivered to or sent by certified mail to flie Owner, and a copy shall be delivered to or sent by certified mail to the Contractor at the same time. The demand shall contain a detailed breakdown of the balance due under the Subcontract and also a statement of the status of completion of the Subcontract work. Any demand made after substantial completion of the Subcontract work shall be valid even if delivered or mailed prior to the seventieth day after the Subcontractor has substantially completed the Subcontract work. Within ten days after the Subcontractor has delivered or so mailed the derivand to the Owner and delivered or so mailed a copy to the Contractor, the Contractor may reply to the demand. The reply shall be by a swom statement delivered to or sent by certified mail to the Owner and a copy shall be delivered to or sent by certified mail to the Subcontractor at the same time. INSURANCE AND BONDS

11.1 CONTRACTOR'S LIABILITY INSURANCE

- II.1.1 The Contractor shall purchase from and maintain in a company or companies lawfully authorized to do business in the jurisdiction in which the Project is located and to which the Owner has no reasonable objection such insurance as will protect the Contractor from claims set forth below which may arise out of or result from the Contractor's operations under the Contractor and for which the Contractor may be legally liable, whether such operations be by the Contractor or by a Subcontractor or by anyone directly or indirectly employed by any of them or by anyone for whose acts any of them may be liable:
 - claims under workers' or workmen's compensation, disability benefit and other similar employee benefit acts which are applicable to the Work to be performed;
 - .2 claims for damages because of bodily injury, occupational sickness or disease, or death of the Contractor's employees;
 - .3 claims for damages because of bodily injury, sickness or disease, or death of any person other than the Contractor's employees;
 - .4 claims for damages insured by usual personal injury liability coverage which are sustained (1) by a person as a result of an offense directly or indirectly related to employment of such person by the Contractor, or (2) by another person;

- claims for damages, other than to the Work itself, because of injury to or destruction of tangible property, including loss of use resulting therefrom:
- claims for damages because of bodily injury, death of a person or property damage arising out of ownership, maintenance or use of a motor vehicle; and
- .7 claims involving contractual liability insurance applicable to the Contractor's obligations under Paragraph 3.18.
- The insurance required by Subparagraph 11.1.1 shall include all major divisions of coverage, and shall be on a comprehensive general basis including Premises and Operations (including X-C-U), Owner's and Contractor's Protective, Products and Completed Operations, and Owned, Nonowned, and Hired Motor Vehicles. Such insurance shall be written for not less than any limits of liability required by law or those set forth in the Contract Documents, whichever is greater.

All insurance shall be written on an occurrence basis, unless the Owner approves in writing coverage on a claims-made basis. Coverages, whether written on an occurrence or claims-made basis, shall be maintained without interruption from date of commencement of the Work until date of final payment and termination of any coverage required to be maintained after final payment. The Owner shall be added as an Additional Insured on all policies, which shall? constitute primary insurance for the Owner in relation to any similar or concurrent insurance independently maintained by the Owner.

- 11.1.4 In addition to Statutory Workers' Compensation Coverage; the Contractor shall provide Employers Liability Coverage at the following limits of liability:

Each accident - \$500,000;

Disease policy limit \$500,000;

Disease - each employee \$500,000.

11.1.5 The liability insurance coverage purchased by the Contractor in order to comply with Section 11.1.1 (.1-.7) above shall contain the following limits of liability:

\$3,000,000 - general aggregate;

\$3,000,000 - products/completed operations aggregate;

\$1,000,000 - personal injury and advertising;

11.2 OWNER'S LIABILITY INSURANCE

The Owner shall be responsible for purchasing and maintaining the Owner's usual liability insurance. Optionally, the Owner may purchase and maintain other insurance for self-protection against claims which may arise from operations under the Contract. The Contractor shall not be responsible for purchasing and maintaining this optional Owner's liability insurance unless specifically required by the Contract Documents.

PROPERTY INSURANCE BUILDERS RISK POLICY

Unless otherwise provided, the Owner shall purchase and maintain, in a company or companies lawfully anthorized to do business in the jurisdiction in which the Project is located property insurance in the amount of the initial Contract Sum as well as subsequent modifications thereto for the entire Work at the site on a replacement cost basis. Such property insurance shall be maintained, linkess otherwise provided in the Contract Documents or otherwise agreed in writing by all persons and entities who are beneficiaries of such insurance, until final payment has been made as provided in Paragraph 9.10 or until no person or entity other than the Owner has an insurable interest in the property required by this Paragraph 11.3 to be covered, whichever is earlier. This insurance shall include interests of the Owner, the Contractor, Subcontractors and Sub-subcontractors in the Work.

Property insurance shall be on an all-risk policy form and shall insure against the perils of fire and extended coverage and physical loss or damage including, without duplication of coverage, theft, vandalism, malicious mischief, collapse, false-work, temporary buildings and debris removal including derivolition occasioned by enforcement of any applicable legal requirements, and shall cover reasonable compensation for Architect's services and expenses required as a result of such insured loss. Coverage for other perils shall not be required unless otherwise provided in the Contract Documents. The form of policy for this coverage shall provide for coverage in the event of a loss up to the contemplated value of the property following completion of all Work required under the Contract.

- 11.3.1.2 If the Owner does not intend to purchase such property insurance required by the Contract and with all of the coverages in the amount described above, the Owner shall so inform the Contractor in writing prior to commencement of the Work. The Contractor may then effect insurance which will protect the interests of the Contractor, Subcontractors and Subsubcontractors in the Work, and by appropriate Change Order the cost thereof shall be charged to the Owner. If the Contractor is damaged by the failure or neglect of the Owner to purchase or maintain insurance as described above, without so notifying the Contractor, then the Owner shall bear all reasonable costs properly attributable thereto.
- The property insurance maintained hereunder by the Owner has a deductible of \$100,000 applicable to each/any claim thereunder. In the event of any property damage, arising from any occurrence prior to the Architect's issuance of a final Certificate for Payment under Section 9.10.1, including but not limited to property damage arising from vandalism or casualty of any kind, the Contractor shall be responsible for the cost of said property damage: (a) to the extent not indemnified by the Owner's insurance policy because of said deductible; or (b) to the extent not indemnified by the Owner's insurance policy for any other reason.
- 11.3.1.4 Property insurance for portions of the Work stored off site and in transit shall be procured and the cost borne by the Contractor, unless otherwise provided in the Contract Documents.
- Boiler and Machinery Insurance. The Owner shall purchase and maintain boiler and machinery insurance required by the Contract Documents or by law, which shall specifically cover such insured objects during installation and until final acceptance by the Owner; this insurance shall include interests of the Owner, Contractor, Subcontractors and Subsubcontractors in the Work, and the Owner and Contractor shall be named insureds.
- 11.3.3 Loss of Use Insurance. The Owner, at the Owner's option, may purchase and maintain such insurance as will insure the Owner against loss of use of the Owner's property due to fire or other hazards, however caused. The Owner waives all rights of action against the Contractor for loss of use of the Owner's property, including consequential losses due to fire or other hazards however caused, to the extent covered and paid by insurance under this Subparagraph 11.3.3.
 - If the Contractor requests in writing that insurance for risks other than those described herein or for other special hazards be included in the property insurance policy, the Owner shall, if possible, include such insurance, and the cost thereof shall be borne by the Contractor.
 - 11.3.5 If during the Project construction period the Owner insures properties, real or personal or both, adjoining or adjacent to the site by property insurance under policies separate from those insuring the Project, or if after final payment property insurance is to be provided on the completed Project through a policy or policies other than those insuring the Project during the construction period, the Owner shall waive all rights in accordance with the terms of.

 Subparagraph 11.3.7 for damages caused by fire or other perils covered by this separate property

insurance. All separate policies shall provide this waiver of subrogation by endorsement or otherwise.

- Before an exposure to loss may occur, the Owner shall file with the Contractor a copy of each policy that includes insurance coverages required by this Paragraph 11.3. Each policy shall contain all generally applicable conditions, definitions, exclusions and endorsements related to this Project. Each policy shall contain a provision that the policy will not be canceled or allowed to expire until at least 30 days prior written notice has been given to the Contractor.
- 11.3.7 Waivers of Subrogation. INTENTIONALLY OMITTED.
- 11.3.8 A loss insured under Owner's property insurance shall be adjusted by the Owner and made payable to the Owner on its behalf and on behalf of the insureds, as then interests may appear, subject to requirements of any applicable mortgagee clause and of Subparagraph 11.3.10. The Contractor shall pay Subcontractors their just shares of insurance proceeds received by the Contractor, and by appropriate agreements, written where legally required for validity, shall require Subcontractors to make payments to their Subcontractors in similar manner.
- If required in writing by a party in interest, the Owner shall, upon occurrence of an insured loss, give bond for proper performance of the Owner's duties all subject to the requirements, if any, of the Owner's construction and/or permanent lender. The cost of required bonds shall be charged against proceeds received by Owner. The Owner shall deposit in a separate account proceeds so received, which the Owner shall distribute in accordance with such agreement as the parties in interest may reach, or in accordance with an arbitration award in which case the procedure shall be as provided in Paragraph 4.5.
- 11.3/10 The Owner shall have power to adjust and settle a loss with insurers incless one of the parties in interest shall object in writing within five days after occurrence of loss to the Owner's exercise of this power, it slich objection be made, arbitrators shall be chosen as provided in Paragraph 4.5. The Owner shall, in that case, make settlement with insurers in accordance with directions of such arbitrators. If distribution of insurance proceeds by arbitration is required, the arbitrators will direct such distribution.

11.4 PERFORMANCE BOND AND PAYMENT BOND

- 11.4.1 The Contractor shall furnish bonds covering faithful performance of the Contract and payment of obligations arising thereunder as stipulated in bidding requirements of specifically required in the Contract Documents on the date of execution of the Contract. Said bonds shall satisfy the applicable statutory requirements of the place in which the Work is to be performed.
- Upon the request of any person or entity appearing to be a potential beneficiary of bonds covering payment of obligations arising under the Contract, the Contractor shall promptly furnish a copy of the bonds or shall permit a copy to be made.

ARTICLE 12

UNCOVERING AND CORRECTION OF WORK

12.1 UNCOVERING OF WORK

- 12.1.1 If a portion of the Work is covered, contrary to the Architect's request or to requirements specifically expressed in the Contract Documents, it must, if required in writing by the Architect, be incovered for the Architect's observation and be replaced at the Contractor's expense without change in the Contract Time.
- If a portion of the Work has been covered in accordance with the requirements specifically expressed in the contract documents, and which the Architect has not specifically requested to observe prior to its being covered, the Architect may request to see such. Work and it shall be uncovered by the Contractor. If such Work is in accordance with the Contract Documents, costs of improveing and replacement shall by appropriate Change Order, be charged to the Owner. If such Work is not in accordance with the Contract Documents, the Contractor shall pay such costs unless the condition was caused by the Owner or a separate contractor in which event the Owner shall be responsible for payment of such costs.

12.2 CORRECTION OF WORK

- The Contractor shall promptly correct Work rejected by the Architect or failing to conform to the requirements of the Contract Documents, whether observed before or after. Substantial Completion and whether or not fabricated, installed or completed. The Contractor shall bear costs of correcting such rejected work, including additional testing and inspections and compensation for the Architect's services and expenses made necessary thereby and any cost, loss, or damages to the Owner resulting from such failure or defect.
 - 12.2.2 If, within one year after the date of Substantial Completion of the Work or designated portion thereof, or after the date for commencement of warranties established under. Subparagraph 9.9.1, or by terms of an applicable special warranty required by the Contract. Documents, any of the Work is found to be not in accordance with the requirements of the Contract Documents, the Contractor shall correct it promptly after receipt of written notice from the Owner to do so unless the Owner has previously given the Contractor a written acceptance of such condition. This period of one year shall be extended with respect to portions of Work first performed after Substantial Completion by the period of time between Substantial Completion and the actual performance of the Work. This obligation under this Subparagraph 12.2.2 shall survive acceptance of the Work under the Contract and termination of the Contract. The Owner shall give such notice promptly after discovery of the condition.
 - 12.2.3 The Contractor shall remove from the site portions of the Work which are not in accordance with the requirements of the Contract Documents and are neither corrected by the Contractor nor accepted by the Owner.

- 12-24 If the Contractor fails to correct nonconforming Work within a reasonable time, the Owner may correct if in accordance with Paragraph 2.4. If the Contractor does not proceed with correction of such nonconforming Work within a reasonable time fixed by written notice, from the Architect, the Owner may remove it and store the salvable materials or equipment at the Contractor's expense. If the Contractor does not pay costs of such removal and storage within ten days after written notice, the Owner may upon ten additional days' written notice sell such materials and equipment at auction or at private sale and shall account for the proceeds thereof, after deducting costs and damages that should have been borne by the Contractor, including compensation for the Architect's services and expenses made necessary thereby. If such proceeds of sale do not cover costs which the Contractor should have borne, the Contract Sum shall be reduced by the deficiency. If payments then or thereafter due the Contractor are not sufficient to cover such amount, the Contractor shall pay the difference to the Owner.
- 12.25 The Confractor shall bear the cost of correcting destroyed or damaged construction, whether completed or partially completed, of the Owner or separate contractors caused by the Contractor's correction or removal of Work which is not in accordance with the requirements of the Contract Documents.
- 12.26 Nothing contained in this Paragraph 12.2 shall be construed to establish a period of limitation with respect to other obligations which the Contractor might have under the Contract Documents. Establishment of the time period of one year as described in Subparagraph 12.2 relates only to the specific obligation of the Contractor to correct the Work, and has no relationship to the time within which the obligation to comply with the Contract Documents may be sought to be enforced, nor to the time within which proceedings may be commenced to establish the Contractor's liability with respect to the Contractor's obligations other than specifically to correct the Work.

12.3 ACCEPTANCE OF NONCONFORMING WORK

12.3.1 If the Owner prefers to accept Work which is not in accordance with the requirements of the Contract Documents; the Owner may do so instead of requiring its removal and correction, in which case the Contract Sum will be reduced as appropriate and equitable. Such adjustment shall be effected whether or not final payment has been made.

ARTICLE 13

MISCELLANEOUS PROVISIONS

13.1 · GOVERNING LAW

13.1.1 The Contract shall be governed by the law of the place where the Project is located.

SUCCESSORS AND ASSIGNS

- 13.2.1 The Owner and Contractor respectively bind themselves, their partners, successors, assigns and legal representatives to the other party hereto and to partners, successors, assigns and legal representatives of such other party in respect to covenants, agreements and obligations contained in the Contract Documents. Except as hereinafter provided, neither party to the Contract shall assign the Contract or sublet it as a whole without the written consent of the other, nor shall the Contractor assign any moneys due or to become due to him hereinder, without the previous written consent of the Owner. The Owner may assign the Contract to any institutional lender providing construction or permanent financing for the Project or to any person acquiring the Owner's interest in the Project, and the Contractor agrees to execute all consents, certificates, and other documents required by such lender or other person in connection with such assignment.
- 13.2.2 If the Owner conveys its interest in the Project to a third party, any rights which the Owner may have against the Contractor ansing from this Agreement shall automatically transfer to such third party.

13.3 WRITTEN NOTICE

13.2

13.3.1 Written notice shall be deemed to have been duly served if delivered in person to the individual or a member of the firm or entity or to an officer of the corporation for which it, was intended, or if delivered at or sent by registered or certified mail to the last business address known to the party giving notice.

13.4 RIGHTS ÄND REMEDIES

- 13.4.1 Duties and obligations imposed by the Contract Documents and rights and remedies available thereunder shall be in addition to and not a limitation of duties; obligations, rights and remedies otherwise imposed or available by law.
- 13.4.2 No action or failure to act by the Owner, Architect or Contractor shall constitute a waiver of a right or duty afforded them under the Contract, nor shall such action or failure to act constitute approval of or acquiescence in a breach thereunder, except as may be specifically, agreed in writing.

13.5 TESTS AND INSPECTIONS

13.5.1 Tests, inspections and approvals of portions of the Work required by the Contract Documents or by laws, ordinances, rules, regulations or orders of public authorities having jurisdiction shall be made at an appropriate time. Unless otherwise provided, the Contractor shall make arrangements for such tests, inspections and approvals with an independent testing laboratory or entity acceptable to the Owner, or with the appropriate public authority, and shall bear all related costs of tests, inspections and approvals. The Contractor shall give the Architect timely notice of when and where tests and inspections are to be made so the Architect may

observe such procedures. The Owner shall bear costs of tests, inspections or approvals which do not become requirements until after bids are received or negotiations concluded.

- 13.5.2 If the Architect, Owner or public authorities having jurisdiction determine that portions of the Work require additional testing, inspection or approval not included under Subparagraph 13.5.1, the Architect will, upon written authorization from the Owner, instruct the Contractor to make arrangements for such additional testing, inspection or approval by an entity acceptable to the Owner, and the Contractor shall give timely notice to the Architect of when and where tests and inspections are to be made so the Architect may observe such procedures. The Owner shall bear such costs except as provided in Subparagraph 13.5.3.
- If such procedures for testing, inspection or approval under Subjaragraphs 13.5.1 and 13.5.2 reveal failure of the portions of the Work to comply with requirements established by the Contract Documents, the Contractor shall bear all costs made necessary by such failure including those of repeated procedures and compensation for the Architect's services and expenses.
- 13.5.4 The Contractor shall obtain and deliver promptly to the Architect any occupancy permit and any certificates of final inspection of any part of the Contractor's work and operating permits for any mechanical apparatus, such as elevators, escalators, boilers, air compressors, etc. which may be required by law to permit full use and occupancy of the premises by the Owner. Receipt of such permits or certificates by the Architect shall be a condition precedent to Substantial Completion of the Work.

13.6 F. EIMITATION OF LIABILITY

- 13.5.1 The Owner shall be liable only to the extent of its interest in the Project, and no officer, director, partner, agent or employee of the Owner (or any partner of a partner or any agent or employee of a partner) shall ever be personally of individually liable with respect to this Contract or the Work. Each Subcontract shall include the foregoing limitation, which shall be effective if the Owner ever succeeds to the Contractor's rights and obligations linder a Subcontract.
- The Contractor shall comply with any decisions of the Arlington Redevelopment Board applicable to the Project, and with any other Laws, By-Laws, Rules, and Regulations or Ordinances within the Town of Arlington.

The Owner shall be entitled to collect from the Contractor all direct, indirect, liquidated, and consequential damages suffered by the Owner on account of the Contractor's default, including without limitation additional services and expenses of the Architect made necessary thereby. The Owner shall be entitled to hold all amounts due the Contractor at the date of termination until all of the Owner's damages have been established, and to apply such amounts to such damages.

- 14.2.3 If the unpaid balance of the Contract Sum exceeds costs of finishing the Work, including compensation for the Architect's services and expenses made necessary thereby, such excess shall be paid to the Contractor. If such costs exceed the unpaid balance, the Contractor shall pay the difference to the Owner. The amount to be paid to the Contractor or Owner, as the case may be, shall be certified by the Architect, upon application, and this obligation for payment shall survive termination of the Contract.

ARTICLE 1 - WAGES AND EMPLOYMENT PRACTICES

- Preference To Veterans and Citizens In Public Work; Rate of Wages. (Statutory reference: Mass. Gen. This section shall also apply to regular employees of the Commonwealth or of a county, town or district, when such employees are employed in the construction, addition to or alteration of public buildings for which special appropriations of more than one thousand

List of Jobs; Classifications; Determination of Rate of Wages; Schedule. (Statutory reference; Mass. Gen. Laws Chapter 149, Section 27) This Paragraph applies to every contract or subcontract for the construction of public works by the Commonwealth, or by a county, town or district.

The Commissioner of Labor and Industries shall prepare, for the use of such public officials or public bodies whose duty it shall be to cause public works to be constructed, a list of the several jobs usually performed on various types of public works upon which mechanics and apprentices, teamsters, chauffeurs and laborers are employed. The Commissioner shall classify said jobs, and he may revise such classifications from time to time, as he may deem advisable. Prior to awarding a contract for the construction of public works, said public official or public body shall submit to the Commissioner a list of the jobs upon which mechanics and. apprentices, teamsters, chauffeurs and laborers are to be employed, and shall. request the Commissioner to determine the rate of wages to be paid on each job. In advertising or calling for bids for said works, the awarding official or public body shall incorporate said schedule in the advertisement or call for bids by an appropriate reference thereto, and shall furnish a copy of said schedule without cost, to any person requesting the same. Said schedule shall be made a part of the contract for said works and shall continue to the minimum rate or rates of wages, for said employees during the life of the contract. Any person engaged in the construction of said works shall cause a legible copy of said schedule to be kept posted in a conspicuous place at the site of said works during the life of the contract. The aforesaid rates of wages in the. schedule of wage rates shall include payment by employers to health and welfare plans, pension plans, and supplementary unemployment benefit plans, and such. payments shall be considered as payments to persons under this section performing work as herein provided. Any employer engaged in the construction of such works who does not make payments to a health and welfare plan, a pension plan and a supplementary unemployment benefit plan, where such payments are included in said rates of wages, shall pay the amount of said ... payments directly to each employee engaged in said construction. Note: The awarding authority does not guarantee the accuracy of any schedule of wage rates

The wage schedule must be posted in a conspicuous place at the work site for the life of the project in accordance with M.G.L. c. 149 § 27. The wages listed on the wage schedule must be paid to employees performing construction work on the project whether they are employed by the prime contractor, a filed sub-bidder, or any sub-contractor.
- All apprentices working on the project are required to be registered with the Massachusetts Division of Apprentice Standards (DAS). Apprentice must keep his/her apprentice identification card on his/her person during all work hours on the project. An apprentice registered with DAS may be paid the lower apprentice wage rate at the applicable step as provided on the prevailing wage schedule. If an apprentice rate is not listed on the prevailing wage schedule for the trade in which an apprentice is registered with the DAS, the apprentice must be paid the journeyworker's rate for the trade.
- The wage rates will remain in effect for the duration of the project, except in the case of multi-year public construction projects. For construction projects lasting longer than one year, awarding authorities must request an updated wage schedule. Awarding authorities are required to request these updates no later than two weeks before the anniversary of the date the contract was executed by the awarding authority and the general contractor. For multi-year CM AT RISK projects, awarding authority must request an annual update no later than two weeks before the anniversary date, determined as the earlier of: (a) the execution date of the GMP Amendment, or (b) the execution date of the first amendment to permit procurement of construction services. Contractors are required to obtain the wage schedules from awarding authorities, and to pay no less than these rates to covered workers. The annual update requirement is not applicable to 27F "rental of equipment" contracts.
- Every contractor or subcontractor which performs construction work on the project is required to submit weekly payroll reports and a Statement of Compliance directly to the awarding authority by mail or email and keep them on file for three years. Each weekly payroll report must contain: the employee's name, address, occupational classification, hours worked, and wages paid. Do not submit weekly payroll reports to DLS. A sample of a payroll reporting form may be obtained at http://www.mass.gov/dols/pw.
- Contractors with questions about the wage rates or classifications included on the wage schedule have an affirmative obligation to inquire with DLS at (617) 626-6953.
- Employees not receiving the prevailing wage rate set forth on the wage schedule may report the violation to the Fair Labor Division of the office of the Attorney General at (617) 727-3465.
- Failure of a contractor or subcontractor to pay the prevailing wage rates listed on the wage schedule to all employees who perform construction work on the project is a violation of the law and subjects the contractor or subcontractor to civil and criminal penalties.
