

Vision 2020 Sustainable Arlington Minutes

Minutes: June 16, 2015 minutes reviewed and approved with a few amendments. There was no meeting in July.

Town Day planning

SA will share a table with Vision 2020. Supplies needed include the SA banner, EcoFest 2015 materials information and posters, signup sheets, name tags, T-shirts, and some information about current SA activities (Charlotte will draft), both to offer visitors and to use for volunteers. 2 volunteers per shift are preferred, David will create a Sign Up Genius. All materials should be brought to Laura's house so she can bring them on Sept 12 by 8am to the table.

Forming a coalition with Mothers Out Front (MoF)

Erin Taylor is an Arlington resident who works with Mass Energy, the non profit working with MoF to plan a Community Choice Aggregation (CCA) program for the town. CCA would be an opt-in, opt-out or opt-greener consumer electricity purchasing arrangement that could lead to lower electricity prices as well as more renewable energy generation in the whole of that generation portfolio.

Currently, the Metropolitan Area Planning Council, of which Arlington is a member, is looking for a broker to represent the group of communities. As a Town Meeting form of government our Town Meeting would have to vote to adopt the new generator as our Town's default provider, but all residents maintain the ability to make an independent choice of energy provider.

Discussion-

- Region has distribution problems, how will such an aggregation project take these into account?
- Storage and smart grid capability are growing concerns
- Energy efficiency and gas leaks are also key to reducing demand from the system
- Participating in building a coalition would lead to SA members having a basic understanding of these issues and a willingness to reach out to our sphere of influence to educate them on the topic

VOTED: SA is interested in being part of a community choice aggregation of consumer electricity coalition with MoF.
