I. Call to order: The regular meeting of the Council on Aging Board was called to order by Jim Munsey at 6:07PM on February 18, 2016, at 27 Maple Street, Arlington, MA.

II. Old Business: Ann reported on a meeting of the Capital Planning Committee regarding the lack of housing in Arlington. Elders sharing housing was one of the suggestions. Bob Tosi mentioned zoning is a point of contention.

- A. Feasibility study. No update as yet. The next meeting will be February 25, 2016. Christine Bongiorno will advocate that 200K be put back into the budget for architectural plans.
- B. Vision 20/20: Results are due in early April. Julie Brazile will report to the COA.
- C. Laura Munsey is working on the Newsletter.
- D. Paul Raia reported on the requirements to attain the status of an Aging Friendly Community. He will bring in a copy of the workbook and Susan will look into having partner college interns assist in study and goals.

- IV. Executive Director's Report
 - A. Work is continuing on a community wide program involving local banks and seniors. Scams of seniors continue to be a problem.
 - B. Ken Greenly, President of the Friends of COA, reported the \$14,500 requested would be funded. Jim and Susan will investigate particulars.

- C. Susan is examining different options for transportation. Jim will assist. Unlike other communities, Arlington provides no funding for a driver.
- D. Mark Waksmonski, the COA nurse, may be participating in a program to reach out to seniors who have phoned emergency dispatch for medical or non-medical issues. The purpose of the program will be to connect individual to potential other services as well as considered a well-being follow up.

The current director is retiring and a search committee has been formed.
