Improvements to Senior Center:

# **Handicapped Parking:**

Available Commission Members agreed to meet prior to the December Meeting for a photo that will be taken next to the handicapped parking space adjacent to the Robbins Library on Massachusetts Ave. This photo will be placed in the Arlington Advocate with a press release about the additional handicapped parking spaces. Twelve of the additional handicapped parking spaces have been installed as planned. Jack said that a resident that lives at the corner of Bartlett Ave. and Mass. Ave has expressed concern regarding a handicapped parking sign located in front of his home.
