Mr. Hayner, Vice Chair opened the School Committee meeting at 6:32 p.m. and said Mr. Pierce was absent due to attending the annual Ostregren Award dinner hosted by the Touchdown Club of Arlington, for junior and senior athletes from Arlington High School. Mr. Hayner presented the Pierce Elementary School artwork displayed around the room this month in the School Committee Room.

APS Presentations

Mr. Schlichtman introduced Ms. Sue Sheffler, Director of Arlington Nagaokakyo Sister Cities activities. Ms. Sheffler, former School Committee member presented a slide show of students and host families to the School Committee members. Students Nik Streit and Fiona Moseley, freshman, who both had hosted Japanese students the past two years will be traveling to Japan this summer, thanked the community and School Committee for allowing this program to Arlington which continues to enrich the students from Arlington and Nagaokakyo.

Public Participation

Ms. Alecia Serafini and Mr. Todd Sundstrom, Ottoson Middle School teachers, as well as Mr. Pat Tassone Interim

Director of Music, participated in public participation tonight and offered their support and encouraged the School Committee members to vote to approve the Memorandum of Agreement to Enroll Out of District Children of Teachers into Arlington Public Schools starting in 2013-2014 school year. Mr. Tassone spoke on behalf of Mr. Tino D'Agostino, Music Teacher, who was unavailable to attend the meeting. All said that they appreciate the support they have received with the Union and Negotiation Team, whom they have been working with over the past two years, on an agreement.

District Goals 2013-2014 Discussion

Dr. Bodie presented draft 4 of the Arlington Public Schools District Goals to the full committee. It was the consensus of the committee that the Superintendent and School Committee retreat to work on the goals was a step in the right direction. Dr. Ampe suggested that she would like to see action, results and tracking of the goals. She also requested a long-range planning goal be added to the goals as well. The committee continued the discussion and it was agreed that Dr. Bodie will continue to work with the Administration and bring forth a set of goals with an action plan and to add a long-range planning goal to the set as well and bring all to the next meeting. The budget subcommittee will meet and help draft the goal around long term planning.

Monthly Financial Report

Ms. Johnson presented the May 6, 2013 tracking reports, and said all principals and department heads have submitted their purchasing requests for FY 13 general funds. Ms. Johnson said due to the winter expenses there could possibly be some funds to purchase additional iPads and other equipment.

<u>Update on Thompson Rebuild</u>

Dr. Bodie presented some pictures of the Thompson School dated April 2013 of the construction. Things remain on track.

Superintendent Report

Dr. Bodie announced that Ms. Kristen DeFrancisco was hired as the Hardy Elementary School Principal. Dr. Bodie commended Mr. Pat Tassone on the Pops Concert and the students who performed at the Cherry Blossom Festival, and informed us that the April newsletter was out. Dr. Bodie spoke about the bus challenges during the past week, hosted a Diversity Coffee and spoke about the US News Report on Arlington Public Schools ranking, and thanked the entire staff.

After Mr. Hayner welcomed Mr. Pierce, Chair to the meeting, back from the Annual Touchdown Dinner, the following motion was made:

Mr. Schlichtman moved to take off the table the Discussion on Enrollment of Out of District Children of Teachers into Arlington Public Schools, seconded by Ms. Starks.

Voted: 7-0

- Dr. Bodie recommends that the School Committee accept and approve the Memorandum of Agreement to permit the enrollment of school-age, nonresident children residing with our employed teacher in the district, with the 10 guidelines outlined in the collective bargaining language proposed.
- Dr. Bodie would like to provide an incentive to retain teachers and after having a two-year discussion about it, hopes the committee agrees to the agreement on a one year trial on a space available basis.
- Dr. Allison-Ampe expressed concern with space issues at the Ottoson Middle School and said she will be abstaining from the vote. Ms. Starks was concerned with the space issues too especially if it causes issues with late enrollments in the district. Ms. Heigham pointed out that she missed the discussion on proposed MOA during the last Executive Session meeting when the committee voted. Ms. Heigham inquired on the plans for those in the buffer zones or open enrollment priorities before allowing teacher's children into the district. Mr. Thielman agrees with the union and to study the trial and agrees it is an attempt to attract and retain teachers in Arlington. Mr. Schlichtman agrees with Mr. Thielman and with said it is an excellent policy. Mr. Schlichtman said Dr. Bodie would have to look into the enrollment numbers to insure no overcrowding was going to happen in each of the schools.
- Mr. Hayner motioned: Beginning in the 2013-2014 school year, on a trial basis for that school year, the School Committee shall permit the enrollment of a school-age, nonresident child residing with his/her parent or guardian who is employed as a teacher (or other Unit A position) in the district subject to the restrictions outlined in the attached Memorandum of Agreement with the AEA., seconded by Ms. Starks.
