- 1. Citizen Open Forum no discussion
- 2. Review and Acceptance of Minutes Motion to accept minutes from the June 2017 meeting was made, seconded, and approved.

4. Incidents & Complaints

APD Incident #17016502 – Homophobic hate speech by unapproved solicitors from out of town to a town resident. Commissioner Carney will reach out to Complainant to thank them for reporting the incident and to offer AHRC's support.

- 5. Municipal Equality Index Awaiting draft score from the Human Rights Campaign. Commissioner Goldsipe met with Health and Human Services Director Christine Bongiorno about ways we can make the town better for LGBTQ community. Steps in progress:
 - Town employee handbook being updated to include sexual orientation (SO) & gender identity (GI) in nondiscrimination statement
 - Looking at procedure for updating Town Contractor agreement to include nondiscrimination requirement that includes SO & GI
 - Job descriptions to include nondiscrimination statement also listing SO & GI
 - Compiling a list of places to place job ads to encourage LGBTQ applicants
 - Possibly offering HIV, Hep B, HepC testing & BP screenings at Town Day at Robbins House. Fliers to be available at Pride Commission Table and/or AHRC table.
 - Recommended internal survey for the Police Department. Possible questions: Have you had
 a conversation with an LGBTQ? Do you identify as LGBT? Are you out? Are there reasons
 related to APD atmosphere/policies that have affected why you have chosen to be/not be
 out?
 - Finding vendors for a half-day competency training on LGBTQ issues and one on trans issues.
 - Commissioner Goldsipe to take the lead on hosting coffees in Arlington to help LGBTQ community learn more about the AHRC and the new Rainbow Commission.

 Suggestion to go to other events and make presentation about AHRC and Rainbow Commission.
