Mr. Hayner moved to approve the Memorandum of Agreement Between The Arlington School Committee and the Arlington Education Association (Unit A) dated May, 10, 2011 and the Side Letter of Agreement between The Arlington School Committee and the Arlington Education Association (Unit A) May 10, 2011. Seconded by Dr. Allison-Ampe.

Public Hearing - School Choice Policy JFBB

Dr. Bodie explained the School Choice Policy JFBB is an annual decision. Dr. Bodie noted the very high class sizes that our district currently has and recommended that the Committee vote not to admit non-resident students under the terms and conditions of the Inter-district School Choice Law (M.G.L.76: 12). It was also pointed out that Title 1 Visas are not affected by this decision.

No public comments on School Choice.

Ms. Heigham moved not to admit non-resident students under the terms and conditions of the Inter-district School Choice Law, seconded by Mr. Hayner.

Public Participation

Mr. John Kusiak, parent and professional music composer spoke on the importance and creative expressions from high school music teacher Mr. DiTomaso.

Ms. Kerry Irons spoke that she was disappointed with the proposed Special Education changes Dr. Bodie has recommended, and asked the School Committee members to listen to parents who have voiced against the proposed changes and vote against these recommendations.

Mr. Michael Levi and Trish Orlovsky read the prepared statement presented by them and with input from the SEPAC Board addressed to Ms. Starks, Chair of the Arlington School Committee. They asked the School Committee members not to adopt Dr. Bodie's recommendation to the proposed organizational and staffing changes in the Special Education Department.

Mr. David McLaughlin expressed his concerns with co-housing of Stratton and Thompson students and loosing sight of Stratton being a Blue Ribbon school and would like additional leadership not less at Stratton Elementary.

Mr. Stephen Harrington, Arlington resident, parent and Treasurer of the Arlington Athletic Foundation asked the School Committee members to vote the Memorandum of Understanding regarding Private Fundraising so the committee can start receiving donations to benefit the Athletic Department.

Ms. Beth Martin and Mr. Chris Carmody, Co Presidents of the Stratton Elementary School PTO expressed their concerns with hosting other school communities during other school rebuilds and now would like to hear from the administration the promise made to the Stratton Community to build their school. The Stratton Community would like Dr. Bodie to clarify the plans to build Stratton, the timeline on the plans and asked them to work with parents and teachers on those plans. They would like the School Committee to be part of the planning process and retain equitable class sizes across all schools.

Thompson Update

Dr. Bodie stated that Town Meeting had approved the Thompson School Rebuild and Thompson Elementary School

Principal Ms. Sherri Donovan presented a power point timeline on the new rebuild plan. The timeline included plans with no override and plans with an override. The students would attend Stratton, Hardy and 5th graders at Bishop and some students in grades K, 3, and 4 will be blended with students of the school they are attending. Students would be bused to and from Stratton and Bishop and crossing guards will be assigned to Hardy School. Teachers will meet at their host school to plan for next year and students will visits their host schools this spring.

Special Education Changes

Dr. Bodie asked if the School Committee would table the Special Education Changes until June 14, 2011

Ms. Heigham moved to table Special Education Changes until June 14, 2011, seconded by Dr. Allison-Ampe. Voted: 6-0

Sports Update

Mr. Ted Dever, Athletic Director of Arlington High School presented the Title 9 report, athletic facilities needs and the Athletic participation numbers of FY 11 and previous years. The facilities report showed many areas in which the Athletic Department is responsible for and would require maintenance which currently not in the budget. Mr. Dever said all coaching staff will be posted on the website as soon as all coaches for that season are hired.

Mr. Pierce asked Mr. Dever to give the School Committee members his recommendation of the top priorities he sees should be taken care of in the Athletic Department. Mr. Dever replied the top priority would be the maintenance of the turf on Peirce Field, to refurbish the gym floor at the high school, new locker rooms for girls and boys at the high school and to lower the fees to use our own Arlington Town Rink.

Mr. Hayner said he has heard from many people around town about the large amount Arlington parents pay to use our own rink and suggested to Dr. Bodie she look into the high fees we are paying to use our own Arlington Town Rink and look for a way to lower them.

Mr. Dever did report that participation in athletic was down due to the high athletic user fees. Ms. Heigham suggested that families fill out one application form if they qualify for financial hardship, either for free and reduced lunch or fee waivers instead of two separate forms from Food Services and the Business Office. Dr. Bodie responded that two application forms are required by parents to apply for financial scholarships but will continue to help expedite the process for families.

Update on CDBG funds for athletics from Town Meeting

Ms. Starks thanked the Arlington Athletic Advisory Committee for the hard work and application process they completed in obtaining an additional \$35,000 for next year as well as the \$8,000 they already received to equal \$43,000 from the CDBG Funds for athletic scholarships.

Mr. Hayner moved to authorize the Chair of the School Committee and Superintendent Bodie to enter into this Memorandum of Understanding Regarding Private Fundraising, as presented, seconded by Mr. Pierce.

Ms. Heigham requested legal opinion on this MOU before authorizing the chair to sign. Ms. Heigham said we would be authorizing this committee in essence to lease out our public school property and if we enter into this agreement the School Committee is delegating authority and that is against our policy.

Mr. Hayner said he would be willing to table this MOU but said the Arlington Athletic Foundation is eager to start the process on getting the fundraising efforts moving forward.

Mr. Hayner withdrew his motion and Mr. Thielman suggested to the committee to authorize the chair to consult with Town Counsel and seek legal opinion on the Memorandum of Understanding on Private Fundraising before signing it. It was also mentioned that we have a policy on Private Fundraising Policy KBGA but the MOU has no end date and it was suggested to add that to the MOU. Dr. Bodie recommends the Memorandum of Understanding.

Mr. Thielman moved to direct the chair and Superintendent, upon consultation with Town Counsel and the Chief Financial Officer, to sign the MOU Regarding Private Fundraising, seconded by Mr. Hayner.
