Ms. Heigham moved, In accordance with its vote of March 1, 2011, the Arlington School Committee did on Monday, March 28, 2011 meet in executive session with Superintendent of Schools Kathleen Bodie to discuss administration decisions and actions surrounding the fiscal year 2010 end-of-year budget shortfall. The School Committee acknowledges the extended length of time that has elapsed since the shortfall was first discussed in an open session on August 26, 2010, while further acknowledging that the passage of the intervening months allows for a broader assessment of measures that have been taken since that date to prevent similar incidents in the future.

The School Committee voted to express its confidence in Dr. Bodie's continued leadership of the Arlington Public Schools and in specific measures that have been taken to date with regard to financial operations of the District, such as monthly revenue and expenditure tracking reports, regular budget reconciliation meetings with municipal financial authorities, and related procedures, seconded by Ms. Starks.
