## **WALKER REPORT**

*Dr. Jim Earley, from Walker Partnerships along with Interim Ottoson Principal Dr. Malone Neville, presented on the Special Education Programs and Services at the Ottoson Middle School. Superintendent Levenson requested this review for the focus on current effectiveness and status of programs and services provided by the Department of Special Education. The purpose is to provide a report to identify areas of strength, need and recommendations.*

*The committee members responded to the review with various questions and Dr. Earley and Dr. Malone Neville responded that some issues that were recommended are already being addressed and other issues could be 3-5 years away. Superintendent noted that a major schedule overhaul is needed and would have to be built from scratch. Dr. Malone Neville noted, English, Math and other departments can be integrated in for the professional development and this should be mapped out before school starts in September.*

## **UPDATE ON IMPLEMENTATION OF 21<sup>st</sup> CENTURY EDUCATION PLAN**

*Mr. Skidmore reported that Arlington students are prepared for social, emotional and vocation success when they graduate from Arlington High School. This is possible with the very talented teachers at Arlington High School, the addition of two new hired social workers and the collaboration of administrators all working towards better communication. Teachers take their position very seriously and have found that students are becoming more responsible, creative thinkers who respect learning and complete their homework, participate in athletics and school activities as well as work after school.*

**We, the seven-independent members of the Arlington School Committee, are of diverse points of view and while often it is our differences that are highlighted, we do have common values and concerns.**

**We do all agree on the following:**

**We agree that all Arlington Children deserve a first class education.**

**Requiring program fees, increasing class size, and cutting programs are unacceptable solutions for addressing our budget problems.**

**The Commonwealth is failing in its responsibility to fund education. Taking inflation into account, Massachusetts is still spending nearly half-a-billion dollars less on education every year than in 2002, thanks to devastating budget cuts during the last recession.**

**To change the way we fund education it will take all of us-School Committee members, educators, parents and concerned citizens- to make our voices heard on Beacon Hill. Together we need to Stand for Children.**
