MCAS

Kathleen Bodie, Assistant Superintendent, reported on MCAS statistics jointly prepared by Leilanie D'Agostino to the committee with handouts and a presentation was given. The data includes district scores of students in out-of-district but does not include students who attend Minuteman. The data was given from two perspectives, grade level trends and cohort trends. Overall all grade levels show improvement from 2001 to present.

Kathy expressed we have new teachers and they are continuing to improve our schools and student scores. This is partly due to administration hiring these new teachers and our veteran teachers here in Arlington who continues to mentor new teachers.

"WHAT WE'RE DOING AND WHY?

Susan Lovelace reported to the committee and presented again what was offered at the State of the Schools Address at Town Hall on November 6th.

The five concepts of what we are doing are:

- 1. Build on past strengths
- 2. Melding 9 schools into 1 system, to help kids learn
- 3. support and challenge student learning
- 4. support our students social and emotional needs
- 5. prepare all students for the 21st century.

The five concepts of why we are doing this:

- 1. we have dedicated and talented staff,
- 2. a history of strong performance,
- 3. a higher rate of students going on to college,
- 4. outstanding arts and athletic programs,
- 5. caring staff and a welcoming environment.

GOALS DISCUSSION / APPROVAL

Superintendent Levenson recommended the District Goals of 2007-2008 draft 11/12/07, version 6 to the committee for approval. Nate pointed out that the goals have been fined tune from meeting with the community, staff, discussions from the School Committee / Retreat and cabinet meetings.

On a motion by Mr. Thielman and seconded by Mr. Garballey it was Voted to approve the Four District Goals of 2007-2008 draft 11/12/07 version 6. Vote 6:0 motion passes

The committee members articulated positive comments and will continue discussion on the goals to see how they are working.

CHAIR REPORT

Ms. Susan Lovelace acknowledged the oversight for not sending a personal invitation to The Board of Selectman to attend the State of the School Address but noted the meeting had been clearly posted for anyone to attend.

Ms. Lovelace handed out the Town of Arlington Financial Summit III for the committee to review and the draft version of the Arlington Public Schools vision with strategy and objectives for 2007 – 2008. Questions from The State of School Address were compiled and distributed.

SUPERINTENDENT REPORT

Superintendent Levenson reviewed the Professional Development that was held on Thursday November 1, 2007. Nate has received mostly positive feedback from the day and noted 18 seminars were offered for staff to choose from.

Nate addressed the major trends that were mentioned at a conference attended by over 10 special education administrators and team chairs, it was not an upbeat event.

The state wide major trends were:

- 1. more frequent use of advocates
- 2. parent funded evaluations with long lists of added services
- 3. increased out-of-district placements
- 4. regulations increasing the quality and detail of documentation needed to defend a district recommended IEP.

We are in the process of developing a tool that will closely monitor and track all student services, out of district placements, transportation and price increased to tell us what impact this will have on the budget.

On a motion by Mr. Thielman and seconded by Mr. Garballey it was Voted to approve the four District Goals for 2007 – 2008. Vote 6:0 unanimous
