## Take-A-Walk/Connecting Arlington's Open Spaces: Next steps for Take-A-Walk maps:

- 1. Collect graphic feedback to bring to Adam Kurowski to streamline revision process once all areas have been mapped initially.
- 2. Brian added routes in Morningside area and Turkey Hill to the online draft map

## **Open Space and Recreation Plan:**

- 1. To track projects in Google drive, Wendy will code meeting minutes per the Open Space Plan categories.
- 2. Funding options for OSC: CDBG funds have been used in the past. The previous cost to produce the OS& R plan was around \$15K to hire a consultant and printing costs. The plan is a requirement for the town.
- 3. OSC target date to submit a budget to the town: before the end of the year. We discussed various items in need of funding and Ann will consult with Planning Department on the process.

- 1. Process to update photos of renovated parks in "Experiencing Arlington's Open Spaces" (on town web site):
