## 2019 Annual Town Meeting - Consent Agenda

Just as we do with the Budgets, I will read through all of the Articles on the Consent Agenda, if you wish to have a particular Article removed call out "hold" and I will remove the Article. We will take two electronic votes. The first on the majority vote Articles and the second on the 2/3rds Vote Articles. The recorded vote for each Article will be the recommended vote in the appropriate reporting Committee or Boards' report. The Votes will be recorded as a vote on each individual Articles.

I have chosen Articles that have either a No Action recommended Vote, Articles which I anticipate will have no debate, or that are housekeeping Articles which we pass each year by a unanimous vote.
