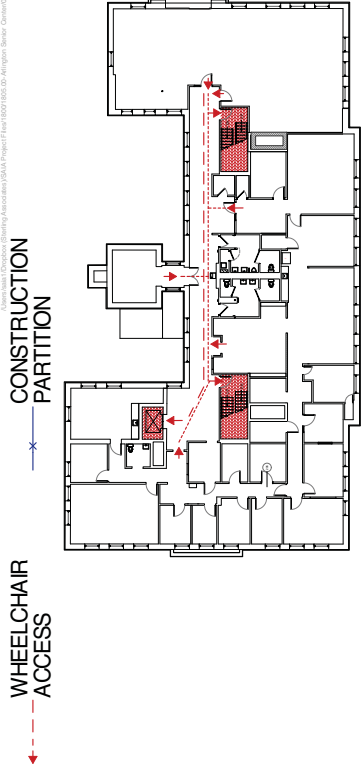


2 FIRST FLOOR EVACUATION ROUTE, PHASE ONE (EST. 8W)

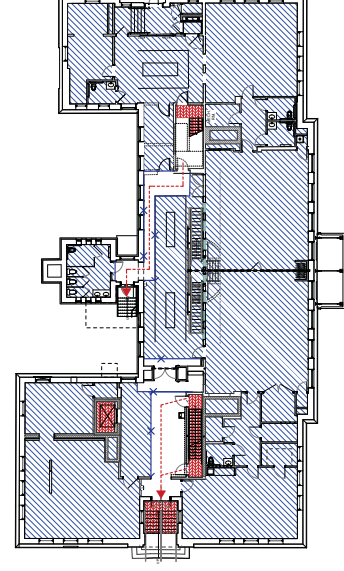


1 GROUND FLR. EVAC. ROUTE, PHASE ONE (EST. 8W)

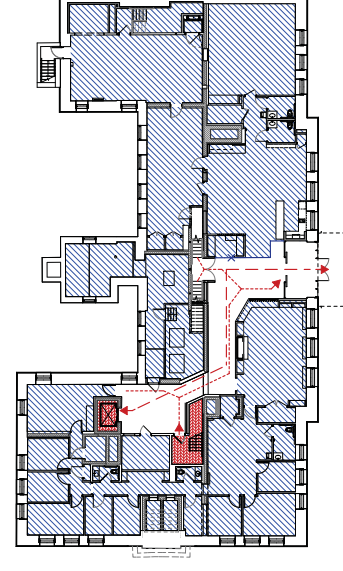

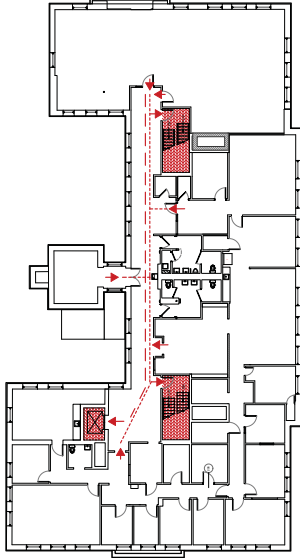
5 FIRST FLOOR EVACUATION ROUTE, SUBPHASE TWO-A (EST. 24W)

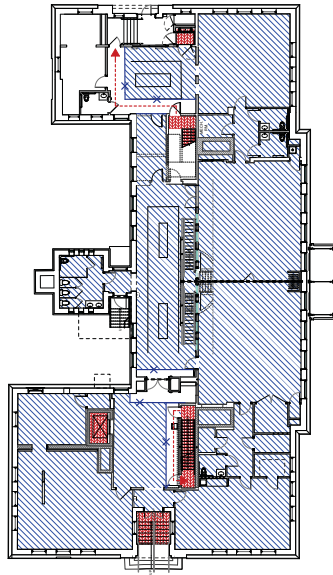
4 GROUND FLOOR EVACUATION ROUTE PHASE TWO-A (EST. 24W)

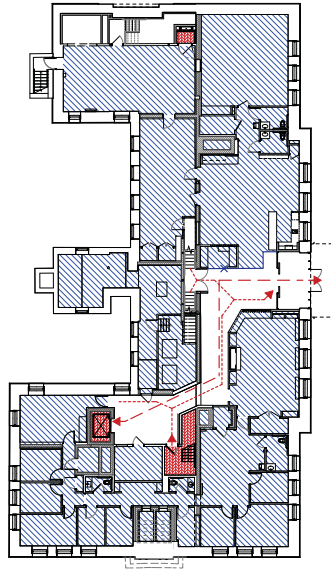

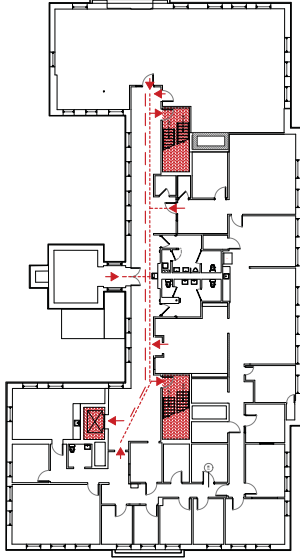
8 FIRST FLOOR EVACUATION ROUTE, SUBPHASE TWO-B (EST. 6W)

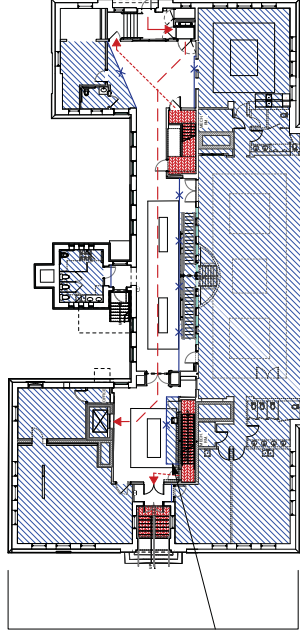
7 GROUND FLOOR EVACUATION ROUTE, SUBPHASE TWO-B (EST. 6W)

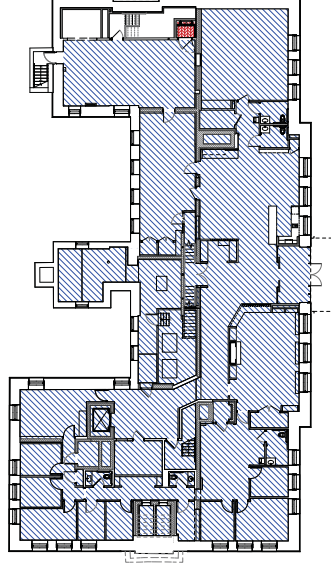


12 SECOND FLOOR EVACUATION ROUTE (EST. 12-14W)

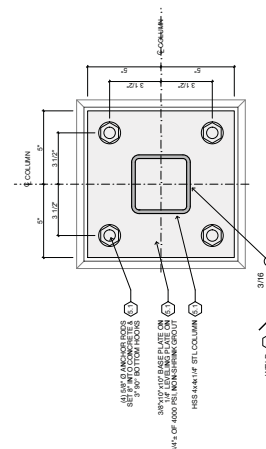
SECTION DETAIL @ NEW WT WELDED TO EXIST. W10 BEAM

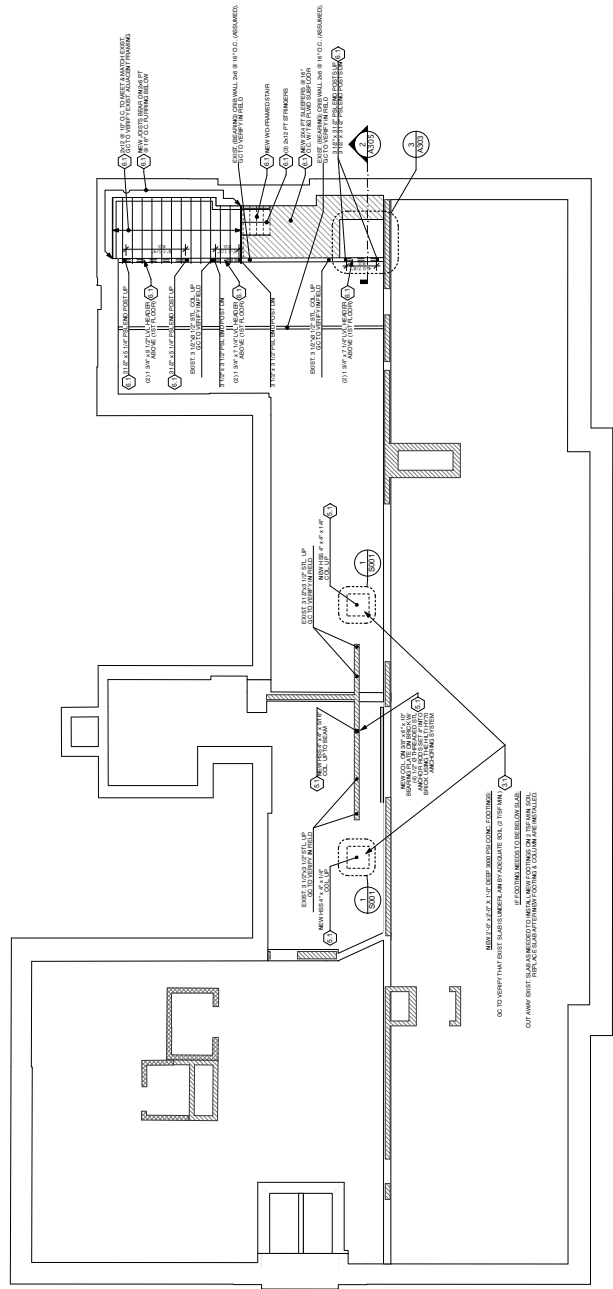
COLUMN BEARING DETAIL @ GROUND FLOOR

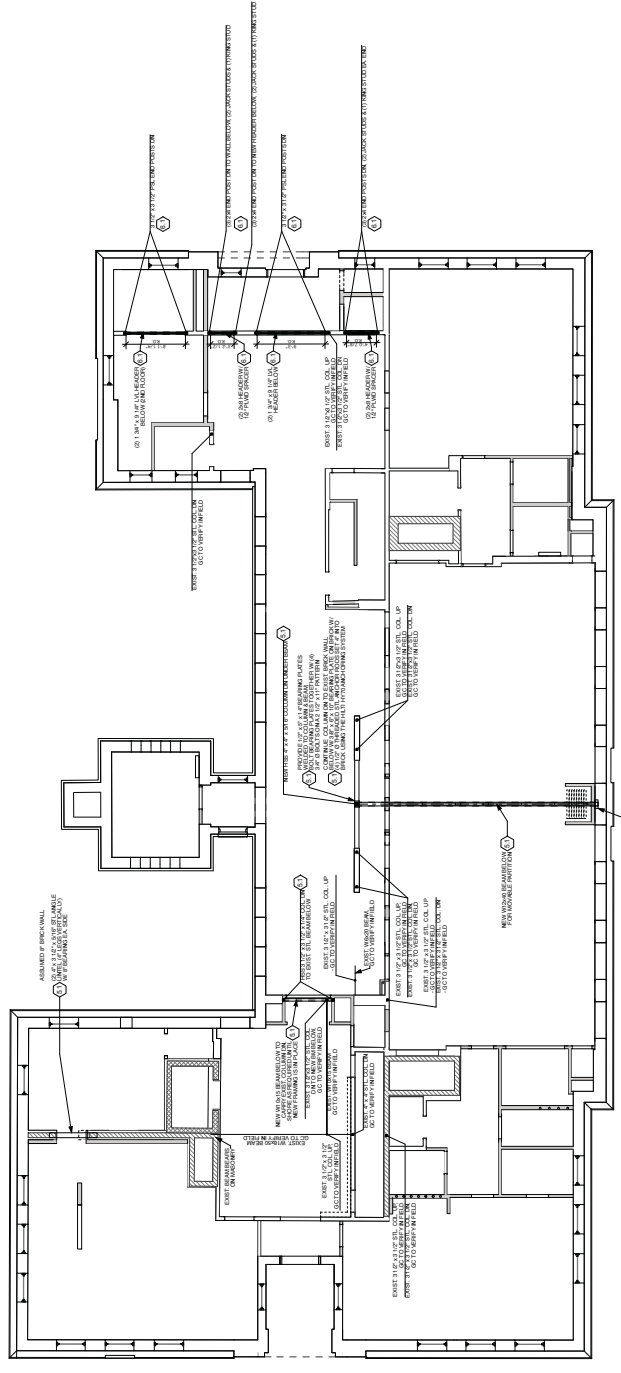


1 GROUND FLOOR FRAMING PLAN
