The following specifications are intended to describe and provide for a finished piece of work and to furnish sufficient information to indicate what is necessary for the practical construction and entire completion of the work and included the furnishing of all labor, materials, and equipment of all work requisite as hereinafter specified. Should any work or material be required which is not noted in the specifications directly or indirectly, but which is nevertheless necessary for the purpose of properly carrying out of the intent thereof, the Contractor is to understand the same to be implied and required and shall perform all such work and furnish such materials as fully as if they were particularly delineated or described. Sizes shall be determined by actual measurements of wearer.

Hash Marks for Years Service: One for each five years of service. Aligned fenced. Red for firefighters.

The bottom button to be not less than 8 $\frac{1}{2}$ inches from the bottom of coat. Three 25 ligne buttons to be counter-sunk on each sleeve, lower button to be 1 $\frac{1}{2}$ inches from bottom of sleeve and others 1 $\frac{1}{2}$ inches apart.

Bidders are to be within a fifteen (15) mile radius of Arlington, MA. Any bidder outside this area will have to deliver all items requested by employees to them on a regular basis.

Bid must be firm for the contract period FY'2020 through FY" 2022.

All quantities are "More or Less" and will be purchased as needed throughout the bid period.

Awarded vendor must have in stock items requested or be able to provide within 7-10 days.

Embroidery to be furnished no later than 10 days from order.

All invoices must be submitted with an attached sales receipt signed by the purchaser.

Should any work or material be required which is not noted in the specifications directly or indirectly, but which is nevertheless necessary for the purpose of properly carrying out of the intent thereof, the Contractor is to understand the same to be implied and required and shall perform all such work and furnish such material as fully as if they were particularly delineated or described.

Service stripes for all men for number of years of service on all type of coats. Specifications for clothing are attached.

Sizes shall be determined by actual measurement of wearer.

TROUSERS - FOR ALL RANKS - GENERAL PURPOSE- ALL POLYESTER

WINTER MATERIAL: Blauer# 8560p8f 75/25 poly/wool #8652p8f 100% poly

SUMMER MATERIAL: To be 55% Dacron and 45% Wool - 9 -1/2 to 10 oz. tropical in place of all wool tropical. Color: Police Blue - see specifications for winter trousers for additional information.

TROUSERS FOR PATROLMEN: Pockets: Two side, one fob, two hip finished 6-1/4 inches wide; outside measure 7-1/2 inches deep inside measure. Club pockets, 3-3/4 inches wide outside, 13 inches deep inside, 4-1/4 inches below right hip pocket. 1 inch back on side seam. Pistol pocket on left side below hip pocket, 5-3/4 inches wide outside unless otherwise specified 8 inches deep inside, 4-1/2 inches below hip pocket, 1 inch back side seam, 4 inches wide, 6 inches deep: pockets opposite lower edge of side pockets. Trousers to have 18 inch bottoms. 250 weight drill to be used in the linings and pockets.

STRIPE: 1/2 of an inch copan blue cloth (piping) sewed securely in the outside seams, as far as bottom of side pockets. Bottoms gummed and felled, cloth heel stay. Trousers cut with waistband attached; Clasp on trousers instead of button in front through top. Suspender bottoms on bone-hand sewed; zippered fly; back buckle straps; and six belt loops. All pockets must be sewed to waistband seam; all pockets strongly bar tacked with silk. Pearl Satin waistband lining; drill pocketing. Seat seam to be sewed through tape. Graded 17 to 18-1/2 inches in width according to waist size. Reinforced stitching on seat and around pockets.

BLACK NYLON BRAID: For Ranking Officers sewed securely in the outside seams, as far as bottom of belt loops to inside the bottom hem; in the following widths 1/2 " wide for Sergeants, 3/4 " for Lieutenants and 1" for Captains and Chief
