Lussiano/North Union Playground and Connecting Pathways Design

The Arlington Park and Recreation Commission is soliciting Proposals from selected landscape architectural firms to prepare a master plan for the park, final design and construction administration for upgrades and improvements to the Lussiano/North Union Playgound and Connecting Pathways. This includes all necessary ADA upgrades to the facility per the ADA. The available budget for the project is \$425,000.

Proposals are due *August 29, 2019, no later than 1:00 PM* at the Town Managers Office/Purchasing Dept., Town Hall Annex, 730 Massachusetts Ave., Arlington, MA 02476.

The following is a description of the selected site and anticipated Scope of Work.

Lussiano/North Union Playgound and Connecting Pathways is located betweenNorth Union Street and Everett Street in Arlington, MA. The scope of work includes upgrades and improvements to the Lussiano Playground and Connecting Pathways, which were last improved over twenty years ago. The project includes connecting pathways from North Union Street and Everett Street. The project does not include improvements to the athletic field. The selected landscape architect should recommend where existing landscape elements can be rehabilitated or reused, and where new design and construction is needed.
