I have reviewed all the materials you have on file and found nothing new for the TAC to review at this time. There is no updated or revised Traffic Impact and Access Study (TIAS), nor are there any responses to our comments on the original TIAS. The following sentence was in the second paragraph on page 5 of the <u>ALR Response Completeness Review</u>, dated 3/18/2020, <u>Applicant will submit a revised Traffic Impact and Accss Study (TIAS)</u>, to better reflect current traffic conditions and revisions to the project design based upon the updated survey work performed by the Project Engineers at <u>BSC</u>.

The new engineer preparing the revised TIAS might wish to contact the TAC to get more recent traffic data than in the original report. Because of the COVID-19 pandemic, traffic volumes are considerably reduced from pre-pandemic levels and counts at this time would not be reflective of normal traffic conditions. If it would be helpful, we would also be willing to meet with the traffic engineer to review our comments on the original report and we will be happy to review the revised TIAS when it becomes available.
