Mr. Gates moved to approve the Plugged In Summer 2020 Funding Request, Mr. Delmolino seconded the motion. The Board held a roll call vote. Review Proposed Amended Trustee Bylaws

Fox Shop Lease Update

Ms. Nicolay recommends that the Fox Shop Lease be renewed. Ms. Nicolay shared with the Board that the Little Fox Shop, Inc. delivered the first check for the Fox offset of \$25,700 (\$500 in excess of the standard offset of \$25,200) and that it's been deposited. The Board discussed how the library reopening strategy will affect the Shop.

Revised Library Budget

The Board reviewed the municipal budget for FY21. Ms. Nicolay shared that the Fox full-time Children's Librarian position is retained in the budget.

Library Trustees Meeting Schedule

The Board reviewed the FY21 Library Trustees Meeting Schedule.

Director's Report

The Board reviewed the May Director's Report. Ms. Nicolay thanked staff for their quick pivot to new circumstances. The Board discussed re-opening phases. Ms. Hampe thanked staff for the Big Return event. Ms. Hampe thanked Ms. Nicolay for the library's statement on the place of the library, "The enemy of systemic racism is a well-informed citizen who is prepared to speak, act, and vote. Your library supports you in that work."

Foundation Liaison Update

Ms. Calvin reported on the Foundation meeting. The Foundation is strategizing around recruitment and beginning the annual report earlier than in the past.

Friends Liaison Updates

Ms. Radochia reported on the Friends of Robbins meeting. The Friends discussed book sales, programs, grounds work, and the Annual General Meeting. The Board received no notification

of a Friends of Fox meeting. The Friends of Fox have indicated they will support a carpet replacement project at the Fox.

Communications and Announcements

There were no communications and announcements.

Unanticipated Items

Ms. Hampe shared information on a petition by the Black Alum Activates Arlington to hang a Black Lives Matter banner at Robbins Library. The Board discussed a policy addressing banners at Robbins. Ms. Nicolay will provide information to the Board on town signage laws.
