BOARD OF SELECTMEN Meeting Minutes Monday, March 28, 2011 7:15 p.m.

Present: Mrs. Mahon, Chair, Ms. LaCourt, Vice Chair, Mr. Greeley, Mr. Hurd, and Ms. Rowe. Also present: Mr. Sullivan, Ms. Rice, and Mrs. Sullivan

The Selectmen started the meeting commemorating John (Jack) W. Hurd's 14 years of service as Selectmen. During his 14 years of dedicated service, Jack was involved with many different committees/boards and community events. Everyone thanked Jack and wished him luck in his campaign for Town Clerk.

Mr. Greeley thanked everyone for their support to the Greeley family in the sudden death of Brian Greeley.

4. Discussion: Retiree Health Insurance Reductions

Al Tosti, Finance Committee, Chairman

(tabled from 3/14/11 meeting)

Mr. Tosti requested that the Board vote on the following issues:

- a) the OPEB Fund allocation of \$155,000. be put in the general fund to help with the deficit for this year.
- b) the retiree contribution for healthcare is increased from 15% to 25%.

Mr. Greeley asked that Mr. Tosti's requests be split into separate votes.

Mr. Bilafer, Chair of the Arlington Retirement Board, requested that the Selectmen honor the original agreement of allocating funds to the OPEB Fund and what a break in trust if the Board votes the funds to the General Fund. He also pointed out that he recently honored the agreement by voting no to COLA pay raises for retirees-he was one of only three towns out of the State that did. The majority of Selectmen agreed that in response to the budget deficit it was necessary to alter the agreement for this year.

Ms. Rowe moved favorable action on allocating OPEB monies to the General Fund.

SO VOTED (4-1)

Ms. Mahon voted in the negative.

After much discussion, it was unanimously agreed that more information was needed as a means testing for retirees to see the effects of a healthcare contribution increase before voting on it. The Selectmen also agreed negotiations between the Town Manager and the Unions should be complete first.

Mr. Greeley moved to table until negotiations are completed.

Ms. Rowe stated the idea is right, but would like the verbiage of the override questions rewritten to be more easily understood with the PAYT question placed first.

Mr. Greeley moved receipt of the committee suggestions with the agreement to have it as a vote at the 4/4/11 meeting along with a setting of a date.

It would be a "to the point" document and financial snapshot at the end of the fiscal year. This will not replace the Annual Report. Mr. Gilligan did request a no action vote for the bylaw amendment, but asked the Board to approve moving forward with the trial.

He believes that consolidation would be useful in the override showing credibility and transparency for all Town/School finances. Mr. Greeley moved favorable action and referred article to the TGRC for comment, either at a future BoS meeting or to Town Meeting during warrant discussion.
