- 4. New Arlington CCA Rates, next steps for opt-up campaign
 - a. MOF has a small group on opt-up campaign ideas, looking for more people to work on that. Winchester Heat Smart team is also interested in brainstorming around it.
- 5. Brookline's Gas Ban bylaw, can we do the same in Arlington?
 - a. Recent MCAN call with Brookline TMM, would be happy to come give a talk about what she did. Possibly also in partnership with Concord, who is also interested. They also put up a webinar and slides that are accessible online (ADD LINK HERE). We should post these and spread the word.
 - b. In the past several years Brookline created a "Green Caucus" for their Town Meeting Members. They thought this was a helpful factor.
 - c. Another thing they did was reached out to every person who had pulled a permit for the past several years and talked to them to get them on board.
 - d. There is a 90 day periods for the AG to determine if their ban is legal, but maybe she actually has until August 30th?
 - e. MOF has a goal of 2020 to work on the gas ban.
 - f. Maybe convene a meeting in the beginning of January, see how many people show up, and if there are enough committed people then work Jan to April to educate TMMs and create consensus.
 - g. We will try to have a kickoff meeting the afternoon of Sunday Jan 5th.
- 6. Official Arts Arlington Partnership
 - a. We would like to officially partner with Arts Arlington and Michelle Lougee's workshops, which would mean helping to get the word out, how to use it as a platform to engage people, committing to come to a portion of workshops, etc.
 - b. They need plastic bags, we should help get the word out.
