

# Arlington Bicycle Advisory Committee Minutes

# 1. Review/Approval of November Minutes

Corrections touched on: bike lane uprising

- Motion to approve as amended
- Motion carried, with no opposition

## 2. Report from COBWEB officer.

No COBWEB office in attendance

### 3. TAC (Transportation Advisory Committee) report.

- Price for the traffic signal at Lake Street and the Minuteman Bikeway was estimated at \$700k; bid price came a little higher than the budget but the Town is committed to constructing it by summer 2020.
- Discussed issues with snow removal in area east of underpass near Alewife. Removal appears worse than prior years.
- o **Action:** will contact DPW to evaluate having a member attend on a regular basis.

#### 4. Arlington High School rebuild:

- Detail design was completed and was \$29m over budget. \$5m was reduced, additional review is in process to find the savings. It was reported the connection to the bike path could potentially be removed from the design.
- Action: proposal to write a letter to the Arlington High School Building Project recommending the connection to the bike path be prioritized. Main points were discussed – supporting health and safety of the students; etc.. Jack will draft a letter for review & Christopher will send to the High School Building Committee.
- Motion to draft the letter, covering major points discussed
- Motion carried, with no opposition

### 5. Sustainable Transportation Plan:

- o Received 4 proposal for consulting services to help develop the plan
- A committee reviewed and scored the proposals. Scores were close and interview were conducted. The firm Nelson/Nygaard was selected to work on developing the plan
- First meeting with be in mid-January

## 6. Bikeway signage: working group report.

- Question raised if ABAC should develop a budget proposal to implement signage the town council. Discussion included:
  - The inventory signs to be added and removed; mile makers, wayfinding on the path, wayfinding on the street, trail signs, cross walks, etc.
  - Plan to adopt Lexington design, with a slight increase in font size
  - There are safety benefits of the signage in the event of an emergency,
  - making the path more visitor / tourist friendly. Potential to coordinate with the Tourism Committee to add emphasis
  - more information is needed on where funding would be secured and if it would be a capital item or an operating expense.
  - The overall project could be prioritized and sequenced to facilitate implementation over time.

# 7. Application for CPA funds to study the Bikeway.

- o The proposal was submitted to the CPA Committee.
- There were 7 letters of support; including ABAC,TAC, ACAC, the Town of Bedford, Mystic River Watershed Association, Walking in Arlington, and the Conservation Commission

# 8. Warrant Article for the removal or changing of the Bikeway hours.

- Chris attended a precinct meeting; most attendees were not aware there were hours of usage.
- Neither Lexington nor Bedford have curfew hours posted, few people are aware of the hours, not physically posted on the path.
- Captain Curran responded with a desire to meet in person. He also raised a concern about safety of path users outside the current curfew hours. Discuss a potential response:
  - There is no alternative between Alewife and Varnum St.
  - Bike path in winter is often better cleared than side walks and are safer for dog walkers
  - Suggest creating target times for requiring lights be in use.
  - Action: Adam will draft a talking points document.
  - Agreed: a few members will join Adam for the meeting. (Daniel, Chris, Rod)

### 9. Bike share update

- Lime contract ends in May and there is some question if Lime will renew with the MAPC, due to lower than desired usage.
- Lime bikes have been removed for the winter, next update form Lime will come in March when bikes would return for the season
- Blue Bike is a potential provider if Lime exits. There is a minimum of 5 docks required.
- Lyft (the Bluebikes operator) is exploring a hybrid dock / dock-less model, but this is still around 24 months in the future.

#### 10. Arlington bike-parking guide any updates.

- Was completed by the Department of Planning & Community Development.
- o It was reported as a news item advertised before Thanksgiving.

o Discussion included that some funding was requested for additional bike parking, This may be included in the budget for town fiscal year 2021.

# 11. Partnering with Arlington Community Education for a talk.

- ABAC agree to co-sponsor the event.
- A date has been identified and will be announced.

## 12. Doug G's interactive map. Linking to Town's website

- Agreed this is a feasible to establish, some modification to the format might be required.
- Action: Chris to discuss next steps with Doug.
