#### NEW BUSINESS

Mr. Sullivan announced that there will be work done improving the CSO discharges – floatable control plan that will effect Alewife Brook Parkway and Massachusetts Avenue beginning August 1<sup>st</sup> and be complete by October 31st, during the hours of 8 p.m. to 5 a.m..

Ms. Rowe announced a Bus Shelter Meeting notice for Tuesday, July 20<sup>th</sup> at 7 p.m. in the Town Hall Auditorium. Ms. Wiener explained that the first part of the meeting will be an MBTA presentation; the second part will be the identification of the nine proposed locations; and the third part will be a question & answer period. Mrs. Mahon requested that any proposed changes include handicap accessibility improvements.

Ms. LaCourt asked Mr. Sullivan about the Washington Street repairs. Mr. Sullivan responded that the work would be ongoing over the next couple of weeks, with completion by the end of July.

Mr. Greeley asked Mr. Sullivan when the Forest Street repair project was starting, Mr. Sullivan responded in August sometime with notification to residents through the website, newspaper, and abutter notification. Mrs. Mahon suggested also using the mobile board with a five-day before notice.

Mrs. Mahon stated that she and Mr. Curro, School Committee Chairman, are arranging a joint committee meeting sometime in October. Mr. Curro has also referred to a sub-committee for review and recommendation the current pledge of allegiance issue presented by Sean Harrington.

Mrs. Mahon requested based on the new Open Meeting Laws an updated description for "Citizens Open Forum" from Ms. Rice. Mrs. Mahon requested that the DCR (Rick Sullivan) be part of the September meeting regarding the sound and light issues at Dilboy Field. Mrs. Mahon suggested that Arlington offer a bid for the lease of Dilboy Field. Mr. Hurd suggested asking for a change in hours, changing the 11:00 p.m. to 10:00 p.m.

Mrs. Mahon will forward a copy of Mr. Curro's traffic supervisors plan for the schools to Mrs. Krepelka when it is available.

Mr. Greeley moved to adjourn at 9:00 p.m. SO VOTED (5-0)
