# **Trust Liaison Update**

Mr. Gates reported that the RFP for the new investment advisor service is closed and the Town received four proposals. A new investment advisor for trust funds will be selected shortly.

#### **Reading Room Artwork Report**

Ms. Nicolay discussed the research on the paintings hanging in the Reading Room that was completed by volunteer scholar Marion Kilson in 2019. The Board discussed the relationship of these works to the town of Arlington and options for the artworks. Ms. Nicolay will consider possible next steps.

The Board reviewed the FY20 Russell Fund Report. The Board thanked Russell Fund Coordinator Mora Rothenberg for the report.

# **Director's Report**

The Board discussed the September 2020 Director's Report. Ms. Nicolay shared that the Friends of Fox voted to support new carpeting and painting at the Fox Branch library. The Arlington Reads Together selection committee chose *Why Are All The Black Kids Sitting Together in the Cafeteria* for the 2021 ART Title. The library will not be providing in-person computer support at this stage, Chromebooks and hotspots will be circulating soon. The new Fox Children's librarian was onboarded recently, and new security cameras and people counters will be installed at both buildings.

## **Foundation Liaison Update**

Ms. Calvin reported that the Foundation continues to fundraise above last year's levels. The ALF annual report is almost done. Ms. Nicolay complimented AFL Board members for their work on the ALF annual report.

## **Friends Liaison Updates**

Ms. Radochia reported on the Friends of Robbins sponsored library program featuring Richard Duffy and their successful pop-up book sale.
