Phil McCarthy explained the RCN Cable License Amendment and recommended the Selectmen move favorable action. Mrs. Mahon requested that there be clarification regarding the I-net system before the final vote at the December meeting. Mr. McCarthy announced his resignation and asked the Selectmen's Office to advertise for two new Cable Advisory Committee members (one member resigned earlier in the year).

3. <u>CITIZENS OPEN FORUM</u>

These matters were presented for consideration of the Board.

Mr. Robert Radochia, 45 Columbia Rd., requesting the town take action on the violations committed by many bicyclists

relative to the rules and laws of operating on public ways. He passed out a packet of pictures and a letter requesting four actions to be enforced. Ms. Rowe was sent an email from the Arlington Bicycle Advisory Committee with suggestions on better bike safety. Mrs. Mahon would like to see educational plans such as flyers, website info educating cyclists, and possibly bike license plates for recourse for property damage. Mr. Hurd pointed out that Cambridge gives out tickets for bicycle violations.

Mrs. Mahon referred this matter to Mr. Sullivan, the Transportation Advisory Committee, and the Arlington Bicycle Advisory Committee to draft a bicycle safety program to be approved at a future meeting.

4. Presentation: HCA Forest-Peirce Preservation Project

David Levy, Executive Director, Housing Corporation of Arlington

Mr. Levy presented some of the projects that the Housing Corporation was working on and how the corporation is looking for new multi dwelling properties. Shortly the corporation will be initiating an outreach program for the Homelessness Program.

The Selectmen thanked Mr. Levy and the Housing Corporation for all their great work.

Ms. LaCourt stated that the Mt. Gilboa residents have expressed interest in what will be happening to Busa Farm and asked if the Selectmen would support requesting a member on the Lexington planning committee.

Laurel Kayne, 79 Westmoreland Avenue, spoke asking the Selectmen to encourage Lexington Selectmen to allow Arlington a seat on the planning committee in order to express Arlington's interest in the farmland.

Janet Kern, 72 Lowell Street of Lexington, spoke to the Selectmen encouraging them to work with Lexington to ensure a seat on the planning committee.

The Selectmen agreed to reach out and request to be part of the planning committee.

Mr. Hurd made a motion to designate Ms. Rowe to approach and write a letter of request to Lexington allowing Arlington to have a committee member that votes.

Ms. Rowe stated that Elsie Fiore requested that the town through the Planning Department write a letter of concern about the Discovery Park plans, especially the impact to Arlington due to flooding and traffic. Ms. Rowe asked Mr. Sullivan to work with Planning and write a letter.

Mr. Hurd remarked that he would hope the School Committee would confer with Town Counsel regarding current litigation. Mr. Hurd stated that Ms. Kowalski, Director of Planning, says that improvements to Downing Square are eligible for CDBG funds.

Ms. LaCourt stated that the recycle brochure includes much information and that recycling is much simpler now.

Mr. Greeley reported that the alcohol seminar held this past Sunday "Best Practices for the Safe Sales of Alcoholic Beverages" was well attended and very informative.

Mrs. Mahon asked Ms. Rice to explore the possibility of requiring all licensees to be professionally trained to serve alcohol by a TIPS like training program.

Mrs. Mahon moved to adjourn.
