## 9. Discussion: Coalition Bargaining of Health Insurance

Brian F. Sullivan, Town Manager

(from 2/13/06 meeting)

Mrs. Mahon moved to adopt Coalition Bargaining under Chapter 32B, Section 19.

Kenneth Hughes, Chairman of the Town's Health Insurance Advisory Committee, said that he believes coalition bargaining is the best way to solve the impending health care emergency.

Mr. Kenneth Donnelly, President, International Firefighters Union, once again spoke in behalf of Coalition Bargaining. He referred to a situation in Worcester where negotiations didn't go well and turned to arbitration. He stated that there are ways to have civil disputes with unions and there are ways where you can have an adversarial relationship with your unions.

David Blakely, Arlington Education Association President, said he sees a challenge in getting his union members to agree to what might be difficult plan changes, if they cannot be assured the other unions are doing the same. He stated that the Town is facing a health care crisis and it requires an emergency response.

Mr. Brian Sullivan, Town Manager, presented the following reasons on why Coalition Bargaining is not good for Arlington Reasons why accepting Section 19 is <u>not</u> in the Town's best interest

- Divorces wage discussions from healthcare discussions.
- Override commitment requires that wage and benefit costs be linked.
- Weighted vote of unions leaves one or two unions in control.
- Acceptance is forever, 70% of the unions must vote to dissolve.
- o Acceptance gives away the Town's right to determine retiree healthcare benefits.
- Does not allow for different benefit structure or contribution levels for different unions.
  - Mr. Greeley stated that if you look at this from our side of the table, we'd be crazy, in his opinion, to enter into coalition bargaining.
  - Mrs. Dias stated that she doesn't think it is in the best interest of the community.
  - Mrs. Mahon stated that what she thinks she is hearing from the Board is that you just don't want to do it, you don't like it, and you don't trust the unions.
  - Ms. LaCourt stated that we have talked a lot about what this law does but one of the things that is clear to me from all of these discussions is a lot of people don't know the answers to a lot of the questions.
  - Mr. Hurd stated that if this is such a worthy goal, this coalition bargaining, why is it that such a small percentage of cities and towns are utilizing it.
  - Mr. Greeley moved against adopting Coalition Bargaining, Chapter 32, Section 19. Mrs. Mahon voted in the affirmative. SO VOTED (1-4)

## 15. Article 7 Bylaw Amendment/Control of Stormwater Quantity and Quality

The BOS voted that the Bylaws be amended as follows: "That a new Article 13 "Storm water management" be added to Title V Regulations on the Use of Private Property.

#### Article 8 Bylaw Amendment/Curb Snow Removal

Article 9 By law Amendment/Snow Removal Donald R. Marquis Minuteman Trail

Mrs. Barbara Cutler, Commission on Disabilities, and Paulo Marinelli, 28 Brooks Avenue appeared before Board.

Mrs. Dias stated that when the Minuteman Trail was constructed, abutters were promised that the bikeway would not be plowed in the wintertime in order to afford the abutters some privacy during a portion of the year. Also, due to limited resources and monies, the Public Works Department could not take on this extra work.

Ms. LaCourt moved no action.

SO VOTED (4-1)

Mrs. Mahon voted in the negative.

#### Article 10 Bylaw Amendment/Uniform Construction Access

Mrs. Barbara Cutler, Commission on Disabilities, appeared before Board. The Board agrees in principal with the Commission's aim of encouraging the use of universal design and "age in place" so as to facilitate handicapped individuals and elderly to say in their homes, the Board suggested that a Resolution may be the best way to proceed.

Mrs. Mahon moved no action.

#### Article 11 Bylaw Amendment/Smoother Sidewalks

Mrs. Barbara Cutler, Commission on Disabilities, appeared before Board. The Board agrees with the Commission that repair of brick sidewalks with a smoother construction method is appropriate and suggested that the Commission and the Director of Public Works work together to address this issue.

This proposed bylaw change would bring non-union personnel in line with other unions.

## Article 17 Bylaw Amendment/Section 8 Animal Control

Jeanne Leary, 425 Summer Street, and Angela Olszewski, 1 Watermill Place, appeared before the BOS asking that a hearing process to consider community input be in place regarding the creation and placement of dog parks.

The Board agreed that an amendment to the Bylaw would provide a public forum to hear the concerns of the neighborhood. Mrs. Mahon moved approval.
