Minutes

Meeting called to order at 4:01pm by Devney

- 1. Call to Order- Read Ground Rules, Welcome
- 2. Approve January Meeting Minutes & Emergency Meeting Minutes
 - Parravano motioned to approve January meeting minutes, Raia seconded, motion approved.
 - b. Devney motioned to approve emergency meeting minutes, Raia seconded, motion approved.

3. Check-Ins

- a. Raia Arlington HS Architect responded to recommendations from IHCD.
- 4. New Business (25 min)
 - a. Automatic Traffic Signals Tabled to next meeting
 - b. Vaccines
 - Christine Bongiorno (Director of HHS) Town started vaccinating first responders in the beginning of January; opened up to healthcare workers; then residents 75+.
 - ii. HHS has been working hard to get residents vaccinated; there are three clinics for residents 75+; Council on aging has assisted with registering Arlington residents 75+ for their vaccines; the Veteran's Services Director assisted getting qualified Veterans to the VA for vaccinations.
 - iii. Arlington Health Department is getting 100 doses of the covid-19 vaccine per week for the Arlington community, but Governor Baker announced today that the Commonwealth will no longer be providing vaccines to hospitals, local community centers, and local public health departments all vaccines in the state will be administered at Mass vaccination clinics.
 - iv. HHS will be getting a small amount of vaccines to provide vaccinations to residents who live in senior housing buildings (five in town); possibly some for home visits.
 - v. Devney spoke with Commission on Disability Alliance (CODA) regarding writing a letter to the governor about their concerns with the vaccination distribution process no update on if CODA is writing a letter.
 - vi. Leigh and Devney will draft a letter on behalf of the Disability
 Commission requesting that Governor Baker provide vaccinations
 to local public health departments, prioritizing residents who are
 disabled specifically those who cannot leave their homes to go to a
 physical vaccination clinic. Will consult with HHS about the letter.

c. Retreat Update

i. Parravano – Retreat is Tuesday, February 23, 2021 from 3:00 pm until 5:30pm; overview of agenda: ice breakers, goals and priorities, working groups, and inspirational statement.

ii. Retreat starts promptly at 3:00pm; Harvey assigned as time keeper for the retreat.

d. Snow Removal

- i. Rademacher explained the snow removal process during start of snow storm DPW prioritizes keeping the roads as safe as possible for emergency access; snow typically gets plowed to the sides of the roads. The following day, DPW clears crosswalks, areas around schools, bus stops, parking meters in the center of town, handicap parking spots, and ramps at roadway intersections.
- ii. Snow removal near Housing Authority buildings— the property owners of the Housing Authority buildings are responsible for snow removal on their property; the Housing Authority usually has contractors who do the snow removal for them. Additionally, homeowners and private property owners are responsible for clearing the sidewalks and curb cuts on their property.
- iii. DeAngelis suggested sending out a reminder on the Disability Commission's social media channels to remind residents about their snow removal responsibilities. Carpenter and Leigh will send out reminders.
- iv. Rademacher if a sidewalk has not been shoveled report it to the police, if there is a crosswalk or main area that has not been shoveled – call the DPW at 781-316-3301.
