Goals for the Meeting


- Hear your concerns about safety issues on Chestnut Street between Mystic Street and Medford Street.
- Learn what you prefer for improvements to safety for pedestrians crossing and walking along Chestnut Street.
- Learn what you prefer for improvements to enhance safety for bicyclists riding on Chestnut Street.
- Identify measures to discourage cars and trucks from speeding



- Pedestrian fatality at Chestnut Terrace crosswalk.
- Vehicles turning right from Mystic Street northbound to Chestnut Street and vehicles turning right from Chestnut St to Mystic St northbound can move at high speed through the slip lanes.
- Vehicles lining up from Mystic Street through Chestnut Terrace crosswalk.
- Complaints of speeding on Chestnut Street.


- Frequent bicycle traffic with no marked bike lanes.
- Broken sidewalk across Russell Common Parking Lot driveway
- Study of potential safety improvements along Chestnut Street between Mystic Street and Medford Street undertaken at the request of the Select Board.
- Chestnut Street is 50 feet wide.

Potential Short-Term Improvements




- 1. Repair sidewalk across the Russell Common Lot driveway and install detectable panels on both sides of driveway.
- 2. Install a temporary curb extension on the north side of the street at the Chestnut Terrace crosswalk.

Potential Short-Term Improvements




- 3. Install a temporary pedestrian refuge island in the middle of the Chestnut Terrace crosswalk.
- 4. Install additional crosswalk warning signs throughout the Chestnut Street corridor.

Potential Short-Term Improvements




 Remove the crosswalk at Chestnut Terrace because of proximity to Mystic Street and direct pedestrians to crosswalks at Medford Street and Mystic Street.

Potential Mid-Term Improvements




- 1. Install permanent 8-foot pedestrian curb extensions on the north side of Chestnut Street at Chestnut Terrace and Medford Street crosswalks.
- 2. Narrow the travel lane in each direction to 11 feet.

Potential Mid-Term Improvements




- 3. Provide an 8-foot parking lane on the north side of Chestnut Street (parking is allowed on the south side on Saturdays and Sundays only).
- 4. Install 5-foot bicycle lanes on each side of Chestnut Street.

Potential Mid-Term Improvements




5. Install a 3-foot buffer between the parking lane and the bicycle lane on the north side of Chestnut Street.

Potential Long-Term Improvements



- 1a. Install a permanent 5-foot pedestrian refuge island in the middle of the Chestnut Terrace crosswalk.
- 1b. Install a raised crosswalk at Chestnut Terrace.
- 2. Install a pedestrian-activated signal or an automatic flashing warning signal at Chestnut Terrace crosswalk.

Potential Long-Term Improvements



- 3. Reconstruct the intersection of Chestnut and Medford Street as a traditional T-intersection.
- 4. Reconfigure the Chestnut Street and Mystic Street intersection to eliminate slip lanes and improve pedestrian and bicycle travel.

- In next 1 2 months, develop short-term measures for safety improvements
- Present short-term recommendations to Select Board for approval
- Consult with Town Departments to have as many short-term improvements as possible installed before the end of 2021
- In the summer and early fall, review medium and long-term improvements for cost, and potential effectiveness and impacts
- Present medium and long-term recommendations to the Select Board for approval
- TAC deliberations will be open to the public to receive additional input
