3. NStar: Update on Power Outages

Bill Zamparelli

Mr. Zamparelli reported that there were a number of factors that exacerbated outage problems in Town, they are:

An NSTAR labor strike disrupted maintenance repairs May 15th through June 6th.

A Nor'easter storm on May 25th and 26th caused tree damage resulting from extremely high winds.

An extended heat wave of 90 degrees plus over June 12th, 13th, and 14th.

Mr. Zamparelli assured the Selectmen of NSTAR's commitment to improving electric reliability to Arlington and their customers.

Mr. Zamparelli spoke regarding general progress on the Four-Phase Reliability Enhancement Project. Phase one and two are complete, finishing the cut over to the new higher voltage system in mid Arlington and the Morningside area. Phase three is underway in East Arlington. The setting of 320 new poles delayed the progress yet is due to be completed by mid November. Phase four is pending in West Arlington and is due to be completed by September 1, 2006. All residents/customers are requested to call in all outages to 1800 592-2000 so that trouble spots can be routed by NSTAR.

NEW BUSINESS

Mr. Greeley announced to all Arlington Heights business owners/employees that there is parking available at Sunrise assisted living, so they should contact Sunrise for information. Mr. Greeley would like this permitted parking process tightened up a bit and the information given to all businesses.

Mr. Greeley sent well wishes to Mrs. Krepelka and hopes she'll be back from sick leave soon.

Mr. Greeley expressed thanks to Arlington residents for the positive override vote and asked Mr. Sullivan and Mr. Sanchez to report back on the water/sewer debt shift on tax bills. Those opposed believe it should be based solely on water usage not value of property.

Mr. Greeley wants to work with the Assessor and the Treasurer on how and when to implement the change over. Ms. LaCourt recommends involving residents via a committee on studying the debt shift and reclassification.

Mr. Greeley stated that Arlington owes a debt of gratitude to Mr. Lyons who was the architect for the blueprint for this successful override; it was a great plan with total backing.

Ms. Mahon thanked all the "yes" override voters.

Ms. Mahon would like to make sure the Abatement Program is available for those in need.

Ms. Mahon would like two future agenda items:

- 1) Refer Mr. Frideau to the Assessor and report back to the Board.
- 2) Congratulated John Searson on his promotion to Captain and suggested he come to a future Board of Selectmen meeting with the two new patrolmen once they finish the academy.

Mrs. Dias wanted to restate that the Board agreed to a "no pay as you throw fee" if the override was passed, except for large bulk recycling. Mrs. Dias would like to look into an increase in recycling programs, maybe utilizing volunteers to increasing recycling efforts. Mr. Hurd agreed the environmental basis for increasing recycling is very important. Mr. Hurd would like to create an incentive to recycle but not a fee. Ms. LaCourt restated that she was clear during the override campaign that she will consider a "pay as you throw fee" even if the override was passed.

Mrs. Mahon moved to adjourn to the Goal Setting Workshop at 9:44 pm. SO VOTED (5-0)
