- 1. Remote participation statement and guidelines read by AR.
- 2. Welcome and introductions (include your pronouns if you want to)
- 3. Consent Agenda
  - a. Consent Agenda: Passed, with Our Revolution MA request for event cosponsorship of a virtual forum removed from consent agenda for later discussion
- 4. Liaison Updates
  - a. Council on Aging:
    - MSI asked ARC to consider matching the COA honorarium to the Sisters of Perpetual Indulgence non-profit for hosting Pride Bingo event; BH moved to affirm request, MG seconded, motion passed unanimously

- ii. MSI gave a brief history of her 10 years of LGBT Programming through the Arlington Senior Center, and going strong.
- b. Director of Equity and Inclusion
  - i. Focus on Juneteenth town event, July 15, 2021 conversation re: Fair Housing, Town Manager and post-covid changes to operations
- c. Robbins Library (MSI) Liaison Rob Lorino moving on, The ARC thanks Rob for creating, publicizing, and running LGBTQIA+ programming
- d. APD: JF Crosswalk painting detail feedback was positive; the APD Advisory Committee discussed LGBTQIA+ community and police relation
  - i. Chief Flaherty looking for opportunities for dialogue to increase understanding between the groups
- e. Select Board: LD nothing to report other than Pride Proclamation went over well
- 5. Working Group Updates
  - a. Community Engagement/events
    - i. need to plan events and order giveaways in January for June Pride events; need to publicize methods for donating to ARC through DEI office
      - note for next newsletter; discussed possibility of retreat 1x or 2x year for planning purposes
  - b. Public Education
    - i. MG: working with schools to improve curriculum, teacher enablement in all grades
  - c. Municipal Equality Index
    - i. HN: Arlington may be eligible for points for out, gay elected officials and for third-party vendor non-discrimination clauses for both sexual orientation and gender identity - research provided to JH; KS: May be bonus point eligible for inclusive workplace policies, domestic partner benefits as well
- 6. Commissioner Membership/Recruitment
  - a. Commissioner JF is resigning, Thank you Julia for your leadership!
  - b. New Commissioner recruitment will be synced with other Commission recruitment this summer and led by Jill Harvey/DEI Director.
- 7. New Business
  - a. Active Bystander for Law Enforcement APD endorsement request: HN moves KS seconds to write a letter endorsing APD participation in this training
  - b. Our Revolution MA request: BH moved to end discussion with no action on request, MG seconded
