# Request for Proposal Stratton School, Bishop School & Peirce School Playground Design

The Town of Arlington, acting thru the Park and Recreation Commission seeks proposals from Landscape Architectural Firms to prepare a final design and construction administration for upgrades and improvements to the Stratton School, Bishop School, and Peirce School playgrounds. This includes all necessary ADA upgrades to the facility per the 2014 ADA Audit. The available budget for the construction is \$1,800,000.

The Stratton School, Bishop School and Peirce School playgrounds were all identified as hazard 1 playgrounds and recommended for full replacement in the last playground audit. Both playgrounds are to be fully renovated with equipment, surfacing, site furnishings, pathways, landscaping, and all necessary ADA compliant upgrades.
