NOMINATION PAPERS FOR TOWN-WIDE OFFICE AVAILABLE JANUARY 3, 2022 NOMINATION PAPERS FOR TOWN MEETING AVAILABLE JANUARY 26, 2022

<u>H.3745</u> allows Arlington to consolidate elections for Town Meeting such that ballots will indicate the total number of seats for each precinct rather than filling vacancies with separate races for 1 or 2-year seats.

The Town Clerk shall not furnish blank forms for nomination of candidates for town office to any person other than a candidate seeking such nominations or a person presenting the signed authorization of a candidate to secure said forms on their behalf (53:17).

Each candidate shall file with the Town Clerk prior to obtaining blank nomination papers, a statement containing their name and address, and the office for which they intend to be a candidate. (53:9A). No candidate for town office shall receive more blank nomination papers than will contain the number of signatures required to place their name in nomination, multiplied by five (53:9A).

Nomination papers must contain the name of the candidate as it appears on the voter list and that is the name that will appear on the ballot. No nomination paper shall be received or be valid unless it is signed by the candidate thereby nominated (53:9).
