Minutes

1. Review and Approve prior Meeting Minutes - September minutes approved

- 2. Design and Building Initiatives Impacting Trees
 - a. Mass Ave improvements 13 trees planted. Contractor is responsible to water for 1 year.
 - b. Lake Street/bike path: 8 trees will be planted (Tulip, Linden, Hophornbeam)
 - c. AHS trees on site are being protected. No updates
 - d. Old Burying Ground 5 trees removed, mason fixing stones, spring replanting
 - e. Lussiano contractor watering. Keith to add new planted trees to town tree inventory
 - f. Mirak development no update, there will be public input sessions
 - g. Mugar property- MaryEllen/Susan attended 10/13 ZBA meeting re: wetland impacts and stormwater mgmt. Additional meetings: 11/10, 11/24, 12/8, 12/22.
- 3. DPW Tree Dept/Tree Warden Update
 - a. Fall planting 200 bare root trees ordered, expect mid-November planting
 - Species ordered: large: horsechestnut, white oak, london plane; medium: yellowwood, gingko, sweet gum; small: service berry, tree lilac, sargent cherry
 - ii. Mt Pleasant Cemetery: 6 trees being planted: sugar maple, serviceberry, kousa dogwood, tree lilac
 - b. Tree watering (Adopt-A-Tree at ~ 100 residents' adopting trees
 - c. Tree hearing(s) none
 - d. Tree Bylaw activity;
 - i. 65 Lancaster Rd: ~40" oak tree taken down due to driveway placement. Developer tried to save tree but was denied a curb cut approval. (Susan to contact engineering dept, to discuss curb cut denial)
 - e. EAB budget 2021 and forward
 - i. \$30k in tree mgmt. plan, yet that was if \$1/inch, yet it costs \$10/inch, therefore more limited application.
 - ii. Treatment occurs June Sept. Arlington has 900 ash trees.
 - iii. 3 trees on Hardy grounds have EAB. DCR was notified, they are verifying. Arlington will be listed as having EAB on state website, and on Arlington's town website. Protocol for EAB infected trees: if > 30% canopy impacted, the tree will be taken down. Neighbors: Brookline: only treating in parks; Belmont: not treating; Winchester: not treating; Somerville/Cambridge: treating extensively
 - f. Purchase second watering truck? (Mara/Phil) no update
 - g. 564 Appleton St. model for preserving trees during construction; photo provided by Keith. Certificate or form of recognition – Steve to present at November meeting
 - h. Trees Please Fund accounting no update
