Meeting Purpose: This first of two meetings of Arlington housing stakeholders is an opportunity for elected officials, and community, board, and commission leaders who have a role in the Town's production and preservation of affordable housing to engage in the development of the Arlington Affordable Housing Trust Fund Board's (the Trust) Action Plan.

This meeting comes after a summer of substantial and direct engagement with the community, with intentional outreach to communities historically underrepresented in traditional public forums. The purpose of this meeting is for Trustees to engage and get feedback from the Town's primary housing stakeholders, in the interest of encouraging alignment around the Town's affordable housing goals. It is not expected that public participation will be invited in this particular meeting.
