


Arlington Picture Post Update - December 2022


Picture Posts is a citizen science project with stations around the world, but mostly in the US. Picture Posts are installed at forests, parks, and schools - even backyards. Each post guides visitors to photograph a location in nine orientations. Photos are dated, geotagged, uploaded, and shared on this site. Picture Post is a part of the Digital Earth Watch (DEW) network.

Picture posts are an environmental and educational resource. Here is a presentation that discusses many of the educational aspects. https://picturepost.ou.edu/resources/BOF-Educators1.pdf. The Picture Post project started at the University of New Hampshire but is now hosted at the University of Oklahoma. Funding is provided by NASA and the US Park Service. The website is: https://picturepost.ou.edu/

Arlington currently has seven picture posts, four in Menotomy Rocks Park and three at the Arlington Reservoir.

Menotomy Rocks Park Picture Post #1 Latitude: 42.410617°N Longitude: 71.164983°W

The project: We are studying the health of plants and the status of invasive species in this area of Menotomy Rocks Park while having fun watching nature change with the seasons.

We need digital pictures to create a time-lapse sequence of photos that will document the growth of plants 360° around this picture post throughout the year, and hopefully years to come.

You can help by taking a set of pictures from this post. Here's how:

- Take a digital picture of these instructions to indicate the location of the post. Include your watch in the picture, if possible, since this will be used as an accurate check of the time and date of the photos. Make is easier and download an iPhone app to automatically upload the photos:
- http://picturepost.unh.edu/mobileapps.isp
- Place the bottom of the digital camera flat on the disc, with the back against the side of the octagon that faces North and is marked "N." Align the middle of the back of your camera with the edge of the octagon. Point the lens away from the post.
- Use widest angle lens setting and take a picture. Repeat for the other 7 clockwise locations on the octagon.
- With the camera pointing skyward and the bottom along the north edge of octagon, take a picture of the sky and/or leaf canopy cover overhead.
- Submit your photos and view others' at http://picturepost.unh.edu/post.isp?postId=5
 If you have nothing to write this information down, take a photograph of this card and reread on your computer screen.







ARLINGTON PARK & RECREATION COMMISSION MEETING MINTUES

January 10, 2023

The Town of Arlington Park and Recreation Commission came to order for its online virtual meeting via Zoom on Tuesday January 10, 2023 at 7:00pm.

Commission Members: Phil Lasker, Leslie Mayer, Shirley Canniff, Scott Walker and Josh Fenollosa. Jen Rothenberg and Sarah Carrier were not in attendance. Recreation Director Joe Connelly was also present.

Preliminary Matter: Phil Walker, Park & Recreation Commission chair, took formal attendance via a roll call and read a statement pertaining to Governor Baker's Public Meeting Law change due to COVID-19 regarding virtual meetings. Meeting business ground rules and procedures were also covered by Mr. Lasker.

Open Forum: N/A

Capital Project Updates:

Spy 95% complete and Parmenter 92% complete

- Rubber test sent, waiting on lab results.
- Rubber cannot be installed until the spring.
- Fence work complete.
- One small load of EWF needed in tot area.
- Parmenter ramps complete, handrail as site measured and to be installed upon arrival.
- Parmenter paving work to be completed in the spring.
- No completion date available at this time, substantial completion by end of month.

Robbins Playground

- Second public input meeting went very well with over 50 participants.
- Mr. Connelly is reviewing draft of preferred plan tomorrow.
- Next public meeting is early February.

Arlington Reservoir Phase II - No change

- Small punch list items remain.
 - Planting replacement in spring and clean-up of paths.
- Final walkthrough with LCWF completed.

Stratton, Peirce, Bishop ARPA Project -No change

- Bishop is Open Sealcoating in the spring.
- Stratton Open with some minor tweaks in the spring.
- Peirce Open Sealcoating in the spring with change to PIP early summer.
- A copy of the punch list was provided to the Commission.

Hurd Field Project

- Majority of project complete.
- Working on patio entrance and pavers.
- Field is substantially completed.
- We did ask for some additional fencing work to be completed.
- Waiting on change order for scoreboard.

Poets Corner

Filing with Concom on Wetland delineation soon.

Follow up public meeting to occur after wetland delineation.

Turf Prohibition Discussion

- Meeting with Conservation Commission last week.
- Concom to hold off on prohibition language during Town Manager's "Study Period".
- Town Wide Forum to take place February/March.

Arlington Court Needs Assessment

- RFP awarded to Activitas. Activitas has an abundance of court knowledge and is currently conducting survey work which will produce data to assist with CPA requests.
- Activitas taking drone pictures of existing sites this week.
- Meeting with Activitas on the 18th.

CPA Requests – Hills Hill, Menotomy, Turkey Hill

- Final applications have been submitted.
- Presentations are scheduled for February 1st. Mr. Connelly will make a five minute presentation for each project which will be followed by a 5 minute question and answer period.

Hi Joe,

I hope it is not to late for me to weigh in on the proposed Hill's Hill bike trails. As others have requested, I too hope the pump track will be built outside of the woods, and that the bike trails within Hills Hill are built in consultation with independent experts (selected by Arlington committees, not the contractor) who can insure minimal damage to the habitat.

I live across from Hills Hill and have always been grateful there was a small area of barely touched (except for the teens on Friday nights) land where trees, plants and animals were for the most part left in peace (over the years I've seen coyotes, woodchucks, owls, etc. in Hills Hill). For more than a decade, I have walked several miles each night on varying routes and watched many patches of trees/shrubs disappear as smaller homes are torn down and replaced by mansions. We are slowly removing every last bit of natural habitat, and then folks complain about water runoff, nuisance wildlife, etc. I'm sure there is a way to accommodate bikers while maintaining the habitat in Hills Hill, but I don't see how it can be done if a pump track is added to the woods.

I am impressed by and commend your work on the fine athletic fields and facilities in Arlington, but I also think it's important to protect the tiny bits of wild space that remain.

One small suggestion for the new Hills Hill biking area: Trash has always been a huge problem within Hills Hill and at the Washington Street extension entrance (abutters are sick of cleaning it up). Included in funding for the bike trail, please add trash barrels/trash pick up, perhaps one at the entrance from the soccer field and definitely at least one (maybe 2?) at the entrance from the Washington St. extension. If nothing else, barrels make it feasible for good samaritans walking by to help keep the area clean. (I frequently pick up others' litter, but only if barrels are fairly close by).

While on the topic of litter... not sure if you have any say in this.... The woods that run along Summer St., adjacent to the soccer field, small baseball field and

hockey rink are also filled with trash. I fear the addition of a bike trail will only add to that. Any possibility the town can clean the woods once per year, in early spring, before the underbrush and poison ivy grow?
