The Town Clerk provided an opportunity for Town Meeting candidates to submit a statement for publication to help voters make informed choices and to reduce the potential cost of running for Town Meeting. Neither the Town of Arlington nor the Town Clerk endorse candidates. The statements were not fact-checked and if a candidate on the ballot is not listed here, it simply means they did not submit a statement.

In all precincts, there are four 3-year seats as usual and any vacancies to be filled following resignations. The ballot will indicate the number of people to be elected. In all cases, the candidates with the highest number of votes will be seated for three years, the next group will be seated for two years and the final group will be seated for one year. For a precinct electing 5 or 6 members, the vacancies will be filled the same way with two-year and one-year terms filled in the order of the number of votes.

In Arlington, we suffer from myriad concerns: Displacement of long-time residents, damage to the local business fabric, loss of green space, safe streets.

In Somerville, I advocated for better building design and zoning on behalf of community members. As a board member and then co-chair of the Union Square Neighborhood Council, we negotiated for millions of dollars in community benefits from developers, including affordable housing, support for local businesses and workers, civic and community center space.

I hope to bring my experience toward handling similar issues and more at Town Meeting.

Arlington needs diverse housing options, from starter homes for young families, to apartments and ADUs for seniors to age in place. The MBTA communities law requires Arlington to zone a minimum capacity of housing units to keep certain state grant funding and zone fossil fuel free buildings. We should think creatively about zoning that satisfies the needs of existing residents while welcoming folks of all different socioeconomic status, age, and backgrounds.

We should preserve our existing industrial spaces and promote active streetscapes in mixed-use districts. We should adopt the specialized stretch energy code to decrease fossil fuel use and minimize pollutants.

As a pedestrian, cyclist, public transit user, and driver, we need more traffic calming measures that minimize conflict areas between these modes of transportation.

Younger families have trouble finding a place they can afford. Older residents wonder whether they can afford to stay.

As a Town Meeting Member, my top concerns will include these:

Town Meeting's most important job is to pass a budget. Arlington's annual budget consistently increases by 3 to 4 percent, a rate that, until recently, was higher than inflation. We need to reduce annual budget increases to between 2 and 3 percent. We passed a debt exclusion to fund the new high school, and will soon face a large override. The tax burden is excessive.

Arlington's housing is scarce and expensive. However, cannibalizing our remaining business space for housing is not a good solution. We need business in Arlington as well as housing, good jobs, so that people can afford to both live here -and- work here. While the state requires us to build more housing, we need to do so in a way that fits Arlington.

We must adapt to a changing climate and clean up Alewife Brook. Sewage in the brook in the 21st century is unacceptable.

Again, I ask for your vote on Election Day.
