ARLINGTON PARK & RECREATION COMMISSION MEETING MINTUES

February 28, 2023

The Town of Arlington Park and Recreation Commission came to order for its online virtual meeting via Zoom on Tuesday February 28, 2023 at 7:00pm.

Commission Members: Leslie Mayer, Shirley Canniff, Phil Lasker, Jen Rothenberg, and Josh Fenollosa. Phil Lasker and Sarah Carrier were not in attendance. Recreation Director Joe Connelly and Captain Richard Flynn were also present.

Anticipated Speakers: N/A

Preliminary Matter: Phil Lasker, Park & Recreation Commission chair, took formal attendance via a roll call and read a statement pertaining to Governor Baker's Public Meeting Law change due to COVID-19 regarding virtual meetings. Meeting business ground rules and procedures were also covered by Mr. Lasker.

Special Event Request - Reservoir Path - 6/10/23 - Joyce Murphy

Mr. Connelly briefly reviewed the request by Ms. Murphy for the Alzheimer's walk around the reservoir beach on Saturday, June 10th. The event is sponsored by a Lexington based organization. Ms. Murphy reviewed the request and reason for requesting the location. The Commission and Ms. Murphy discussed the event.

Ms. Mayer motioned to approve the request with the following conditions, seconded by Ms. Rothenberg and approved 4-0.

- 1. Dogs must be on leash at all times and the event must advertise that fact
- 2. Trash In and Trash Out
- 3. Registration and Snacks to occur in grass area beyond vehicular access gate to left of boat ramp.
- 4. A food license is obtained through Arlington BOH

Off Leash Dog Program Review

Mr. Connelly and Mr. Lasker reviewed the reason for the Park Commission discussion regarding the off leash dog program and set some meeting parameters:

- 1 General Review
- 2 -No major changes will be made without a greater public process
- 3- Start of a longer discussion and process
- 4 Cannot change the town bylaw

Captain Flynn gave a brief overview of the program from an APD perspective and updated the commission as to the process for filling the vacant ACO position.

The Commission asked Captain Flynn and Mr. Connelly where the trouble areas seem to be:

- Menotomy Rocks Park
- McClennen Park
- Thorndike
- Spy
- Leashing dogs when DPW in the park an issue at each park

Mr. Connelly reviewed the importance of self-policing which was so successful when the off leash program was first implemented. Ms. Rothenberg suggested reaching out to the Friends of Parks for liaisons to assist in spreading the word on the program rules and assist in organizing the self-policing efforts. Mr. Connelly will bring this up at the next Friends of Parks meeting.

The Commission discussed the impacts of the pandemic on the current dog issues.

The Commission brainstormed ways to get the word out including:

- Education and sign off while registering dogs
- Signage
- ACO Meet and Greets
- Information during annual clean-ups and other public events
